**(1) Plan Description and Summary of Significant Accounting Policies**

**(a) Description of Plan**

The following description of the J.F. Edwards Construction Co. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan established November 1, 1984, covering all employees of J.F. Edwards Construction Co. (the Company) who have completed one year and 1,000 hours of service and are age twenty-one or older. Participation in the Plan is voluntary and employees can enroll in the Plan the first day of each month following the date the employee satisfied the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA). The Board of Trustees oversees governance of the Plan, determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

**Change in the Plan and Plan Custodian**

In April 2023, the custodian and recordkeeping services for the Plan was changed from Fidelity Management Trust Company (Fidelity) to Ascensus Trust Company (Ascensus). The Plan was amended on April 17, 2023 to convert the Plan document and adoption agreement from Fidelity to Ascensus. All investment funds held by Fidelity were liquidated and reinvested in funds offered by Ascensus as determined by each participant.

Subsequent to December 31, 2024, the Plan was amended to add the option of an after-tax (Roth) salary contribution.

**Contributions**

Participants may contribute a percentage of annual compensation (as defined in the Plan document) in the form of a pre-tax salary reduction. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (referred to as rollover contributions). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible compensation with an automatic increase of 1% annually up to a maximum of 10%. Contributions related to auto-enrollments are automatically invested in a designated balanced fund until changed by the participant. Contributions are subject to certain IRS statutory annual limitations.

The Company contributes a discretionary matching amount to the Plan’s eligible participants. The discretionary match was 25% of the participants’ deferrals in the year-ending December 31, 2024 and 2023. Eligibility for the matching contribution requires at least 1,000 worked hours during the year and employment upon the last day of the Plan year.

The Plan also allows for additional Company profit-sharing contributions at the discretion of the Company’s Board of Directors to eligible participants. The discretionary profit-sharing contribution amounted to \$300,000 in 2024 and \$275,000 in 2023. Eligibility for the profit-sharing contribution requires at least 1,000 worked hours during the year and employment upon the last day of the Plan year.

**(a) Description of Plan, continued**

**Contributions, continued**

Employee contributions, matching employer contributions and employer profit-sharing contributions are invested in one or more investment fund options offered by the Plan as directed by the individual participant.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions, and (b) Plan earnings (losses), and charged with the participant's withdrawals and an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeited balances of terminated participant's non-vested accounts are used to pay for the Plan's general administrative expenses and/or to reduce employer contributions. Forfeitures included in net assets available for benefits amounted to \$98,948 and \$46,951 as of December 31, 2024 and 2023, respectively. Total forfeitures used to reduce employer contributions and/or pay administration expenses amounted to \$23,450 in 2024 and \$15,682 in 2023.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contributions, plus actual earnings thereon, is based on years of credited service. A participant is 100% vested after six years of credited service.

**Payment of Benefits and Participant Loans**

Upon death, disability, retirement or termination of service or separation from service, a participant (or participant's beneficiary in the event of death) with a vested account balance greater than \$5,000 may elect to receive as a distribution from his or her account the value of their account in a lump-sum payment, or they may elect to continue their account until the participant attains age 72. Participants with a vested account balance between \$1,000 and \$5,000 will have their account balance distributed directly to an Individual Retirement Account (IRA) upon termination of service. Participants with a vested account balance of \$1,000 or less will receive a lump sum payment upon termination of service. A participant is also allowed to make hardship withdrawals in certain circumstances as described in the Plan document.

Participant loans are not permitted.

**(b) Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting

The Plan evaluated subsequent events through August 14, 2025, which is the date the financial statements were available to be issued.

**Use of Estimates**

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are held by Ascensus (Custodian) who allocates Plan assets to the individual accounts of each participant as directed by the participant.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in a transaction between market participants at the measurement date. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis and dividends are recorded on the ex-dividend date. The net appreciation (depreciation) in the fair value of investments includes realized and unrealized gains and losses on investments bought and sold during the year as well as held by the Plan at year end.

**Contribution Recognition**

The Plan recognizes employee contributions, and the related employer matching contributions, based on the period the employee contribution is withheld by the Company from the employee's compensation.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses incurred in the general administration of the Plan are paid by the plan sponsor and therefore, are not included in the accompanying statement of changes in net assets available for benefits. Other Plan administration expenses related to member requested services, recordkeeping services and investment fees are deducted directly from the participant's account balance. Certain investment related expenses are included in net appreciation (depreciation) in fair value of investments.

**(3) Fair Value Measurements**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of quoted prices in active markets of similar assets for assets in non-active markets and Level 3 inputs consist of other valuation techniques which have the lowest priority. The Plan uses appropriate valuation techniques based on the availability of inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

There were no Plan investments requiring the use of Level 3 inputs in December 31, 2024 and 2023 and there were no changes in the methods used to measure fair value or transfers between Levels in 2024 and 2023.

(3) Fair Value Measurements, continued

Level 1 Fair Value Measurements – Mutual Funds

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end. The mutual funds are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The mutual funds must publish their daily net asset value and transact at that price; and therefore, they are considered actively traded.

Level 2 Fair Value Measurements – Common Investment Trusts

The underlying assets of the common investment trusts consist of publicly traded open-end mutual funds registered with the U.S. Securities and Exchange Commission. The net asset value of these funds is determined daily and transacted at that price. Thus, the fair value of substantially all mutual fund investments within the common investment trusts are based on the quoted market prices of the investments.

(4) Federal Income Taxes

The Plan uses a prototype plan document sponsored by Ascensus Trust Company. Ascensus Trust Company received an opinion letter from the Internal Revenue Service (“IRS”), dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. However, the Plan’s management believes that the Plan is currently designed and being operating in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan’s financial statements.

The Plan evaluates the tax benefits of a tax position using the “more likely than not” threshold. As of December 31, 2024, management is not aware of any uncertain tax positions and related tax benefits which would be material to the Plan’s financial statements. The Plan files annual information returns which for years subsequent to 2020 are subject to examination by taxing authorities.

(5) Related Party and Party-in-Interest Transactions

The Plan’s investments include investments managed by Ascensus. Ascensus is also the custodian as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions. Fees paid by the Plan for recordkeeping and custodial services amounted to \$16,437 and \$6,633 for the years ended December 31, 2024 and 2023, respectively.

**(8) Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes would materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.

**(9) Economic Impacts**

National and worldwide factors have led to significant volatility in the financial markets and have affected, and may continue to affect, the value of the Plan's investments. The potential future economic impact of these conditions is difficult to assess or predict. The Plan sponsor is not able to estimate the full impact of these conditions on the Plan's financial statements.

**(10) Recent Developments**

On December 29, 2022, the Consolidated Appropriations Act of 2023 was signed into law, which includes the package of retirement provisions referred to as "SECURE 2.0". These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system and finding ways for them to accumulate more assets. These changes have various effective dates starting in 2025 and forward. The Plan Sponsor is working with Ascensus to determine that the Plan document is updated to comply with the provisions of SECURE 2.0 Act.
