### 1. Description of the Plan

The following brief description of the SAIA Motor Freight Line, LLC 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

#### *General*

The Plan was adopted by SAIA Motor Freight Line, LLC (the Company) effective December 31, 1970. The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective May 20, 2022, the Plan was amended and restated. As a result, no significant changes were made to the provisions or operations of the Plan.

#### *Eligibility*

All active employees of the Company are eligible to participate upon attainment of age 21 and, effective January 1, 2024, 1 month of service (prior to January 1, 2024, 3 months of service); however, employees covered by a collective bargaining agreement, contract employees and leased employees are excluded from participating. The entry date is as soon as administratively feasible following satisfaction of the eligibility requirements. Long-term part-time employees who met eligibility requirements under SECURE Act are also eligible to participate in the Plan.

#### *Contributions*

Each year, participants may contribute up to 50% of pre-tax annual compensation, as defined in the plan document, up to the maximum limits of the IRC. Participants also may designate all or a portion of their deferral and Company contributions as after-tax contributions into a Roth account. In addition, eligible participants are permitted to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make a basic matching contribution (Company basic matching contribution) determined and calculated each payroll period. During the period ended December 31, 2024, the Company's basic matching contribution was 50% up to 6% of the participant's deferrals. A percentage is determined each Plan year by the Company. In addition, the Company may make additional discretionary contributions. Any additional discretionary contribution is allocated in the same ratio as each participant's compensation bears to the total of such compensation of all participants. There were no additional discretionary contributions made in 2024. Company contributions are subject to certain limitations as defined by the IRC and the Plan document.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions, Company matching contributions, allocations of the Company's additional discretionary contributions and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants are vested immediately in their voluntary contributions, as well as all Company contributions, plus actual earnings (losses) thereon.

#### *Forfeitures*

At December 31, 2024 and 2023, forfeited balances totaled \$10,480 and \$4,625, respectively. Forfeited balances are used to reduce future Company contributions and to offset Plan expenses. During the year ended December 31, 2024, no forfeited funds were used.

#### *Payment of Benefits*

Participant accounts may be withdrawn upon retirement, death, disability, attainment of age 59½, or termination of employment as a lump-sum. Account balances less than \$7,000 are distributed as a lump-sum payment or rolled over to an individual retirement plan designated by the Plan administrator. Hardship distributions are available from all accounts and rollover contributions may be distributed any time.

#### *Notes Receivable from Participants*

The Plan provides that loans are available to all Plan participants on a nondiscriminatory basis. A participant may borrow the lesser of \$50,000 or 50% of his or her vested account balance. Loans are repayable through payroll deductions and are secured by the participant's account balance. The interest rate is the prime rate plus 1% and is fixed over the life of the note. Loans are repaid over a period not to exceed five years.

### 2. Summary of Significant Accounting Policies

#### *Basis of Accounting*

The accompanying financial statements are prepared on the accrual basis of accounting. The Plan follows accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets accounting principles generally accepted in the United States of America (GAAP).

#### *Accounting Estimates*

The preparation of financial statements in conformity with GAAP require the Plan's management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

#### *Investment Valuation and Income (Loss) Recognition*

The investments of the Plan are reported at fair value, including the stable value fund held in the common collective trust, which holds indirect investments in fully benefit-responsive investment contracts. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 4 for discussion of the fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest is recorded when earned and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as, held during the year.

#### *Contributions*

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

#### *Plan Expenses*

Certain administrative expenses of the Plan are paid by the Plan as provided in the Plan agreement. Certain other administrative expenses of the Plan are paid by the Company. Investment fees are paid by the Plan in the form of reductions of net investment income (loss) earned by Plan participants. The Plan participates in an agreement with Fidelity Management Trust Company (Fidelity), where excess revenue may be returned and deposited into an unallocated revenue credit account. The amounts in the unallocated revenue credit account may be used to pay reasonable and necessary Plan expenses or may be allocated to participants. There were \$204,624 and \$219,584 of unallocated funds in the revenue credit account as of December 31, 2024 and 2023, respectively. The Plan received \$700,205 of revenue credits during 2024. For the year ended December 31, 2024, \$726,620 of unallocated funds from the revenue credit account were allocated to eligible Plan participants.

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

#### *Payment of Benefits*

Benefit payments to participants are recorded upon distribution.

### 3. Certified Information

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Fidelity, the Custodian of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### 4. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs in which little or no market data exists (Level 3 measurements).

#### *Basis of Fair Value Measurement*

*Level 1* - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

#### *Basis of Fair Value Measurement (cont.)*

*Level 2* - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

*Level 3* - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trust* - Valued at the net asset value using NAV as the practical expedient based on the last reported sales price of the underlying investments held. The Plan's interest in the collective trust fund was based on information reported using the audited financial statements of the collective trust fund at year-end. The investment income (loss) was allocated to participants based on their proportionate share of the net assets of the funds.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Tax Status

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA (Pre-Approved Plan) sponsored by FMR LLC, doing business as Fidelity Institutional Asset Management (FMR). The Internal Revenue Service (IRS) has opined and informed FMR by a letter dated June 30, 2020, stating that the form of the Pre-Approved Plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 6. Party-In-Interest Transactions

Fidelity performs services, sells products and maintains certain investments of the Plan for which fees are charged to the Plan. Party-in-interest transactions also include notes receivable from participants. Such transactions, while considered party-in-interest transactions under ERISA, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions.

### **7. Plan Termination**

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100% vested in their accounts.

### **8. Risks and Uncertainties**

The Plan's investments include funds which invest in various types of investment securities and in various companies within various markets. Investment securities are exposed to several risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

### **9. SECURE 2.0 Act of 2022**

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

### **10. Subsequent Events**

The Plan has evaluated, for consideration of recognition or disclosure, subsequent events that have occurred through the date of issuance, July 30, 2025, and has determined that no significant events occurred after December 31, 2024, but prior to the issuance of these financial statements, that would have a material impact on these financial statements.
