NOTES TO FINANCIAL STATEMENTS FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

NOTE A - DESCRIPTION OF PLAN

The following description of National Valuation Consultants, Inc. 401(K) Plan ("the Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established on August 1, 1994. The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code (IRC) covering all employees of National Valuation Consultants, Inc. and National Valuation Consultants Cincinnati, Inc. (collectively referred to as "the Company") who have attained age 21 and have completed two months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective February 1, 2024, the Plan was amended to allow participants to make voluntary, non-deductible, after-tax employee contributions. The participant's elective deferrals plus after-tax contributions cannot exceed 90% of compensation. Effective September 3, 2024, the Plan was amended so that participants who terminate employment with an outstanding loan balance may continue to pay the loan in accordance with the provisions of the loan.

Contributions

Participants may elect to contribute on a pre-tax or post-tax (Roth) basis. Unless a participant makes an affirmative election, participants are automatically enrolled to contribute 6% of compensation each pay period on a pre-tax basis. On January 1st of each Plan year the deferral rate automatically increases by 1% of compensation subject to a deferral cap. Effective February 1, 2023, the deferral cap was amended from 10% of compensation to 12% of compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make voluntary, non-deductible after-tax contributions to the Plan. The participant's elective deferrals plus after-tax contributions may not exceed 90% of compensation. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make annual discretionary matching contributions to the Plan. The Company made an annual discretionary matching contribution equal to 25% of participant contributions up to 1.50% of compensation subject to a \$5,175 maximum match for the year ended December 31, 2024. The annual discretionary matching contribution for the year ended December 31, 2024 was funded in March 2025 and is reflected as an employer contribution receivable on the statement of net assets available for benefits as of December 31, 2024. The Company made an annual discretionary matching contribution equal to 25% of participant contributions up to 1.50% of compensation subject to a \$4,950 maximum match for the year ended December 31, 2023. The annual discretionary matching contribution for the year ended December 31, 2023 was funded in March 2024 and is reflected as an employer contribution receivable on the statement of net assets available for benefits as of December 31, 2023. To be eligible to receive a discretionary matching contribution, participants are required to be employed by the Company on the last day of the Plan year. Participants direct the investment of their Company contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company discretionary matching contributions, if any, and an allocation of Plan earnings. Participants are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants vest immediately in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contributions portion of their account balance is based on years of service as follows.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of 50% of their vested account balance or \$50,000. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Participants, or their beneficiaries, may receive the vested interest of their Plan account through a distribution of benefits upon retirement, death, termination of employment, or a qualifying withdrawal. Hardship withdrawals are permitted by the Plan. In-service distributions may be made to a participant who has not separated from service provided the participant has attained age 59 ½. Benefit payments are made in the form of lump sum distributions. Participants who terminate employment with a balance of less than \$1,000 may receive an automatic lump sum distribution of their balance. Effective January 1, 2024, participants who terminate employment with a balance of less than \$7,000, but more than \$1,000, may receive an automatic direct rollover of their account balance into an individual retirement account. Prior to January 1, 2024, participants who terminated employment with a balance of less than \$5,000, but more than \$1,000, may have received an automatic direct rollover of their account balance into an individual retirement account.

Forfeited Accounts

Forfeitures result from non-vested benefit payments remaining in the Plan for all terminated employees or adjustments, if any. Any forfeitures occurring during a Plan year may be used to pay administrative expenses under the Plan at any time. Any forfeitures not used to pay administrative expenses under the Plan shall be applied to reduce Company contributions for the Plan year immediately following the forfeiture. As of December 31, 2024 and 2023, the forfeiture balance was \$4,721 and \$3,896, respectively. Forfeitures of \$4,218 and \$6,773 were used during the years ended December 31, 2024 and 2023, respectively, to fund a portion of the Company's discretionary matching contribution.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Cash

The Plan considers cash to be non-interest bearing funds.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the Company discretionary matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are

recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

If a participant does not make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Fees for recordkeeping services are included in administrative expenses and allocated to participant accounts based on a flat fee per participant. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses.

The *Fair Value Measurements* topic of the Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC)* establishes a framework for measuring fair value.

That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds (and money market fund): Valued at the daily closing price as reported by the fund. Money market and mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The money market and mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: Plan participants can invest in money market funds, mutual funds, exchange-traded funds (ETFs), common stock, and certain other investments through a self-directed brokerage account. The underlying investments held in the self-directed brokerage accounts as of December 31, 2024 and 2023 are valued as follows:

Corporate stock – common stock: Valued at the closing price reported on the active market on which the individual shares are traded.

Mutual funds, money market fund, and ETFs: Valued at the daily closing price as reported by the fund. The mutual funds, money market fund, and ETFs held in the self-directed brokerage accounts are open-ended funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds, money market fund, and ETFs held in the self-directed brokerage accounts are deemed to be actively traded.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE F – TAX STATUS

The Plan adopted a non-standardized pre-approved defined contribution plan which obtained its latest opinion letter on June 30, 2020, in which the IRS stated that the Plan is designed in accordance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Fidelity Management Trust Company and its affiliates (collectively referred to as "Fidelity") provide third-party administration, recordkeeping, and trustee services to the Plan. Certain Plan investments are managed by Fidelity and are denoted on the supplemental schedule of assets (held at end of year). Fees paid to Fidelity have been included in administrative expenses. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Notes receivable from participants, and related interest income, also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE I – DELINQUENT PARTICIPANT CONTRIBUTIONS

Defined contribution plans are required to remit participant contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. During the year ended December 31, 2023, participant contributions totaling \$144 were not remitted to the Plan until after the required time period and are considered prohibited transactions. The Plan is working with Fidelity to correct the delinquent participant contributions.
