Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Shearwater Health 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution")

Opinion

(1) Description of plan

The following description of the Shearwater Health 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution 401(k) profit sharing plan which was adopted on January 1, 2016 to provide retirement benefits for employees of Shearwater Health (the "Plan Sponsor"). Prior to October 1, 2024, the Plan covered substantially all employees who were age 18 and had completed 6 months of service. Effective January 1, 2024, the Plan covers substantially all employees who are age 18 years old and older. Employees who are not eligible to participate in the Plan include certain non-resident aliens and collective bargaining (union) employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Prior to July 15, 2024, the Plan did not allow hardship withdrawals.

Prior to October 1, 2024, the Plan did not allow notes receivable from participants.

Prior to February 1, 2023, the Plan did not have any age or service requirements.

(b) Contributions

Participants may voluntarily make qualified retirement contributions to the Plan which are deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code ("IRC"). Participants may elect to make their contributions on an after-tax basis in the form of Roth 401(k) contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Participant contributions are permitted up to 100% of compensation, subject to IRC limitations.

The plan allows for discretionary matching contributions, as determined annually by the Plan Sponsor's management. Discretionary matching contributions totaled \$1,104,982 and \$851,521 for the years ended December 31, 2024 and 2023, respectively.

The plan allows for nonelective profit-sharing contributions, as determined annually by the Plan Sponsor's management. There were no nonelective profit-sharing contributions for the years ended December 31, 2024 and 2023, respectively.

Plan Sponsor and participant contributions may not exceed the maximum amount allowable for federal income tax purposes.

(c) Participant accounts

Each participant's account is credited or charged with the participant's and Plan Sponsor contributions, and allocations of investment earnings or losses and administrative expenses. Allocations are based on participant compensation or account balances as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants are immediately vested in their elective salary deferral contributions plus actual earnings or losses thereon. All participants employed as of December 31, 2022, were fully vested in their account balances attributable to matching contributions. For participants who enter the Plan after December 31, 2022, Plan Sponsor discretionary profit sharing and matching contributions are subject to the vesting schedule in the plan documents. The vesting schedule is based on three years of continuous service, according to the vesting schedule below:

(e) Notes receivable from participants

As a part of an amendment, effective October 1, 2024, Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes receivable from participants are secured by the balances in the respective participants' account and bear interest at fixed rates ranging from 7.75% to 8.00%, which are commensurate with prevailing rates as determined by the plan administrator at the time the loan is taken. Principal and interest are paid through payroll deductions.

(f) Payment of benefits

On termination of service due to death, permanent disability, retirement or other reasons, a participant is entitled to receive the vested interest in his or her account balance as a lump-sum distribution. If the vested value of a participant's account is less than \$5,000, the total vested balance is distributed as an automatic lump-sum payment in cash. For participant accounts greater than \$5,000, the participant must consent to any distribution of the account.

(g) Forfeited accounts

Forfeitures are created when participants terminate employment prior to becoming fully vested in any Plan Sponsor discretionary contribution portion of their accounts. Such forfeitures may be used to reduce the Plan Sponsor's contributions to the Plan or used to pay administrative expenses. For the year ended December 31, 2024, forfeitures in the amount of \$1,685 were used to reduce employer match contributions. For the year ended December 31, 2023, forfeitures were not used to reduce employer match contributions. For the years ended December 31, 2024 and 2023, there were no unallocated forfeiture balances.

(h) Hardship withdrawals

As a part of an amendment, effective July 15, 2024, the Plan permits distributions in the event of a hardship, as defined in the plan agreement. Hardship withdrawals can only be made from accounts which are 100% vested. These distributions are taxable and may be subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½.

(i) Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the processing of distributions and administration of notes receivable are charged directly to the applicable participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

(j) Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the ERISA.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

(b) Investment valuation and income recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Payment of benefits

Benefits are recorded when paid.

(d) Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(e) Events occurring after reporting date

The Plan Sponsor has evaluated events and transactions that occurred between December 31, December 31, 2024 and July 28, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Certified information

Certified information related to investments reported and disclosed in the accompanying financial statements and supplemental schedule of assets (held at end of year), including the fair of investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.) ("John Hancock").

(4) Investments measured at net asset value using the practical expedient

The Plan's investments in pooled separate accounts are measured at net asset value ("NAV") as a practical expedient to estimated fair value and, therefore, have not been classified in the fair value hierarchy. The NAV is based on the market value of the underlying investments held by the pooled separate account at year end. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the pooled separate accounts, the issuer reserves the right to temporarily delay or withdrawal from the pool in order to ensure that security liquidations will be carried out in an orderly business manner.

The Plan holds various pooled separate accounts that are not direct filing entities. A majority of these pooled separate accounts seek to mirror the investment objectives and strategies of the underlying mutual fund for which the pooled separate account is named. Certain other pooled separate accounts are target date funds which seek capital appreciation and current income consistent with asset allocation that become more conservative over time to the specified retirement date, and other pooled separate accounts are lifestyle funds which seek returns consistent with the stated investment style.

(5) Income tax status

The Plan Sponsor adopted a non-standardized pre-approved profit sharing plan which has received a favorable opinion letter from the IRS dated June 30, 2020, which stated that the non-standardized pre-approved plan and related trust are designed in accordance with the applicable sections of the IRC. The Plan itself has not received a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. However, the plan administrator believes that the Plan, as amended, is currently being operated in compliance with the applicable requirements of the IRC and is therefore, qualified and exempt from taxation.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) Untimely remittance of participant contributions

The Plan Sponsor is required by Department of Labor regulation to remit participant contributions as soon as practicable, but by no later than the fifteenth business day following the end of the month in which the amounts were withheld from wages. For certain contributions withheld from payrolls during 2023, the funds were not remitted timely. Imputed lost earnings applicable to the 2023 contributions have not been contributed to the Plan as of December 31, 2024.

(7) Related-party and party-in-interest transactions

Certain Plan investments are shares of pooled separate accounts managed by John Hancock and, therefore, these transactions qualify as party-in-interest transactions under the ERISA. As described in Note 1, the Plan paid administrative expenses to various service providers which also qualify as party-in-interest transactions.

(8) Risks and uncertainties

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.


