INDEPENDENT AUDITOR'S REPORT

To the Plan Trustees
C.A.T. Retirement and Savings Plan
St. Helens, Oregon

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of C.A.T. Retirement and Savings Plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of C.A.T. Retirement and Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of C.A.T. Retirement and Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about C.A.T. Retirement and Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendment, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Plan Description

The following description of C.A.T. Retirement and Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Community Action Team, Inc. (Organization), except for union, nonresidential aliens, and leased employees, and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Organization is the Plan's sponsor and serves as plan administrator. The Plan Trustees oversee the governance of the Plan. The Plan's most recent restatement was effective January 1, 2024.

Employees of the Organization who are at least 18 years of age are eligible to make elective deferral contributions immediately upon hire and are eligible to receive discretionary contributions from the Organization after completing one year of service in which at least 700 hours are worked.

Contributions

Participants may elect to contribute, on a pre-tax or after-tax (Roth) basis, up to 100 percent of their eligible compensation to the Plan each year. Individuals who attain age 50 by the end of the Plan year may make additional "catch-up" contributions. Participants may also contribute distributions from other qualified plans (rollover contributions). The Organization may also make discretionary profit-sharing contributions. For 2024 and 2023, the Organization elected to contribute 3 percent of annual eligible compensation to eligible employees who have completed at least one year, but less than three years, of service, and 6 percent of annual eligible compensation to eligible employees who have completed three or more years of service. The Organization's discretionary contribution is calculated based on their eligible compensation for the year as defined by the Plan.

Contributions are subject to regulatory limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Organization's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Participants may direct the investment of their account balances into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

C.A.T. RETIREMENT AND SAVINGS PLAN
NOTES TO FINANCIAL STATEMENTS

1. Plan Description, continued

Vesting

Participants are immediately vested in their deferral and rollover contributions plus actual earnings thereon. Employer contributions become fully vested upon termination of employment due to retirement, death or disability. Otherwise, employer accounts and earnings thereon become fully vested after completing three years of vesting service (defined as one calendar year in which a participant has at least 700 hours of service) according to the following schedule:

Less than 3 years	0%
3 or more years	100%

Forfeited Accounts

Forfeitures of non-vested portions of terminated participant accounts occurs upon distribution of the participant's vested interest. Forfeitures are retained in the Plan and used to reduce the Organization's contributions or pay Plan administrative expenses. Total amounts forfeited in 2024 and 2023 were \$5,922 and \$2,970, respectively. During the years ended December 31, 2024 and 2023, forfeitures from non-vested accounts totaling \$-0- and \$2,998, respectively, were used to fund the Organization's profit-sharing contributions. At December 31, 2024 and 2023, unvested accounts available for use totaled \$5,543 and \$-0-, respectively.

Payment of Benefits

Upon termination of service due to termination of service, death, disability, or retirement for participants with account, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account balance or annual installments over a period of time. In-service withdrawals are permitted upon attainment of 59½ year of age from deferral contribution accounts. Withdrawals from deferral contribution accounts may also be made upon circumstances of financial hardship as defined by the Plan.

Participant Loans

Participants are not permitted to borrow from their accounts under the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

2. Summary of Significant Accounting Policies, continued

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Contributions

Participant and employer contributions are recorded in the year in which the participant contributions are withheld or underlying compensation is paid.

Investment Valuation and Income Recognition

Investments in pooled separate accounts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements. The Plan's guaranteed interest account is carried at contract value which represents deposits, plus interest, less withdrawals. See Note 4 for discussion of investments carried at contract value.

Purchases and sales of securities are recorded on a settlement-date basis. Investment income is recorded on the accrual basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses and Fees

General Plan administrative costs not paid by the Organization are charged to the participants' accounts and apportioned based upon their relative account values. Plan expenses paid by the Organization are excluded from these statements. Transaction-based fees relating to optional services, such as distribution requests, are charged directly against the appropriate participant's account.

Recent Accounting Standard Adopted

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments - Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial assets held by the Plan that are subject to ASC 326 are employer contributions receivable and participant contributions receivable.

The Plan adopted ASC 326 effective January 1, 2023. There was no impact to the financial statements as a result of adopting this standard.

3. Information Certified by the Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Standard Insurance Company, acting as the custodian for the Plan, has certified that the following information included in the accompanying financial statements and supplemental schedules are complete and accurate as of and for the year ended December 31:

4. Insurance Contract

The Plan has a fully benefit-responsive investment contract (FBRIC) with Standard Insurance Company (The Standard), included in the statements of net assets available for benefits as a guaranteed interest account. The Standard maintains the contributions in a general account, (Stable Asset Fund), which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. All assets in the guaranteed interest account are credited with interest using a declared quarterly rate determined by The Standard and stated in advance of the coming quarter. There is no specific portfolio of assets in which the guaranteed interest fund invests. The credited interest rate is backed by the income received from assets held in The Standard's general account. The rate will never be below 1 percent and has no maximum interest rate for the Stable Asset Fund. The crediting rate is based on a formula established by the contract issuer and was 2.39 percent for 2024 and 2.11 percent for 2023. Certain events, such as premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with The Standard. The Plan Administrator believes the occurrence of such events that would also limit the Plan's ability to transact at contract value with the Plan participants is not probable. Based on these factors, The Standard has certified that the fair value of the insurance contracts is equal to the current contract value.

5. Fair Value Measurements

Financial Accounting and Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

5. Fair Value Measurements, continued

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to their fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Pooled separate accounts: Recorded at fair value based on the stated net asset value (NAV) of the separate pooled account, which is used as a practical expedient to estimate fair value. Participant transactions may occur daily at NAV. Pursuant to Accounting Standards Update (ASU) 2015-07, *Fair Value Measurements*, the pooled separate accounts measured at NAV have not been classified in the fair value hierarchy. All pooled separate account investments held by the Plan are held within a group annuity contract and have no unfunded commitments, and the investments may be redeemed by participants on a daily basis with no required notice period.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Party-in-Interest Transactions

Certain Plan investments include units of group annuity accounts managed by Standard Insurance Company. Standard Insurance Company is the custodian as defined by the Plan and therefore these transactions qualify as exempt party-in-interest transactions

Administrative fees and other direct compensation paid to Stancorp Financial, an affiliate of Standard Insurance Company, from Plan assets were \$32,806 and \$27,996 for the years ended December 31, 2024 and 2023, respectively. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

7. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of full or partial Plan termination, affected participants will become 100 percent vested in their accounts.

8. Tax Status

The Plan has adopted a pre-approved non-standardized profit sharing plan with CODA sponsored by Prime Retirement Solutions LLC. The Internal Revenue Service has issued a favorable opinion letter dated October 24, 2022, which stated that the plan, as then designed, was designed in accordance with applicable sections of the Internal Revenue Code (IRC).

8. Tax Status, continued

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

10. Non-exempt Transactions

During 2024, participant contributions totaling \$350 were not remitted to the Plan within the appropriate time period by the Organization. These transactions constitute prohibited transactions as defined by ERISA. The Organization has taken the appropriate steps to correct the situation in 2025 by reimbursing employees for lost earnings and interest, and have further implemented a procedure to ensure that all future remittances are made within the prescribed time period.

11. Subsequent Events

Management evaluates events and transactions that occur after the statement of net assets available for benefits date as potential subsequent events. Management has performed this evaluation through the date of the independent auditor's report.
