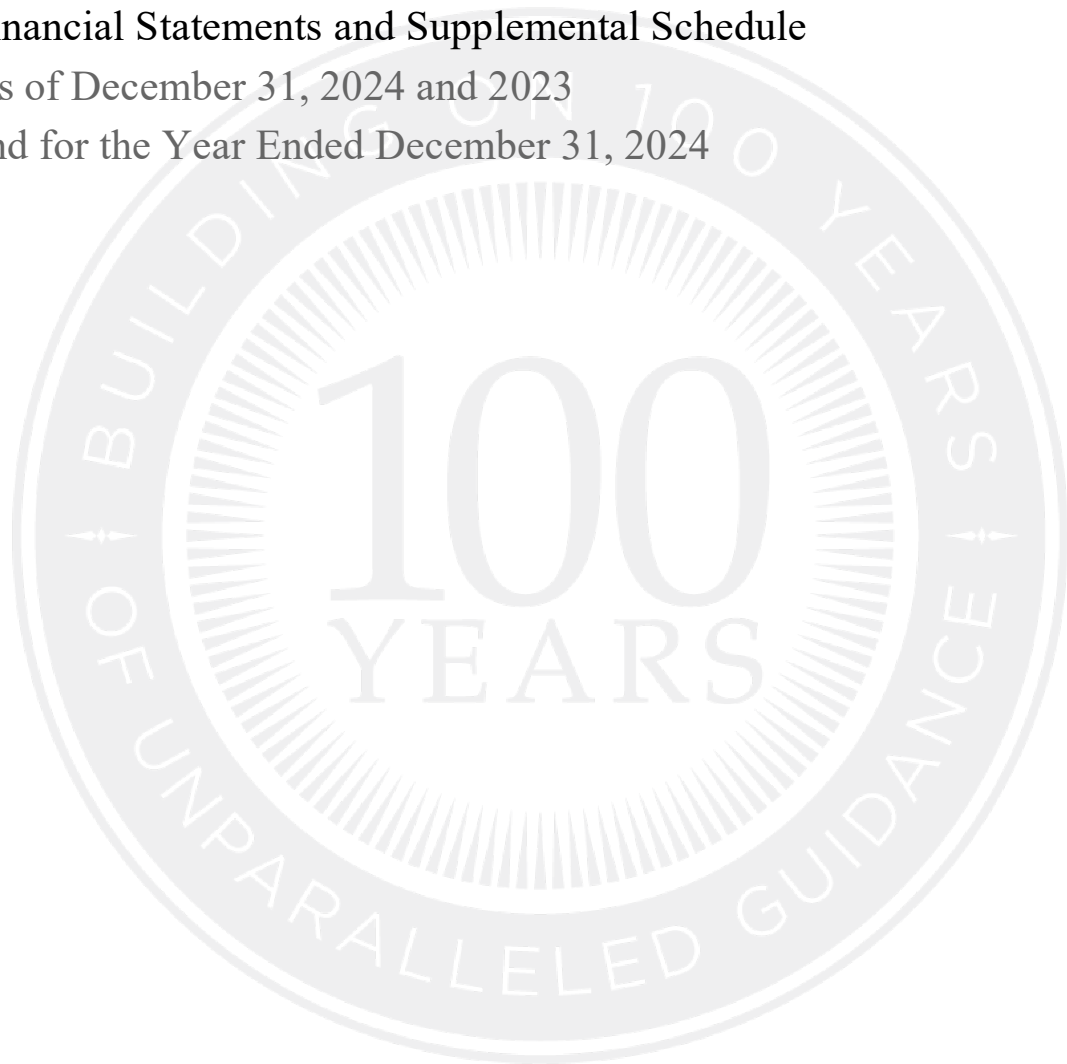

Independent Auditor's Report

To the Plan Administrator of the Creative Financial Staffing 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Creative Financial Staffing 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists.

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

As of December 31, 2024 and 2023 and for the Year Ended December 31, 2024

1. DESCRIPTION OF THE PLAN

The following description of Creative Financial Staffing 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan’s provisions.

Effective January 1, 2019, the Plan has been amended and designed to be a “Safe Harbor 401(k) Plan”.

General

The Plan is a defined contribution plan covering substantially all employees of Creative Financial Staffing, Inc. (the “Plan Sponsor” or the “Company”).

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Reliance Trust Company is the Trustee of the Plan.

Eligibility

The Plan is a defined contribution plan, covering all full-time employees of the Company. Employees are eligible to participate in the Plan after completing one year of service (minimum 1,000 hours) and attaining age twenty-one. If 1,000 hours is not attained within the first year of service, the employee is credited an additional year of service once 1,000 hours have been completed.

Participant Contributions

An active participant may elect to make two types of contributions to the Plan as follows:

Elective Deferral Contributions

Each active participant may elect to contribute to the Plan a percentage of their compensation, as defined, on a pre-tax basis or after-tax basis up to the applicable amount allowable under federal regulations. Elective deferral contributions are remitted to the Plan by the Company on the participants’ behalf.

Rollover Contributions

All eligible employees may, at the discretion of the Plan Administrator, contribute to the Plan distributions from other qualified plans or individual retirement accounts, if the contributions satisfy the tax law requirements for a qualified rollover.

Employer Contributions

The Company may elect to make contributions to the Plan as follows:

Matching Contributions

The Company will make a safe harbor matching contribution equal to 100% on the first 3% of a participant's eligible earnings that a participant defers as an elective deferral, and an additional 50% on the next 2% of a participant's eligible earnings that a participant defers as an elective deferral. A participant must make elective deferrals in order to receive a safe harbor matching contribution. Safe harbor matching contributions will be made each pay period.

The Company may decide to make a discretionary matching contribution on behalf of each participant. These discretionary matching contributions may be subject to certain limitations. The Company did not make a discretionary matching contribution in 2024.

Non-Elective Contributions

The Company may decide each Plan year whether to make a non-elective contribution on behalf of eligible active participants to be allocated to participants based on compensation levels, as defined. The Company did not make a non-elective contribution in 2024.

Vesting

A participant will have a fully vested interest in that portion of their account attributable to elective deferral contributions, rollover contributions, safe harbor matching contributions and related investment earnings. Employer discretionary matching and non-elective contributions vest based on the participant's years of service as follows:

Less than 1	0%
1 - 2	20%
2 - 3	40%
3 - 4	60%
4 - 5	80%
5 or more	100%

Service is credited from the date of employment. If a participant terminates employment with the Company, they will be entitled to receive the vested value of their account.

Forfeitures

Upon a participant's termination, any non-vested portion of the employer's discretionary matching or non-elective contributions is forfeited. Forfeitures are retained in the Plan and will first be used to pay administrative expenses under the Plan, as directed by the Company. Any remaining amounts will be used to reduce future employer contributions

payable under the Plan. In 2024, employer matching contributions were reduced by \$18,888 from forfeited non-vested accounts. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$121 and \$118, respectively.

Investments

The Plan offers a number of investment options which vary by investment objective. Participants elect in which investment or investments they wish their accounts to be invested in. Participants may change their investment options daily. Earnings for each investment are allocated to each participant's investment account based on the ratio of each participant's account balance to the balance of all participants' accounts invested in the same investment.

Notes Receivable from Participants

Loans may be made to participants when directed by the Plan Administrator upon request by the participant. Each loan shall bear a reasonable rate of interest determined at the time the loan is made. The loans are secured by the balance in the participant's account. Interest and principal are repaid and credited to the participant's account based on their current investment choices.

The maximum loan amount is one half of the participant's vested 401(k) account balance, not to exceed \$50,000. The minimum loan amount is \$500. Loans are repayable over a period of up to five years, unless such loan is used to acquire a principal residence of the participant, in which case a longer repayment period is allowed. A participant is not allowed to have more than three loans outstanding at any time.

Distributions

Retirement, Disability or Death

Participants who retire or become disabled will be entitled to 100% of their account balance. Upon death, a participant's beneficiary will be entitled to 100% of the vested account balance, payable in accordance with the Plan document.

In-Service

Participants who have reached a certain age (59½ years old) or service requirements, as defined in the Plan agreement, are entitled to withdraw 100% of their vested account balance.

A participant may also request a withdrawal upon demonstration by the participant to the Plan Administrator that the participant is suffering from hardship, as defined in applicable regulations of the Internal Revenue Code.

Other Termination of Employment

Upon termination of employment for any reason other than retirement, disability, or death, participants shall be entitled to receive the vested amount of their account balance.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at the value reported to the Plan by the Trustee, which represents fair value. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

Excess Payable Contributions

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions. The Plan will distribute the excess contributions for each year to the applicable participants in the following year.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Administrative Expenses

Some administrative costs of the Plan were paid by the Company in 2024, except for loan origination and annual loan maintenance fees which are paid by the participants that have participant loans as are fees related to the processing of benefit payments and certain recordkeeping fees and are included administrative expenses. Investment fees incurred by the Plan are included as a reduction in the investment return earned by the investments.

Benefit Payments

Benefits are recorded when paid.

3. CERTIFIED INVESTMENT INFORMATION

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the Trustee), qualified institution.

The Trustee also certified the information included in the Schedule of Assets (Held at End of Year).

5. FAIR VALUE MEASUREMENTS

The hierarchal framework prioritizes and ranks the level of market price observability used in measuring investments at fair value. Market price observability is impacted by a number of factors, including the type of investment and the characteristics specific to the investment. Investments with readily available active quoted prices or for which fair value can be measured from actively quoted prices generally will have a higher degree of market price observability and a lesser degree of judgment used in measuring fair value.

The Plan groups its financial instruments measured at fair value in three levels, based on the markets in which the assets and liabilities are traded and the reliability of the assumptions used to determine fair value. The three levels of fair value hierarchy are as follows:

Level 1 – Valuation is based on quoted prices in active markets for identical assets or liabilities. Valuations are obtained from readily available pricing sources for market transactions involving identical assets or liabilities.

Level 2 – Valuation is based on observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 – Valuation is based on unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities. Level 3 assets and liabilities include financial instruments whose value is determined using unobservable inputs to pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant management judgment or estimation.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Fund - Issued by Invesco Ltd. that is composed primarily of group annuity contracts that are valued daily at the NAV of units of the collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the Stable Value Fund, the issuer reserves the right to require 3 days notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

7. TAX STATUS

In October 2014, the Company adopted an Automatic Data Processing Prototype 401(k) and Profit Sharing Plan agreement in which the IRS determined, as stated in a letter dated October 6, 2020, that the prototype plan was acceptable under the applicable requirements of the Internal Revenue Code and therefore, the Plan Administrator believes that the Plan qualifies as a tax-exempt plan. The Plan has been amended since receiving the determination letter, however, the Plan Administrator believes that the Plan is designed and operated in compliance with the applicable requirements of the Internal Revenue Code and therefore, believes that the Plan qualifies as a tax-exempt plan. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or the Department of Labor ("DOL"). The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the IRS and DOL; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to examinations for years prior to 2021.

The Plan has not recognized any interest or penalties related to unrecognized tax positions.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

ADP, Inc. is the recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions. The ADP, Inc. fees incurred related to administrative costs to facilitate distributions and other recordkeeping fees amounted to \$8,041 for the year ended December 31, 2024. Notes receivable from participants are also party-in-interest transactions.
