Notes to Financial Statements

NOTE 1: DESCRIPTION OF PLAN

The following description of Piramal Critical Care, Inc. 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan with salary reduction features as permitted under Section 401 (k) of the Internal Revenue Code (“IRC”) and is sponsored by Piramal Critical Care, Inc. (“the Company/ Plan Sponsor”). The Plan is funded by employee and employer contributions and covers substantially all employees of the Company who are age eighteen or older, except those who are covered under a collective bargaining agreement, leased employees, and certain nonresident aliens who have earned no income from sources within the United States. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Broker commissions associated with investment transactions are paid by the Plan and netted against earnings on investments. Administrative expenses are paid by the Plan or the Plan Sponsor.

Contributions

Participants may authorize an elective deferred contribution rate up to the maximum annual limitations as provided by the IRC. The Plan includes a provision under IRC Section 401(k) whereby participants may make elective deferral contributions and Roth elective deferrals (“deferral contributions”) to the Plan up to a maximum of 90% of their annual compensation. Participants enter the Plan on the first day of the month coinciding with or next following date the eligibility requirements are met, solely with respect to making participant contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants.

The Company provides employer safe harbor match contributions. For safe harbor, the Company will contribute an amount equal to 100% of the participants' elective deferrals that do not exceed 5% of the participants' eligible compensation. The Company may make a discretionary employer contribution, a discretionary profit-sharing contribution, and a supplemental matching contribution. Participants must be credited with one year of service to receive employer contributions.

Administration

The Company serves as the Plan administrator. The Plan administrator has the responsibility to administer the Plan for the exclusive benefit of the participants and their beneficiaries. These duties include, but are not limited to, establishing procedures, maintaining records, interpreting provisions of the Plan, and making determinations regarding questions that may affect eligibility for benefits. For the years ended December 31, 2024, and December 31, 2023, the Plan has engaged Automatic Data Processing Retirement Services (“ADP”) as a third-party plan administrator.

For the years ended December 31, 2024, and December 31, 2023, Reliance Trust Company (“Reliance”) served as trustee of the Plan pursuant to the Plan agreement. The trustee received all contributions made under the Plan and held Plan assets.

Participant accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, (b) Plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Also, participants vesting with respect to contributions made by the Plan Sponsor to their 401(k) account balances is 100% vested.

Investment options

Participants are required to make participant-directed allocations of their accounts among various investment options offered by the Plan.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates equal to the prime rate plus one percent as published in the Wall Street Journal on the 14th day of each month, plus one percent (4.25% to 9.50%). Principal and interest are paid ratably through monthly payroll deductions.

Benefit payments

In-service withdrawals of all or a portion of a participant's vested account balance may be made by a participant on incurring a hardship or after reaching age fifty-nine and a half. On termination of service due to death, disability, retirement, or for reasons other than death, disability, or retirement, if the balance of the participant account exceeds \$5,000, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account; a participant may elect to installments over a period of not more than the assumed life expectancy (or the assumed life expectancies of the participant and his or her beneficiary) or participant may elect to make partial withdrawals. The participant may elect to limit the source of such a partial withdrawal to amounts attributable to (1) the participant's rollover account, including amounts attributable to rollovers of Roth elective deferrals, (2) the participant's Roth elective deferral account, including rollovers of Roth elective deferrals held in the rollover account.

NOTE 2: SUMMARY OF ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting. Investments held by the Plan are reported at fair value.

Use of estimates in financial statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Risks and uncertainties

The Plan provided for various investment options in registered investment companies (“mutual funds”). The Plan's exposure to credit losses in the event of nonperformance of investments is limited to the carrying value of such investments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits, participant account balances and the statement of changes in net assets available for benefits.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024, and December 31, 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant's loan to be in default, the loan balance is reduced, and the delinquent participant's note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment valuation and income recognition

Investments in mutual funds are valued at quoted market prices as provided by the trustee. Net appreciation in the fair value of mutual funds represents the change in fair value during the year, including realized and unrealized gains and losses. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Refer note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Basis of fair value measurements

Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities.

Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable. Either directly or indirectly.

Level 3: Prices or valuations that require inputs that are both significant to the fair value measurements and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurements.

The Company evaluates its financial assets and liabilities subject to fair value measurements on a recurring basis to determine the appropriate level of classification as of each reporting period.

Accordingly, as permitted under such election, the Plan administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by Reliance Trust Company, the trustee, except for comparing such information certified by Reliance Trust Company to information included in the Plan’s financial statements and supplemental schedule.

NOTE 7: INCOME TAX STATUS

For the years ended December 31, 2024, and December 31, 2023, the Plan Sponsor entered into a non-standardized arrangement with ADP, LLC, *Non-Standardized Pre-Approved Profit-Sharing/Money Purchase/CODA*. ADP, LLC has received an opinion letter from the Internal Revenue Service (“IRS”) dated *October 06, 2020*, which stated that the form of the non-standardized pre-approved plan and related trust was designed in accordance with applicable sections of the IRC. It is the opinion of the Plan trustee and the Plan’s attorney that the Plan is in compliance with all applicable laws and regulations.

U.S. generally accepted accounting principles require plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, and December 31, 2023, there are no uncertain tax positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8: PARTY-IN-INTEREST TRANSACTIONS

Reliance serves as trustee of the Plan. Reliance performed services for and sold products to and managed and maintained certain investments of the Plan for which fees are paid by the Plan. ADP provides services to the Plan as a third-party Plan administrator for which administration fees are charged to the Plan. Apart from this, the Company provides certain accounting, administrative, and investment management services to the Plan for which no fees are charged. Party-in-interest transactions also include loans made to participants.

Such transactions, while considered party-in-interest transactions under ERISA, are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 9: PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 10: SUBSEQUENT EVENTS

The Plan evaluated all events and transactions that occurred after December 31, 2024, through the date the financial statements were available to be issued. Based on the evaluation:

Change in Trustee

Effective January 01, 2025, the Plan contracted with ADP Retirement Trust Services, LLC to act as directed by the Trustee and the Plan assets were transferred from Reliance Trust Company to ADP Retirement Trust Services, LLC (ADPRTS).
