Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental Schedule H, line 4i—schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1. Plan Description

The following brief description of the Titan Medical Group, LLC 401(k) Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of Titan Medical Group, LLC and affiliated employers (the Company). The affiliated employers include Titan Medical Holdings, Inc. and Titan Nurse Staffing, LLC. Subsequent to year end, effective February 1, 2025, Titan Workforce Solutions, LLC became a participating employer in the Plan.

Employees are eligible to make pre-tax and designated after-tax Roth salary reduction contributions after attaining age 21 and 1,000 hours of service in a consecutive 12-month period of time from the date employment begins. The entry date is any day after the eligible employee has met the eligibility requirements on the measurement dates of the first day of the plan year or the first day of the seventh month of the plan year.

Employees are eligible for discretionary matching contributions and discretionary profit-sharing contributions after becoming eligible to participate in the Plan. There are no additional allocation conditions to receive the discretionary matching contributions once a participant meets the eligibility requirements. To receive profit sharing contributions, a participant must be employed on the last day of the plan year or have at least 500 hours of service in that year. These requirements are waived upon death, disability or attainment of normal retirement age.

Contributions: Participants may make voluntary salary contributions up to 90% of their annual eligible compensation, subject to the maximum dollar amounts allowable by law. The Plan also allows participants to designate a portion or all of their elective contributions as designated after-tax Roth contributions. All participants who are eligible to make deferral contributions and who will attain age 50 before the close of the calendar year shall be eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Discretionary matching and profit-sharing contributions are made at percentages or amounts determined by the Company. There were no profit-sharing contributions made for the year ended December 31, 2024.

Participant accounts: Each participant's account is credited with the participant's contributions and an allocation of: (a) the Company's discretionary matching contribution, (b) the Company's discretionary profit-sharing contribution and (c) Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The Company's discretionary matching contribution is allocated among participants based on each eligible participant's elected salary deferral. The Company's discretionary profit-sharing contribution is allocated among participants based upon eligible compensation of participants. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant.

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and discretionary profit-sharing contributions credited to participants' accounts is based on years of continuous service. A participant becomes 100% vested in Company contributions at normal retirement age, death or disability. A participant is 20% vested after two years of credited service and vesting increases 20% per year until a participant is 100% vested after six years of credited service.

Note 1. Plan Description (Continued)

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by the highest outstanding loan balance in their account during the prior 12-month period. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates. The term of the notes receivable from participants is limited to five years, unless the loan is for the purchase of a primary residence, in which case a longer term may be permitted. Principal and interest are paid through payroll deductions.

Payment of benefits: Upon termination, retirement, disability or death, the participant or beneficiary may elect to receive either partial, lump sum or installment payments equal to the value of the vested funds allocated to the participant's account. If a participant's balance is less than \$1,000, the participant may only receive a lump sum payment. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. Distribution payments between \$1,000 and \$5,000 are directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Participants may also receive in-service and hardship distributions, as permitted in the Plan document. Benefits are recorded when paid.

Revenue sharing account: Fees received from the Plan investments in the form of 12b-1 fees, sub-transfer agency fees and administrative servicing fees, are paid into an In Plan ERISA Account within the Plan. Contractual fees for recordkeeping services and other allowable plan administrative expenses are paid from this account or may be allocated to the participants at the discretion of the Company. For the year ended December 31, 2024, revenue sharing income received totaled \$25,819 and expenses paid totaled \$25,814. The balance of revenue sharing funds at December 31, 2024 and 2023, was \$22 and \$17, respectively.

Forfeitures: Upon a participant's termination of employment before normal retirement, disability or death, the portion of their Company contributions not then vested shall be forfeited. The forfeited portion of any participant's account will be used to reduce future Company contributions or to pay Plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$81,023 and \$41, respectively. During the year ended December 31, 2024, approximately \$125,000 of forfeitures were used to reduce discretionary employer matching contributions and no forfeitures were used to reduce Plan expenses.

Note 2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of accounting: The accompanying financial statements are prepared on the accrual basis of accounting.

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Note 2. Summary of Significant Accounting Policies (Continued)

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Notes receivable outstanding at December 31, 2024, mature through November 2029 and have interest rates ranging from 4.25% to 9.50%. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of benefits: Benefit payments to participants are recorded when paid.

Administrative expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Other reasonable expenses of administration, including investment related expenses, are paid from assets of the Plan and are included in administrative expenses.

Subsequent events: The Plan has evaluated subsequent events through August 12, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by Reliance Trust Company

The following is a summary of the Plan's information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified by Reliance Trust Company, the Trustee of the Plan. The Plan Administrator has obtained certifications from the trustee that information provided to the Plan Administrator by the Trustee related to the following assets is complete and accurate to the best of their knowledge and belief. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and ERISA-required supplemental schedule related to the following:

Note 4. Fair Value Measurements

The Financial Accounting Standards Board Accounting Standards Codification (ASC) Topic 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three-level valuation hierarchy under ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for asset measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common/collective trust: The fair value of the common/collective trust has been determined by referring to the trusts' underlying assets, which are principally guaranteed investment contracts and short-term investments. Units held in the common/collective trust are valued at the unit value as reported by the investment managers. The net asset value (NAV) is used as a practical expedient to determine fair value for these accounts. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

Mutual funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5. Related-Party Transactions and Party-in-Interest Transactions

The Plan paid approximately \$66,000 of record-keeping and other fees paid to related parties and party-in-interest during the year ended December 31, 2024. The Company also provides certain administrative services at no cost to the Plan.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested.

Note 7. Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
