**NOTE 1. DESCRIPTION OF PLAN**

The following description of the OakLeaf Clinics, Inc. Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

***General:***

The Plan is a defined contribution plan. OakLeaf Clinics, Inc. (the Company) is the administrator and sponsor of the Plan. The Plan was established on January 1, 2015, and as of June 1, 2023, uses Reliance Trust Company as the Plan trustee (custodian). The Plan was most recently restated on June 1, 2023. Before June 1, 2023, the Plan used Mid Atlantic Trust Company as the plan trustee and custodian (the "prior trustee"). The participants are responsible for the direction of their account balances into specific investment options and for determining their contribution levels. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

***Eligibility:***

For employee deferrals, employees of the Company who have attained the age of eighteen years or older and completed one month of service are eligible to participate. Plan entry dates are the first day of each month for both employee and employer contributions. For employer contributions, employees of the Company who have attained the age of eighteen years or older, completed one year of service, and accrued 1,000 service hours during a 12-month period of employment per the Plan provisions are eligible to receive employer contributions. To receive discretionary employer non-elective profit-sharing contributions, the participant must be employed on the final day of the Plan year.

***Contributions:***

Each year, participants may contribute, through salary reduction and post-tax Roth contributions, up to 100% of compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan includes an automatic-enrollment provision where newly eligible participants and eligible participants not participating in the Plan automatically have 3% of compensation withheld, unless specifically elected otherwise by the participant. The contribution rate will automatically increase by 1% annually until the participant has reached a 15% contribution rate. The Plan requires an employer safe harbor non-elective contribution of 3% of the participant compensation. The Company may make discretionary matching and profit-sharing contributions. No discretionary matching contributions were made for the years ended December 31, 2024 and 2023. Discretionary profit-sharing contributions in the amounts of \$1,733,272 and \$1,728,182 were made for the years ended December 31, 2024 and 2023, respectively. Contributions are subject to certain IRS limitations.

**NOTE 1. (CONTINUED)**

***Participant accounts:***

Each participant's account is credited with participant pre-tax deferrals, participant post-tax Roth contributions, company non-elective safe harbor contributions, any other discretionary contributions made by the company and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations of the Company discretionary contributions are based on participant compensation, as defined in the Plan. Participant accounts are valued at the end of each business day. The benefit the participant is entitled to is the benefit that can be provided from the participant's vested account.

***Vesting:***

Participants are 100% vested in their retirement savings contributions account, rollover account and safe harbor non-elective contributions account. If a participant's employment with the Company ends for any reason other than retirement, permanent disability or death, he or she will vest in the employer discretionary profit sharing and matching contributed balances in his or her account based on total years of service with the Company. Participants vest on a six-year graded schedule for employer discretionary profit sharing and matching contributions.

***Notes receivable from participants:***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balances or \$50,000. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 5.50% to 10.00%, which are commensurate with prevailing market rates. Rates are determined quarterly at 2% plus prime rate of interest. Loans must be repaid within five years, except a loan used to build or purchase a principal home may be repaid over a fifteen-year period. Principal and interest are paid through bi-weekly payrolls or through a bank wire from the participant's bank account based on a predetermined loan payback agreement.

***Payments of benefits:***

Distributions to terminated or retired participants are made in a single lump-sum payment to the participant (or in the case of death, the participant's beneficiary) or periodic installments over a period specified by the Plan. If terminated/retired participants do not voluntarily elect to move their funds out of the Plan, vested account balances between \$1,000 and \$5,000 are rolled into an IRA on the employee's behalf. Vested account balances less than \$1,000 are paid to the participant in a single lump sum.

Active (not terminated/retired) participants experiencing financial hardship may withdraw a portion of their account balance as defined in the Plan and withdrawals are limited pursuant to the Plan's provisions.

**NOTE 1. (CONTINUED)**

***Forfeited accounts:***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$51,467 and \$58,056, respectively. These accounts will be used to reduce future employer contributions or pay Plan administrative expenses. During the year ended December 31, 2024, \$110,212 and \$0 of forfeitures were used to reduce employer contributions, respectively. During the year ending December 31, 2023, no amounts were used to reduce employer contributions or pay Plan expenses.

**NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of accounting:***

The financial statements of the Plan are maintained on the accrual basis of accounting.

***Use of estimates:***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment valuation and income recognition:***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 4 for the discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes receivable from participants:***

Notes receivable from participants are measured at their unpaid principle balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are charged directly to the borrowing participant's account and are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

***Payment of benefits:***

Benefits are recorded when paid.

***Expenses:***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in the administrative expenses. Fees related to certain administrative activities are paid for by the Plan and are included in the administrative expenses. Investment-related expenses are included in the net appreciation of fair value of investments.

***Subsequent events:***

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through August 15, 2025, the date the financial statements were available to be issued. Effective January 1, 2025, the Plan was amended and restated to update the allocation method of Employer discretionary profit-sharing contributions.

**NOTE 3. CERTIFICATION OF INVESTMENT INFORMATION**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Mid Atlantic Trust Company and Reliance Trust Company, the trustees (custodians) of the Plan, have certified as to the completeness and accuracy of all investment held at fair value and notes receivable information reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ending December 31, 2024 and 2023, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

***Level 1:*** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Common collective trust (CCT):** Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is at a readily determinable fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5. PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Reliance Trust Company. Reliance Trust Company is the custodian and ADP Recordkeeping Services is the record-keeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Certain fund level fees incurred by the funds in which the Plan invests for such services as investment management, shareholder services, and sub-transfer agency fees are paid through fund level revenue sharing arrangements. These fees reduce fund earnings thereby impacting Plan revenue applied to participants' accounts. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**NOTE 7. PLAN TAX STATUS**

The Plan is placing reliance on an advisory opinion letter dated October 6, 2020 received from the Internal Revenue Service (IRS) on the ADP Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA indicating that the Plan is qualified under Section 401 of the Internal Revenue Code (IRC) and is therefore not subject to tax under the current income tax law. The prototype Plan has been amended since receiving the opinion letter; however, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 9. SECURE ACT 2.0**

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and will determine optional provisions to elect in the future.
