**NOTE A – SUMMARY DESCRIPTION OF PLAN**

The following description of the Charles Matoian Enterprises, Inc. DBA OK Produce 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution 401(k) Profit Sharing Plan covering all full-time employees, except union employees governed by a collective bargaining agreement, of Charles Matoian Enterprises, Inc. dba OK Produce who have completed ninety days of service and are age twenty-one and older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

***Contributions***

Each year, participants may contribute a portion of pre-tax compensation, as defined in the Plan. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5 percent of eligible compensation and their contributions invested in a designated investment option until changed by the participant. The Company makes a safe harbor contribution of 100 percent of a participant's salary deferral, up to 6 percent of compensation. The Company may also make matching, nonelective (profit sharing), and discretionary matching contributions. Discretionary matching contributions, if any, are limited to 4 percent of eligible compensation contributed to the Plan. To qualify for the safe harbor, matching, and nonelective contributions, and discretionary matching contribution participants need to complete one year of service and 1,000 hours. The Company made a safe harbor matching contribution of \$891,857 for the year ended December 31, 2024. Contributions are subject to certain IRS limitations.

***Investment Options***

Plan participants direct the investment of their account balances into various investment options offered by the Plan and can change their investments at any time. The Plan currently offers various mutual funds, collective investment trust funds, and a stable value fund, as investment options for participants.

***Participant Accounts***

Each participant's account is credited with the participant's contributions and Company's safe harbor matching contributions, as well as allocations of the Company's discretionary contribution, if any, and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are vested immediately in their contributions and the Company's safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50 percent of their vested account balance for hardship loans and 10 percent of their vested account balance for all other loans. Up to two loans may be outstanding at any time. The notes are secured by the balance in the participant's account and bear interest at local prevailing rates ranging from 4.25 to 9.50 percent, as of December 31, 2024 and 2023. Principal and interest is paid ratably through payroll deductions. Generally, the term of the loan may not exceed five years.

***Payment of Benefits***

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in their account, annual installments, or partial withdrawals. For termination of service for other reasons, a participant, whose vested account balance does not exceed \$5,000, may only receive the value of the vested interest in their account as a lump sum distribution. If the vested balance exceeds \$5,000 the participant may elect to receive either a lump sum, annual installments, or a partial withdrawal. Assets allocated to participants who have terminated but have not withdrawn from the Plan as of December 31, 2024 total \$2,949,691.

***Forfeited Accounts***

As of December 31, 2024 and 2023, the forfeited non-vested account totaled \$10. This account is generally used to pay administrative expenses for the Plan and then to reduce future employer contributions. In 2024, employer contributions were reduced by \$215 from forfeited non-vested accounts.

**NOTE B – SIGNIFICANT ACCOUNTING POLICIES*****Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by Reliance Trust Company. See Note D for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

***Distributions Payable***

Distributions payable represents uncleared checks held for the benefit of the participants until such a time as they have been cashed by the participants. Management has reissued the checks, the majority of which were cleared before the date the financial statements are available to be issued.

***Payment of Benefits***

Benefits are recorded when paid.

***Administration Expenses***

All significant expenses of maintaining the Plan are paid by the Plan and expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' account and are included in administrative expenses. Indirect investment related expenses are included in net appreciation in fair value of investments.

***Management's Review of Subsequent Events***

Management has evaluated subsequent events through August 01, 2025, the date the financial statements were available to be issued.

**NOTE D – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Registered investment companies (mutual funds):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE E – FULLY BENEFIT-RESPONSIVE INVESTMENT**

The Plan offers a fully-benefit responsive stable value fund investment through Invesco Trust Company (Invesco), with custodial services provided by Reliance Trust Company. The Trust invests 100% of its assets in Class C units of Invesco Stable Value Trust. The Trust is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The stable value fund meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Invesco, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

**NOTE E – FULLY BENEFIT-RESPONSIVE INVESTMENT – (Continued)**

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the Plan's ability to transact at contract value with Invesco. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (e) premature termination of contract.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (a) an uncured violation of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a breach of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

**NOTE F – RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Reliance Trust Company manages certain Plan investments. Reliance Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. A portion of the revenue sharing is received by the plan as a credit towards plan expenses and reported as other income. As described in Note B, the Plan made direct payments to the third-party administrator for recordkeeping services, to the independent auditor for Plan audit services, and to a third-party investment advisor for Plan advisory fees totaling \$137,775 for the year ended December 31, 2024. The Plan sponsor pays directly any other fees related to the Plan's operations.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE G – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**NOTE H – TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. Although, the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or Department of Labor. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no significant uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the Internal Revenue Service and the Department of Labor; however, there are currently no audits for any tax periods in progress.

**NOTE I – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
