### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the Providence Mutual Fire Insurance Company Profit Sharing & 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Providence Mutual Fire Insurance Company Profit Sharing & 401(k) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Providence Mutual Fire Insurance Company Profit Sharing & 401(k) Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

**1. Description of Plan**

The following description of the Providence Mutual Fire Insurance Company (the “Company”) Profit Sharing & 401(K) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**

The Plan was established on July 5, 1972. As a non-standardized profit-sharing plan, the Plan is entitled to be treated as a qualified plan under Internal Revenue Code (“IRC”) Sections 401(a) and 401(k). The Plan is a defined contribution plan covering substantially all eligible employees who have reached the age of 21 for elective employee deferrals and employer contributions. The Plan entry date is the day on which eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Board of Directors is responsible for the oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Directors.

On March 27, 2020, in response to the economic impact caused by the Coronavirus (COVID-19) pandemic, the Coronavirus Aid, Relief, and Economic Security (“CARES”) Act was signed into law. As part of the CARES Act, certain universal changes were implemented related to retirement plans, including waiving required minimum distributions for the 2020 calendar year and waiving the 10% early distribution penalty tax for participants affected by the pandemic. The CARES Act also contained provisions which allowed for Plan administrators to make amendments and elections to the Plan to provide greater access to retirement funds for participants impacted by the pandemic. Some of the allowable elections contained within the CARES Act included allowing expanded in-service distributions, increasing Plan limits on loans to \$100,000 or 100% of the participant’s vested balance, and offering suspensions of loan repayments, without default, until December 31, 2020. The Plan administrator had the ability to choose which elections the Plan would make; there was no requirement for Plans to adopt any of these provisions. The Plan administrator made the election to adopt the above provisions during the Plan year ending December 31, 2020. While these provisions were, operationally, enacted immediately upon the Plan administrators’ election, the Plan will not have to be formally amended to incorporate the changes until December 31, 2025. The Plan administrator has indicated that it is their intention to amend the Plan by that date.

**Contributions**

Each year, participants may contribute up to a maximum of 99% of their annual compensation, as defined in the Plan, or the maximum amount allowable by the IRC, through a salary reduction agreement. Total participants’ deferrals may not exceed \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to the IRC limit (\$7,500 in 2024 and 2023). Participants may also contribute amounts representing distributions from other qualified plans.

**Contributions (continued)**

Participants are automatically enrolled in the Plan after meeting eligibility requirements at a contribution percentage of 4% of eligible compensation, as defined by the Plan, unless they opt out. Effective January 1, 2024, each January 1st any participants that have been automatically enrolled into the Plan will increase their deferral by 1% up to a maximum of 10%.

Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan also allows matching and profit-sharing contributions which are discretionary and determined annually by the Company's Board of Directors. For the years ended December 31, 2024 and 2023, the Company's matching contribution was equal to 30% up to the first 10% of each employee's eligible compensation contributed to the Plan and totaled \$110,714 and \$233,405, respectively. See the Plan document for the definition of eligible compensation. For the years ended December 31, 2024 and 2023, the Company made profit sharing contributions to the Plan of \$534,889 and \$490,565, respectively.

**Participant accounts**

Each participant's account is credited with the participant's contributions, rollover contributions, Company discretionary employer matching contributions, Company discretionary profit-sharing contributions, as well as allocations of Plan earnings. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their voluntary and rollover contributions plus actual earnings thereon. Vesting in the Company's matching and profit-sharing contributions plus actual earnings is based on the number of years of credited service. A participant is 100% vested in the Company's matching contributions after six years of credited service and in the Company's profit-sharing contributions after three years of credited service.

**Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Notes fund. Loan terms range from one to five years or longer as permitted by the Plan administrator for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate equal to the prime interest rate (7.50% and 8.50% at December 31, 2024 and 2023, respectively) plus 1%. Principal and interest is paid ratably through payroll deductions. The Plan allows for a maximum of one loan outstanding at any one time.

**Payment of benefits**

If a participant terminates employment with the Company prior to early retirement as defined in the Plan document, they will be entitled to receive the vested percentage of their account balance. In the event of early retirement, disability or death, the participant shall immediately become 100% vested in their account. Participants may elect to receive either a lump-sum amount or receive their distribution in substantially equal installments or they can defer payment until further notification if the account balance is in excess of \$5,000. Upon separation from service, if the participant's vested account balance is between \$1,000 and \$5,000 and the participant does not elect to take a distribution, the Plan administrator may make a lump-sum distribution to a direct rollover individual retirement account.

Participants may make limited in-service withdrawals, as defined by the Plan document, from their accounts. Participants who have a serious financial hardship may make a withdrawal from their eligible account balance, as defined in the Plan document.

**Forfeited accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$15,001 and \$74,990, respectively. Forfeitures may be used to pay administrative expenses and reduce Company contributions for the Plan.

For the Plan years ended December 31, 2024 and 2023, \$169,382 and \$30,647, respectively, of forfeitures were used to offset Employer contributions.

**2. Summary of significant accounting policies**

**Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amount of changes in net assets available for benefits during the reporting period, and disclosure of contingent assets and liabilities. Estimates are principally used in the determination of the fair value of investments. Actual results could differ from those estimates.

**Investment valuation and income recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market

participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, trustee, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Contributions**

Contributions from Plan participants, and the matching and profit-sharing contributions from the Company are recorded in the year in which contributions are withheld from their compensation.

**Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, that participant loan balance is reduced, and a benefit payment is recorded.

**Payment of benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company, unless the Company directs that such expenses shall be paid by the Plan. Expenses paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions to participants are charged directly to the participant's account and are included in administrative expenses. For 2024 and 2023, asset charges as a percentage of total Plan assets are included in administrative expenses. Investment related expenses are included in net appreciation of fair value investments.

**Subsequent events**

The Plan did not have any subsequent events through July 23, 2025, which is the date the financial statements were available to be issued, for events requiring recording or disclosure in the financial statements for the year ended December 31, 2024.

**3. Information prepared and certified by the trustee**

Certain information presented in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, dividends and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan administrator by ADP Retirement Services (“ADP”), the record keeper and custodian, and certified as complete and accurate by Reliance Trust Company (“Reliance”), the trustee of the Plan. The certifications also included schedules of investments and inter-fund transfers.

**4. Fair value measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) *Accounting Standards Codification* (“ASC”) 820, *Fair Value Measurements and Disclosures* are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for Plan investments. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds:**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Common collective trust:**

Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common collective trusts, the investment adviser reserves the right to temporarily delay withdrawal from the trusts in order to ensure that securities liquidations will be carried out in an orderly business manner. See Note 5 for more information.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Investment contract with common collective trust**

The Plan invested in the Metlife Reliance Stable Value Fund as of December 31, 2024 and 2023, a fully benefit-responsive investment contract through a common collective trust in the Plan. The common collective trust's contract value is a relevant measurement attribute since the contract value is the amount participants would receive if they were to initiate permitted

transactions under the terms of the Plan. Therefore, this is the value included in Plan investments for the 2024 and 2023 Plan years. One of the primary risks involved with investment contracts is credit risk of the contract issuer; there are no reserves against contract value for credit risk of the contract issuer or otherwise if termination of the contracts were to occur.

**6. Related party and parties-in-interest transactions**

Certain Plan investments are managed by ADP and Reliance. ADP is the record keeper and custodian for the Plan and Reliance is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. All expenses of administration may be paid out of the participants' account unless paid by the Company. Fees paid by the Plan for investment management services are included in net appreciation in fair value of investments. The Plan also issues loans to participants which are secured by the balances in their accounts.

The Plan is administered by a directed trustee appointed by the Board of Directors of the Company. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**7. Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in all amounts allocated to their accounts.

**8. Tax status**

The Company has adopted a non-standardized profit-sharing plan document and is relying on the non-standardized profit-sharing plan sponsor's opinion letter from the Internal Revenue Service ("IRS") dated October 6, 2020. The letter states that the non-standardized profit-sharing plan and related trust are designed in accordance with applicable sections of the IRC. Although the non-standardized profit-sharing plan has been amended since receiving the opinion letter, the Plan's administrator and the Plan's tax counsel believe that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or

asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**9. Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
