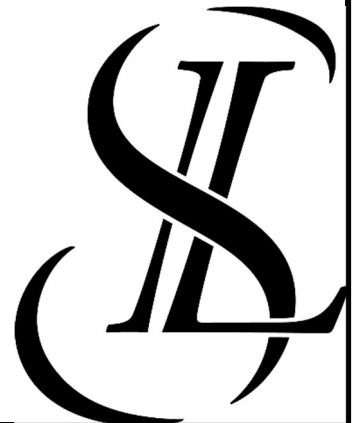

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Vaughan-Bassett Furniture Company, Inc. Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"), which comprise the statements of net assets available for benefits as of November 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements ("financial statements").

### 1. Description of Plan

The following description of the Vaughan-Bassett Furniture Company, Inc. Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all employees of Vaughan-Bassett Furniture Company, Inc. and its subsidiary, Webb Furniture Enterprises, LLC (collectively, the “Company”). Employees who have completed one year of service with at least 1,000 hours are eligible to participate in the Plan. Plan entry dates are either December 1 or June 1. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

#### **Contributions**

The Company may make a discretionary profit sharing contribution to the Plan as determined by its Board of Directors. Participants generally must be employed by the Company as of November 30 and have completed 1,000 hours of service to participate in the profit sharing contribution. Each eligible participant’s account is credited with an allocation of the profit sharing contribution based upon their compensation to total compensation of all eligible participants. However, no discretionary profit sharing contributions were made for 2024 or 2023.

Participants may also contribute amounts representing distributions from other qualified plans (“rollovers”).

#### **Participant Accounts**

Each participant’s account is credited with the Company’s contributions, and an allocation of plan earnings, administrative expenses, and forfeitures of terminated participants’ non-vested accounts. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### **Vesting**

Participants vest in the Company’s discretionary profit sharing contributions plus actual earnings thereon based upon years of continuous service according to the following schedule.

#### **Payment of Benefits**

Lump sum distributions are available for normal retirement, disability retirement, death, or termination of employment.

#### **Forfeitures**

Forfeitures are reallocated to active participants’ accounts in the same manner as the Company’s discretionary profit sharing contribution. Forfeitures reallocated to active participants’ accounts were approximately \$12,800 and \$23,200 for the years ended November 30, 2024 and 2023.

### 1. Description of Plan (Concluded)

#### ***Administrative Expenses***

The Company absorbs substantially all expenses incidental to the administration of the Plan. Distribution and terminated participant fees are paid from affected participant accounts.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual basis of accounting.

#### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Subsequent Events***

Management has evaluated events occurring subsequent to the date of the financial statements through August 14, 2025, the date the financial statements were available to be issued, and has determined that no events have occurred that require adjustments to or additional disclosure in the financial statements.

### 3. Certified Investment Information

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at November 30, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest, and dividends for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Alerus Financial, N.A. ("Alerus").

### 4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 5. Income Tax Status

The Plan has adopted a prototype plan document sponsored by Alerus. The Internal Revenue Service (“IRS”) has determined and informed Alerus by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan has been amended since the date of the determination letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with applicable provisions of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and terminate the Plan. In the event of plan termination, participants will become 100% vested in their accounts.

### 7. Party-in-Interest Transactions

Fees paid by the Plan to Alerus were approximately \$7,100 and \$9,400 in 2024 and 2023.

### 8. Fair Value Measurements

The Plan has adopted Accounting Standards Codification 820, “Fair Value Measurements and Disclosures” (“ASC 820”), which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The three levels of the fair value hierarchy under ASC 820 are as follows:

#### ***Basis of Fair Value Measurement***

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 30, 2024 and 2023.

*Mutual funds:* Valued at the net asset value (“NAV”) of shares held by the Plan at year-end. The NAV for these investments is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

*Common collective trust funds:* Units in the Vanguard Retirement Savings Trust Fund (“VRST”) are valued at NAV at year-end. The VRST invests primarily in investment contracts issued by insurance companies, banks, or other financial institutions. Participant-directed redemptions have no restrictions. This investment is classified within Level 2 of the valuation hierarchy as the NAV is a derived price in an active market as determined by the fund trustee based on the contractual terms of the underlying contracts.

### 8. Fair Value Measurements (Concluded)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
