Independent Auditor's Report

To the Plan Administrator
Branford Group 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Branford Group 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Branford Group 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.



1. DESCRIPTION OF PLAN

The following description of the Branford Group 401(k) Plan (the Plan) for eligible employees of Branford Group provides only general information. Participants should refer to the plan document and subsequent amendments for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan, sponsored by Branford Chain, Inc. (Branford) and the subsidiaries of Branford, including Dreyfus-Cortney, Inc. (Dreyfus), Washington Chain & Supply, Inc. (Washington), and Lister Chain & Forge, Inc. (Lister) (collectively, the Employer or the Plan Sponsor). The Plan is offered to all qualifying employees who have completed three months of service, excluding apprentices, Canadian employees, and employees covered by a collective bargaining agreement including Lister union employees who were excluded effective June 1, 2019. Additionally, employees scheduled to work less than 1,000 hours of service in any 12-month period, shall not be eligible to contribute to the Plan. Eligible employees are enrolled into the Plan on the first day of the month after eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan fiduciaries are responsible for oversight of the Plan and determine the appropriateness of the Plan's investment offerings and monitor investment performance.

In July 2010, E-Mon, LLC (E-Mon), a previously owned subsidiary of Branford, was sold to Honeywell International, Inc. (Honeywell). As a result, E-Mon employees are no longer contributing into or requesting loans from the Plan. Account balances of E-Mon participants who became employees of Honeywell are available for distribution. The amounts distributed may be rolled over directly into the 401(k) plan of Honeywell or into an IRA. As of December 31, 2024, and 2023, there are E-Mon employees that have remaining participant account balances.

Effective December 31, 2012, American Condenser and Coil, LLC (ACC) no longer participates in the Plan. As a result, ACC employees are no longer contributing into or requesting loans from the Plan. Account balances of ACC participants are available for distribution and may be rolled over directly into the new plan ACC has established separately for its employees. ACC's new plan was approved and adopted effective January 15, 2013. ACC ceased operations in December of 2012. As of December 31, 2024 and 2023, there are ACC employees that have remaining participant account balances.

In August 2005, Jered Industries, Inc. (Jered), a previously owned subsidiary of Branford, was sold to a newly formed Jered LLC subsidiary of PaR Systems. As a result, Jered employees are no longer contributing into or requesting loans from the Plan. As of December 31, 2024 and 2023, there are Jered employees that have remaining participant account balances.

Fidelity Management Trust Company (the Trustee) serves as the trustee of the Plan.

Contributions - Each year, participants may elect a deferral up to 50 percent of pre-tax compensation, as defined in the Plan document, up to the maximum allowed by the Internal Revenue Code (IRC), as defined in the Plan. For the 2024 and 2023 plan years, the 401(k)-deferral limit was \$23,000 and \$22,500, respectively. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The maximum catch-up contribution permitted for both 2024 and 2023 was \$7,500. Participants may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer makes safe harbor matching contributions on behalf of qualifying non-union contributing participants on the following basis: An amount equal to 100 percent of the first 3 percent of any active participant's eligible compensation contributed to the Plan and 50 percent of the next 2 percent of the active participant's eligible compensation contributed to the Plan, subject to limitations under the IRC. The total matching contribution percentage on behalf of any contributing participant may not exceed 4 percent of compensation. For December 31, 2024, the Employer made safe harbor matching contributions of \$380,743.

Participant accounts - Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contributions and withdrawals, allocations of the Employer's contributions, an allocation of investment earnings or losses, and administrative expenses. Allocations are based on participant earnings, account balances, or as defined in the plan document. Refer to Note 2 for information on investment transactions and income recognition on individual participant's account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments - The Plan's investments are held by the Trustee. Money market and mutual funds are available as investment options for participants' salary deferrals, Employer safe harbor contributions, and rollovers.

Vesting - Participants are immediately vested in their voluntary contributions and safe harbor matching contribution account plus actual earnings thereon. Non-elective employer contributions, additional matching employer contributions and any earnings thereon vest at 20 percent each year and are fully vested after five years of service. For participants who were union employees of Lister on or prior to May 31, 2019, employer profit sharing contributions and any earnings thereon vest at 25 percent each year beginning after two years of service and are fully vested after five years of service.

Notes receivable from participants - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loan fund. Loan terms range from one to five years, unless the loan is for the purchase of a primary residence, which may extend the loan term to a period of time greater than five years. Participants are allowed to have two outstanding notes at any given time. Principal and interest are paid ratably through payroll deductions. The loans are secured by the balance of the participant's account and bear interest at a reasonable rate as determined by the Plan administrator at the time the loan is approved.

Payment of benefits - On termination of service due to death, disability, or retirement, a participant or their beneficiaries may elect to receive a lump-sum amount equal to the value of the participant's account balance with full vested rights. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Forfeited accounts - Forfeitures resulting from the nonvested portions of participants' accounts who terminate prior to being fully vested are generally used first to pay administrative expenses and second, to reduce Employer contributions. At December 31, 2024 and 2023, the Plan had \$1,661 and \$1,583, respectively, of forfeitures that had not been used to pay administrative expenses or applied to reduce the Employer's contributions. For the 2024 and 2023 plan years, the Plan used \$0 and \$205, respectively, from forfeited nonvested participant accounts to pay for administrative expenses or to reduce the Employer's contributions.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of accounting - The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP), and are stated in United States Dollars. The following is a summary of the significant accounting policies used in preparing the financial statements:

Use of estimates - The preparation of financial statements in accordance with U.S. GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and changes in net assets available for benefits during the year. Accordingly, actual results could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year such adjustments are determined.

Investment valuation and income recognition - The Plan's investments are held by the Trustee in various money market and mutual funds. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of money market and mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end.

Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation or depreciation in the fair value of investments includes the realized gains or losses and the unrealized appreciation or depreciation on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net appreciation or depreciation in fair value of investments.

Notes receivable from participants - Notes receivable from participants are valued at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses had been recorded as of December 31, 2024 and 2023. The financial statements include the delinquent loan balances until specifically written off. Form 5500 reflects delinquent loans as distributions. Included in the benefit payments to participants are discharged loans amounting to \$1,512 and \$21,538 for the years ended December 31, 2024 and 2023 respectively.

Participants may also obtain a cash withdrawal of all or a portion of the value of their vested balance including rollover contributions on the basis of hardship as permitted under the Plan.

Payment of benefits - Benefit payments to participants are recorded when paid.

Expenses - Certain expenses of maintaining the Plan are paid directly by the plan sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events - The Plan's management has evaluated the period from January 1, 2025 to August 20, 2025, the date the financial statements were available to be issued, and has determined that there are no subsequent events that require disclosure under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 855, *Subsequent Events*.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Money market and mutual funds are valued at the daily closing price as reported by the fund. The money market fund held by the Plan is interest-bearing and is valued at \$1.00 per share. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds and money market fund held by the Plan are deemed to be actively traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

4. INFORMATION CERTIFIED BY TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Fidelity Management Trust Company, the Trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

5. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain plan investments are shares of mutual funds and a money market fund managed by Fidelity Investments Institutional Operations Company, Inc. (Fidelity). As defined by the Plan document, the Trustee is an affiliate of Fidelity and, therefore, these transactions qualify as exempt party in interest transactions. Notes receivable from participants are also party in interest transactions.

In addition, fees paid by the Plan to Fidelity for recordkeeping services amounted to \$5,621 for the year ended December 31, 2024, and is included in administrative expenses in the Statement of Changes in Net Assets Available for Benefits. Fees included by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue-sharing, rather than a direct payment. The plan sponsor pays directly any other fees related to the Plan's operations.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their employer contributions.

7. TAX STATUS

The Plan uses a prototype plan document sponsored by FMR LLC. FMR LLC received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which stated that the prototype document satisfied the applicable provisions of the IRC. Although the Plan has been amended since the effective date of the opinion letter, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore, believes the Plan is qualified and the related trust is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. These investments in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the Statements of Net Assets Available for Benefits.
