Opinion

We have audited the accompanying financial statements of CFC ESOP (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of CFC ESOP as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of CFC ESOP and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about CFC ESOP's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. (1) Description of the Plan

The following brief description of the CFC ESOP (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Document for complete information.

- (a) General – Carris Financial Corp. (“CFC” or the “Company”) established the ESOP effective January 1, 1995. The Plan is designed to comply with the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Trustees oversee governance of the Plan. Company contributions are held and managed by the Trustees, which invest cash received and make distributions to participants.
- (b) Contributions – The Plan owns 100% of the outstanding stock (1,300,000 shares) of CFC. The Company contributes cash to the Plan as determined by the Board of Directors of CFC in its role as plan administrator. The Company made contributions to the ESOP for the purpose of repurchasing shares in the amount of \$5,780,038 and \$6,010,403 for the years ended December 31, 2024 and 2023, respectively. In 2024 and 2023, the Company also declared an s-corp distribution in the amount of \$7,875,773 and \$5,776,363, respectively, to repurchase shares in excess of the contributions.
- (c) Participant Accounts – Employees of CFC and its participating subsidiaries are generally eligible to participate in the Plan after 12 months of service provided they worked at least 1,000 hours during the Plan year. Participants who do not have at least 1,000 hours of service during the Plan year or who are not employed on the last working day of the Plan year are generally not eligible for an allocation of CFC contributions for the year.
- (d) Vesting – Participants’ accounts vest according to the following schedule:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 2 years	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 years or more	100%

Normal retirement occurs at age 65. Employees may elect early retirement at age 55 with 10 years of service. Effective January 1, 2025, early retirement age was increased to 60.

- (e) Voting Rights – Each participant is entitled to voting rights on a one participant/one vote basis and is notified by the Trustees prior to the time that such rights are to be exercised.

Description of the Plan (continued)

- (f) Payment of Benefits – Distributions from the Plan are made when a qualified participant retires, dies, or otherwise terminates employment with CFC or its participating subsidiaries. The distribution is based on the number of shares vested in the participant's account and the fair market value of those shares, as determined by the most recent appraisal of CFC's shares.

Under federal income tax regulations, employer stock that is not readily tradable on an established market includes a put option, giving participants the right to require CFC to purchase distributed shares at the appraised value. This ensures participants can convert shares to cash even in the absence of a public market.

Distributions for death, disability, or retirement were made in lump sum payments. Effective January 1, 2025, if the participant's vested balance is less than \$5,000, the payment will be made in a lump sum. For amounts greater than \$5,000, the distribution can be made in substantially equal installments, not to exceed five years with minimum installments of \$200,000.

- (g) Diversification – Participants who are at least age 55 with at least 10 years of participation in the Plan are able to elect to diversify a portion of their account by transferring these funds to their CFC Retirement Plan accounts. During 2024 and 2023, the total diversification amount was \$2,104,185 and \$1,607,045, respectively. The diversification amounts are included in distributions to participants on the accompanying statements of changes in net assets available for benefits.
- (h) Investment Valuation – The Plan is generally 100% invested in the stock of its sponsor company, CFC. The investment is stated at fair value as determined by an independent third party valuation expert in the absence of readily ascertainable market values. Many factors are considered in arriving at fair value, including discounted cash flows and comparisons to similar companies.

At December 31, 2024 and 2023, there were 1,300,000 shares in the Plan with a value of \$75.01 and \$67.90 per share, respectively, as determined by an independent third party valuation expert.

- (i) Termination – CFC reserves the right to terminate the Plan and Trust agreement at any time, subject to Plan provisions. Upon such termination, the interest of each participant will be distributed as prescribed by the Plan terms and the Internal Revenue Code. Upon termination of the Plan, the Trustees shall pay all liabilities and expenses from assets of the Trust fund.

(2) Summary of Significant Accounting Policies

- (a) Basis of Accounting – The financial statements of the Plan are prepared under the accrual basis of accounting.

- (b) Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.
- (c) Allocation of Contributions – Employer contributions are allocated to the accounts of Plan participants in the form of shares based on eligible compensation.

For purposes of employer contributions, compensation was limited to \$62,329 and \$60,572 for 2024 and 2023, respectively.

- (d) Administrative Expenses – Administrative expenses of the Plan are paid by the Company.
- (e) Forfeitures – Forfeitures represent amounts not paid to terminated participants due to failure to meet vesting requirements. Forfeitures are added to CFC’s contributions and allocated to remaining participants. The number of shares forfeited was 4,636 and 7,660 for the years ended December 31, 2024 and 2023, respectively. Based on the respective share value, total forfeitures amounted to \$347,775 and \$520,099 for the years ended December 31, 2024 and 2023, respectively.
- (f) Payment of Benefits – Benefit payments are recorded when paid.
- (g) Subsequent Events – The Plan evaluated subsequent events through August 11, 2025, the date the Plan’s financial statements were available to be used.

(3) Concentration of Credit Risk

The Plan is designed to and invests solely in the securities of CFC. This investment is not insured and is exposed to various risks. Due to the level of risk associated with this investment, it is at least reasonably possible that changes in the values of the investment will occur in the near term. Such changes could materially affect the financial statements.

(4) Withdrawing Participants

All benefit payments that have been processed and approved for payment prior to year-end have been paid, with the exception of one \$43,961 distribution that was redeposited before year-end. This will be paid in 2025.

(5) Parties-in-Interest

The Plan has multiple service providers. Such parties are considered parties-in-interest under ERISA.

Certain administrative functions are performed by officers or employees of the Company or its subsidiaries. No such officer or employee receives compensation from the Plan.

(6) Income Tax

The Internal Revenue Service has ruled that the Plan qualifies under Section 401(a) of the Code and is therefore not subject to tax under current income tax laws. The Plan received a favorable determination letter on April 28, 2017. Although the Plan has been amended since receiving the determination letter, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

(7) Fair Value Measurements

Generally accepted accounting principles in the United States of America establish a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Fair Value Measurements (continued)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

All investments held at December 31, 2024 and 2023 are categorized as Level 3 assets as the fair value of the CFC common stock held by the Plan is valued at estimated fair value based upon an independent appraisal. The appraisal valued the common stock of CFC on a going-concern basis and it was based on a combination of the cost, market, and income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, market comparables, and estimated fair value of Company assets and liabilities. Significant reliance was placed on a calculation of value using discounted cash flows method.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Trustees of the Plan, under the supervision of the Company's Board of Directors, determine the fair value measurement policies and procedures in consultation with the Company's chief financial officer. Those policies and procedures are reassessed at least annually to determine if the current valuation techniques are still appropriate. At that time, the unobservable inputs used in the fair value measurements are evaluated and adjusted, as necessary, based on current market conditions and other third-party information.
