### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Shook Construction Co. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Shook Construction Co. Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### **Opinion**

**NOTE A - DESCRIPTION OF THE PLAN**

The following description of the Shook Construction Co. Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) profit sharing retirement plan sponsored by Shook Construction Co. (the Company) and covers all eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

The Plan includes three separate eligibility provisions. Each employee who is a non-highly compensated employee and has been employed for thirty calendar days with at least one hour of credited service, which constitutes as covered employment under the Davis-Bacon Act or any state or municipal "Prevailing Wage" law, will be eligible for prevailing wage contributions as defined under the terms of the Plan Agreement. Each employee who has been employed for thirty days and is at least eighteen years of age will be eligible for elective deferral, employer matching, and qualified non-elective contributions as defined under the terms of the Plan Agreement. Each employee who has been employed for a year with at least one thousand hours of credited service during the year and is at least eighteen years of age will be eligible for profit sharing contributions as defined under the terms of the Plan Agreement. Plan entry dates for elective deferrals, employer matching, and qualified non-elective contributions are the first day of the month coinciding with or next following the date of completion of eligibility requirements. Plan entry dates for the profit sharing contributions are January 1, April 1, July 1, and October 1 coinciding with or next following the date of completion of eligibility requirements.

Contributions

- (a) *Participant's voluntary salary reductions.* Participants may elect to contribute up to 75% of their compensation, as defined in the Plan. Each participant's contribution may not exceed the federal maximum amount pursuant to Section 402(g) of the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Additionally, the Plan provides for catch-up contributions for participants age 50 or older.

- (b) *Matching contributions.* The Company shall contribute to the Plan on behalf of each participant who made a matched employee contribution in an amount equal to (i) 100% of the matched employee contributions that are not in excess of 3% of the participant's compensation, plus (ii) 50% of the amount of the matched employee contributions that exceed 3% of the participant's compensation but that do not exceed 5% of the participant's compensation. Matching contributions of \$646,771 were made for the year ended December 31, 2024.
- (c) *Discretionary profit sharing contributions.* The Company may, in its sole discretion, make discretionary profit sharing contributions to the Plan on behalf of each participant. The Company did not elect to make a discretionary contribution for the year ended December 31, 2024.
- (d) *Qualified nonelective contributions.* The Company, in its sole discretion, may make additional qualified nonelective contributions for the benefit of all participants eligible to make elective deferrals who are non-highly compensated employees. The Company did not elect to make any qualified nonelective contributions for the year ended December 31, 2024.
- (e) *Prevailing wage contributions.* The Company may, in its sole discretion, make additional prevailing wage contributions to the Plan in an amount necessary to meet the Company's requirements under an applicable prevailing wage statute. The prevailing wage allocations will offset any other discretionary company contribution allocations that would otherwise be made to a participant. No prevailing wage contributions were made for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's own contributions, employer contributions, rollover contributions, and a share of the Plan's investment income and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment in the Plan, a participant may direct employee deferrals, employer contributions, and direct rollovers in any of several different mutual funds or a common collective trust.

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the present value of the participant's non-forfeitable account balance as of the date of the loan. Loan terms range from one to ten years. The loans are collateralized by the balance in the participant's account and bear interest at reasonable rates fixed by the Plan Administrator. Principal and interest is paid ratably through payroll deductions.

Vesting

Participants are immediately vested in their elective contributions and employer contributions, under the Safe Harbor Plan, and earnings thereon.

Forfeited Accounts

The non-vested portion of terminated participant accounts, plus earnings thereon, are forfeited and are used to pay plan fees and are periodically reallocated as matching or profit sharing contributions of the employer. At December 31, 2024 and 2023, there were \$23,108 and \$21,981 of forfeitures available, respectively, to reduce future employer matching contributions or pay future plan fees.

Payment of Benefits

After attaining the normal retirement age (65), a participant is entitled to benefits that equal the value of his or her vested interest in the account. Benefits are also paid upon death, disability, or termination. Participants receive their benefits in a lump-sum distribution, equal installment payments, or through an annuity purchase. Benefit distributions are recorded when paid. For 2024, all persons who elected to withdrawal from the Plan had withdrawn their balance prior to December 31, 2024.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The Plan prepares its financial statements using the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in interest and dividends. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances. No allowance for credit losses has been recorded at December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan a distribution, the note balance is reduced and a withdrawal is recorded.

Administrative Fees

Administrative fees are paid for by both the Plan and the Plan Sponsor. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan.

**NOTE C - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at fair value and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the Trustee of the Plan.

**NOTE D - FAIR VALUE MEASUREMENTS**

FASB ASC 820-10, Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

*Level 1* - Inputs to the valuation methodologies are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodologies include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodologies are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level with the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds* - Valued at the closing price of the shares held by the Plan at year-end reported on the active market on which the individual securities are traded.

*Common Collective Trust Funds* - Valued based on the NAV of units of the common collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

**NOTE E - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Fees paid by the Plan to the trustee, Fidelity Management Trust Company, qualify as party-in-interest transactions. Certain Plan investments are shares of a mutual fund managed by Fidelity Management Trust Company; therefore these transactions qualify as party-in-interest transactions.

**NOTE F - INCOME TAX STATUS**

The prototype plan sponsor has obtained an opinion letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the restated prototype plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan Administrator timely adopted the restated prototype plan. The Plan has been amended and restated since receiving the determination letter; however, the Plan Administrator believes that the Plan is currently designed and being operated in accordance with the IRC. Therefore, no income taxes have been provided for in the financial statements.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by tax jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE G - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**NOTE H - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE I - SUBSEQUENT EVENTS**
