As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report:

Basis for Opinion

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of the Plan

The following description of the Reliance Worldwide Corporation Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for more description of the Plan's provision.

General

The Plan, which became effective September 1, 2002 and was restated effective January 1, 2017, is a defined contribution plan covering substantially all full-time, part-time, temporary, and seasonal employees, regardless of hours worked, of Reliance Worldwide Corporation (the Plan Sponsor or the Company) who are age 18 or older. Employees are eligible to participate on the first day of each calendar month of the Plan year, coincident with or the next month following their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute to the Plan an amount that does not exceed the maximum dollar amount subject to Internal Revenue Code (the Code) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. The Company will withhold an automatic deferral amount of 4% from the participant's compensation each payroll period and deposit in their 401(k) account, unless the participant has a contrary election on file. The automatic deferral percentage is 4% and will increase by 1% a year, up to a maximum of 8% of compensation.

The Plan provides for a safe harbor matching contribution (Safe Harbor Matching Contribution) in which the Company, in order to satisfy the "safe harbor" requirements of the Code, contributes a matching contribution on behalf of the participant based upon each participant's deferred contributions. The Safe Harbor Matching Contributions for 2024 was equal to 100% of the participant's deferred contributions up to 3% of the participant's eligible compensation, plus 50% of the deferred contributions between 3% and 5% of the participant's compensation. The Safe Harbor Matching Contributions are contributed each pay period. For the year ended December 31, 2024, Safe Harbor Matching Contributions totaled \$2,375,755, which are included in the statement of changes in net assets available for benefits. The Company may make additional contributions to the Plan; however, there were no such contributions made during the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and allocation of earnings on investments held in the participant's account. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and employer match contributions, plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow up to \$50,000 but limited to no more than a maximum equal to 50% of their vested account balance with a minimum loan amount of \$1,000. The \$50,000 limit is imposed on a combined total of all loans from the Plan. The loans are secured by the balance in the participant's account and bear interest at prevailing interest rates. The current interest rates range from 5% to 9.5%. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

A participant may receive a benefit payment upon termination, disability, or retirement. Participants may also receive qualified hardship distributions from the Plan. Upon attainment of 59½ years of age or upon hardship, participants may receive an in-service withdrawal from their salary deferral or matching contributions account balances. In accordance with the participant's election, benefit payments can be made in a single lump-sum payment in cash or through installments over a period of not more than the participant's assumed life expectancy. Involuntary cash-outs in a lump-sum payment can be made at the Company's discretion for participant balances under \$1,000, and involuntary rollovers to an individual retirement account can be made at the Company's discretion for participant balances between \$1,000 and \$5,000.

Administrative Expenses

The Company pays the administrative costs associated with any professional services provided to the Plan and the cost of communications to the participants. Administrative expenses recorded by the Plan represent recordkeeping fees paid directly from the Plan to the Plan's trustee. Loan fees and other administrative fees related to benefit payments are deducted directly from the participants' accounts. Investment-related expenses are included in net appreciation in fair value of investments.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investments Valuation and Income Recognition

The investments of the Plan (with the exception of fixed annuity contracts) are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). The Plan's management determines the Plan's valuation policies utilizing information provided by Empower Trust Company, LLC (Empower).

The Plan's fixed annuity contract with Empower Annuity Insurance Company (Note 5) is valued at contract value. Contract value equals the accumulated cash contributions and interested credited to the Plan's contracts, less withdrawals.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. The notes receivable from participants are classified as in default where no repayments have been made by the last day of the calendar quarter after the calendar quarter in which the payment is due. During 2024, \$26,579 of notes receivable from participants was recorded as deemed distributions. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurement*, are as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for the Plan's investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - Mutual funds are valued using the net asset value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus the liabilities and then divided by the number of shares outstanding. The NAV is a quoted price in an active market and is classified within the level 1 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of difference methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

5. Investment Contract

The Plan's investments include a benefit-responsive investment contract with Empower. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The contract is included in the financial statements at contract value, as reported to the Plan by Empower, the trustee of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan (including merger), (2) termination, and (3) other such matters as defined in the agreement. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its

financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

6. Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are managed by Empower Annuity Insurance Company. Empower is the trustee and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. The total fees paid to Empower for the year ended December 31, 2024 are \$101,923. Notes receivable from participants are considered party-in-interest transactions.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in their employer contributions.

8. Tax Status

The Internal Revenue Service has determined and informed Empower in an opinion letter dated June 30, 2020 that the volume-submitter profit-sharing plan prototype and related trust are designed in accordance with applicable sections of the Code. The Plan has since been amended; however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Concentration of Market Risk

Approximately 85% and 84% of the Plan's assets were invested in Vanguard Investments as of December 31, 2024 and 2023, respectively.

10. Subsequent Events

The Plan has evaluated subsequent events from the date of the statements of net assets available for benefits through August 15, 2025, the date the financial statements were available to be issued. During this period, no material recognizable subsequent events were identified.
