### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of CFC Retirement Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of CFC Retirement Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. ### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about CFC Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

(1) Description of Plan

The following description of the CFC Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

- (a) General – The Plan is a defined contribution plan for employees of Carris Financial Corp. (“CFC”), a Vermont corporation; Carris Reels, Inc. (“Carris”), a Vermont corporation; Carris Reels of Connecticut, Inc. (“Connecticut”), a Connecticut corporation; Carris Reels of California, Inc. (“California”), a California corporation; and Carris Reels of Texas, Inc., a Texas corporation, (collectively, the “Companies”).

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Board of Directors oversees governance of the Plan. The Plan's Trustee and Oversight Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Board of Directors.

- (b) Contributions – Employees of the Companies are eligible to participate in the Plan after 6 months of service and attaining the age of 18. Excluded employees include those who are collectively bargained, resident aliens, Puerto Rico residents, leased, or short-service employees. Eligible employees may join the Plan as an active participant on each January 1, April 1, July 1, or October 1 after the employee meets the eligibility requirements. Contributions consist of employee salary deferrals and discretionary employer contributions. Eligible employees are allowed to contribute through payroll deductions up to the Internal Revenue Service (“IRS”) established limit. Employees 50 years old and over are allowed to make catch-up contributions not to exceed IRS established limits. Participants may roll over part or all of an eligible rollover distribution from another qualified plan to the Plan. This includes rollovers resulting from employee stock ownership plan (“ESOP”) diversification elections from the CFC ESOP.

Employer contributions are allocated to the accounts of Plan participants on a “pro rata” allocation method, using a uniform percentage of eligible compensation. Discretionary contributions for 2024 and 2023 were \$1,138,352 and \$1,153,347, respectively.

- (c) Participant Accounts – Each participant's account is credited with the participant's contributions and allocations of (a) the Companies’ contributions, (b) Plan earnings, and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Each participant directs the investment of the contributions into various investment options offered by the Plan.
- (d) Vesting – Participants are 100% vested in their deferral and earnings thereon. Participants are 100% vested in employer contributions and earnings thereon after six years of participation in the Plan, earning 20% per year after two years.

- (e) Payment of Benefits – Benefits under the Plan are distributed upon death, retirement, financial hardship, or termination, based upon the value of the participant's vested account. Normal retirement occurs at age 65. Effective January 1, 2025, early retirement age for the Plan is 60. Distributions are in the form of lump sum or installments. If the terminating employee's vested balance is less than \$1,000, it is mandatory that the Plan distribute the entire account balance as soon as administratively practical. If the employee's vested account balance is greater than \$1,000 but less than \$7,000, it will automatically be rolled into an IRA.

In-service distributions are permitted by those participants who reach age 59-½. A participant may withdraw rollover contributions at any time. Hardship withdrawals are also permitted by the Plan.

- (f) Plan Termination – Although the Companies have not expressed any intent to do so, they have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. Additionally, the Companies may amend the Plan at any time without the consent of any participant or any beneficiary, provided that no amendment deprives any participant of the participant's non-forfeitable accrued benefit.
- (g) Notes Receivable – Participants may borrow a minimum of \$1,000 up to a maximum, not to exceed 50% of their vested account balance or \$50,000, whichever is less. Loan transactions are treated as transfers between the investment fund and the loan account, representing issuance and repayments. Loan terms vary in range up to five years. The loans are secured by the balance in the account and bear interest at the prime rate as published in the Wall Street Journal on the first day of such month. Principal and interest are repaid ratably through weekly payroll deductions.
- (h) Forfeitures – Forfeitures represent amounts which could not be paid to terminated participants due to failure to meet vesting requirements. Forfeitures are used for Plan expenses, to reduce employer contributions, or are allocated to participants using a pro rata allocation method based on a uniform percentage of eligible compensation. Forfeitures used and allocated for plan years 2024 and 2023 were \$92,422 and \$110,069, respectively. Unused forfeitures at December 31, 2024 and 2023 were \$99,339 and \$116,649, respectively.

(2) Summary of Significant Accounting Policies

- (a) Basis of Accounting – The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.
- (b) Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

- (c) Investment Advisory and Recordkeeping Expenses – Certain expenses of maintaining the Plan are paid by the Companies and are therefore excluded from these financial statements. The Plan pays for investment advisory and recordkeeping fees, which are deducted from net asset value. Fees for the administration of notes receivable from participants and distributions are included in investment advisory and recordkeeping expenses and are charged directly to the participant's account.
- (d) Investment Valuation and Income Recognition – The Plan's investments are stated at fair value except for fully benefit-responsive investment contracts which are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

- (e) Notes Receivable – Notes receivable from participants are reported at their unpaid principal balances plus any accrued, but unpaid, interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.
- (f) Payment of Benefits – Benefit payments are recorded when paid.
- (g) Subsequent Events – The Plan evaluated subsequent events through August 8, 2025, the date the Plan's financial statements were available to be issued.

(3) Information Certified by the Plan's Custodians

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC and Massachusetts Mutual Life Insurance Company have certified to the completeness and accuracy of all amounts and types of investments reflected on the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023, the schedule of assets held for investment purposes as of December 31, 2024, and the related investment activities reflected in the statements of changes in net assets available for plan benefits for the years ended December 31, 2024 and 2023.

(4) Investment Contract

The Plan has entered into a fully benefit-responsive investment contract. Because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits attributable to the guaranteed investment contract. Contract value represents contributions plus credited interest, less participant withdrawals and fees. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) violation of a material obligation under the contract, (d) a material misrepresentation. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants are probable of occurring.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

The investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

(5) Income Tax Status

The Plan is based on a prototype plan that has received an opinion letter dated November 14, 2022, which is acceptable under Section 401 of the Internal Revenue Code. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to December 31, 2021.

(6) Risks and Uncertainties

The Plan invests in various investment securities. The investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

(7) Withdrawing Participants

There were no benefits requested but not paid as of December 31, 2024.

(8) Related Party Transactions

The Plan has a number of service providers. Such parties are considered parties-in-interest under ERISA.

(9) Fair Value Measurements

Generally accepted accounting principles in the United States of America establish a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Fair Value Measurements (continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the closing price reported on the active market on which the individual securities are traded. These are considered Level 1 assets and as of December 31, 2024 and 2023 were \$23,279,930 and \$22,505,030, respectively.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
