Notes to Financial Statements

NOTE 1: DESCRIPTION OF PLAN

The following description of Piramal Pharma Solutions, Inc. 401(k) Profit Sharing Plan and Trust ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a profit-sharing plan covering substantially all employees of Piramal Pharma Solutions, Inc. (the Company/ Plan Sponsor/ Plan administrator), other than employees covered by a collective bargaining agreement, nonresident aliens with no income from the United States of America, any residents of Puerto Rico and leased employees, who have attained the age of 21 and have completed three months of service measured from the date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

The Plan includes a provision under Internal Revenue Code ("IRC") Section 401(k) whereby participants may elect to defer pre-tax contributions or Roth 401(k) deferrals to the Plan by a specific percentage or a dollar amount from their annual compensation. Annual participant contribution amounts are limited to \$23,000 and \$22,500 salary deferrals for the years ended December 31, 2024 (\$30,500 for participants aged 50 years and over), and December 31, 2023 (\$30,000 for participants aged 50 years and over), respectively. Participants may also contribute amounts representing distributions from certain other retirement plans as described in the Plan document. The Plan includes an auto-enrolment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5 percent of eligible compensation, and their contributions are invested in a designated balanced fund until changed by the participant.

The Company will make a safe harbor matching contribution to the plan equal to 100% of salary deferrals that do not exceed 5% of eligible compensation received during the year.

The Company may also make a matching contribution. In order to share in the allocation of matching contributions, participants are required to complete 1,000 hours of service in the applicable Plan year and/or be employed by the Company on the last day of the Plan year. The matching Company contribution is invested in the same manner as the employee contributions.

Additional profit-sharing amounts may be contributed at the option of the Company's board of directors and are allocated to employee accounts based on the annual compensation of participants and are invested in the same manner as employee contributions. Contributions are subject to certain limitations.

At the Plan administrator's discretion, a participant may deposit rollover contributions from another qualified plan. Rollover contributions are placed in the participant's account and are subject to the rules for investment established by the Plan administrator.

Administration

Piramal Pharma Solutions, Inc., serves as the Plan administrator. The Plan administrator has the responsibility to administer the Plan for the exclusive benefit of the participants and their beneficiaries. These duties include, but are not limited to, establishing procedures, maintaining records, interpreting provisions of the Plan, and making determinations regarding questions that may affect eligibility for benefits. The Company has engaged Creative Retirement Services, Inc., a third-party plan administrator, to assist in the administration of the Plan. Employees of the Plan sponsor serve as the Plan trustees. All amounts contributed to the Plan are held by the Plan trustees in a qualified trust. The trustee is responsible for the safekeeping of the trust funds and must fulfill all trustee duties in a prudent manner and in the best interest of the beneficiaries. The trust established on behalf of the Plan will be the funding medium used for the accumulation of assets from which Plan benefits will be distributed.

Standard Insurance Company (Standard) served as the custodian of the Plan, pursuant to the Plan agreement for the year ended December 31, 2024, and December 31, 2023. The custodian received all contributions made under the Plan, held plan assets, and paid benefits to participants as directed by the Plan Sponsor.

Investment management fees and other fund-level operating expenses of the pooled separate accounts and mutual funds are borne by those funds and are reflected in their unit values. Accordingly, these amounts reduce the Plan's investment returns and are included in net appreciation (depreciation) of investments and/or investment income, not in administrative expenses. For the fixed income guaranteed option, an investment management/crediting spread is retained by the issuer and is reflected in the contract's crediting rate; such amounts are similarly not presented as administrative expenses of the Plan.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Also, participant vesting with respect to contributions made by the Plan Sponsor to their 401(k) account balance is 100% vested.

Investment options

Participants are required to make participant-directed allocations of their accounts among various investment options offered by the Plan.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The term generally cannot exceed five years. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through monthly payroll deductions. Participants may have only one loan outstanding at any one time.

Benefit payments

In-service withdrawals of all or a portion of a participant's vested account balance may be made by a participant upon incurring a hardship or after reaching age fifty-nine and a half. Upon normal retirement at age sixty-five, disability, or death, the participant or beneficiary may receive the value of the account through a lump sum distribution or under a systematic withdrawal plan over a period not to exceed the joint life expectancy of the participant or the participant's beneficiary.

Participants withdrawing from the Plan due to termination of employment, other than due to retirement, disability, or death, may receive the value of their vested account by transfer to another qualified plan or individual retirement account or through a lump sum distribution.

Distributions from the Plan will normally be subject to income taxes and, in certain circumstances, may also be subject to Internal Revenue Service ("IRS") penalties unless the distribution is transferred to another qualified plan or individual retirement account.

Forfeitures

Forfeitures may be used to pay Plan administrative expenses, to restore forfeitures, or to reduce future employer contributions. As of December 31, 2024, and December 31, 2023, non-vested forfeited accounts totaled \$3 and \$3, respectively. Forfeitures of terminated employees' non-vested accounts totaled \$Nil during the year 2024 and \$ Nil during the year 2023. No forfeitures were applied during the years ended December 31, 2024, and December 31, 2023.

NOTE 2: SUMMARY OF ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting. Investments held by the Plan are reported at fair value, except for fully benefit-responsive investment contracts.

Use of estimates in financial statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Risks and uncertainties

The Plan provided for various investment options in pooled separate funds and fixed investment funds. The Plan's exposure to credit losses in the event of nonperformance of investments is limited to the carrying value of such investments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits, participant account balances and the statement of changes in net assets available for benefits.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024, and

2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant's loan to be in default, the loan balance is reduced, and the delinquent participant's note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment valuation and income recognition

Investments in pooled separate funds are valued at quoted market prices as provided by the custodian. Net appreciation in the value of investments represents the change in fair value or contract value during the year, including realized and unrealized gains and losses. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 5 for a discussion of fair value measurements.

Investments in fixed-income guaranteed options are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to stable value fund investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 3: INFORMATION CERTIFIED BY STANDARD INSURANCE COMPANY (“CUSTODIAN”) (UNAUDITED)

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by Standard Insurance Company, the custodian, except for comparing such information certified by the custodian to information included in the Plan’s financial statements and supplemental information.

NOTE 5: FAIR VALUE MEASUREMENTS

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standard are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024, and December 31, 2023.

Pooled separate accounts: Pooled separate accounts invest in a variety of individual stocks, mutual funds, and short-term securities such as commercial paper. The fair values of the pooled separate accounts are based on the fair value of the underlying investment, which is based on publicly quoted pricing inputs or observable pricing inputs, including quoted prices for similar assets in active or non-active markets.

Fixed income guaranteed option: The guaranteed investment contract consists of the Standard Stable Asset Fund and is reported at contract value. Contract value represents the aggregation of contributions, plus interest, less withdrawals, if any.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables present, by level, within the fair value hierarchy, the Plan investment assets at fair value, as of December 31, 2024, and December 31, 2023. Accounting Standard Codification (ASC) Topic 820 requires that investment assets be classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

NOTE 6: FIXED INCOME GUARANTEED OPTION(BENEFIT-RESPONSIVE)

The Plan invests in the Standard Stable Asset Fund, a benefit-responsive investment contract reported at contract value (contributions plus credited interest less withdrawals). Average crediting rates and average yields earned were 1.92% (2024) and 1.62% (2023). Participant-initiated transactions are permitted at contract value; certain employer-initiated events (e.g., plan termination, significant amendments, mergers/spin-offs, or significant workforce reductions) may limit contract-value withdrawals or require up to 12 months' notice; such events are not considered probable as of December 31, 2024 and December 31, 2023. This investment is not measured at fair value and is excluded from the ASC 820 fair value hierarchy.

NOTE 8: INCOME TAX STATUS

For the years ended December 31, 2024, and December 31, 2023, the Plan Sponsor entered into a non-standardized arrangement of the CCH Incorporated DBA FTWilliam.Com ("CCH"), *Non-Standardized Pre-Approved Profit-Sharing Plan with CODA*. CCH has received an opinion letter from the IRS dated June 30, 2020, which stated that the form of the non-standardized pre-approved and related trust was designed in accordance with applicable sections of the IRC. It is the opinion of the Plan trustee and the Plan's attorney that the Plan complies with all applicable laws and regulations. The Plan has been amended since the latest opinion letter.

U.S. generally accepted accounting principles require plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, and December 31, 2023, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9: PARTY-IN-INTEREST TRANSACTIONS

Standard Insurance Company served as the custodian of the Plan. Certain Plan investments are managed by a custodian, and therefore, these transactions qualify as party-in-interest transactions. Creative Retirement Services, Inc. provides services to the Plan as a third-party administrator for which administration fees are charged to the Plan.

NOTE 10: PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 11: DELINQUENT PARTICIPANT CONTRIBUTIONS

During the year ended December 31, 2023, due to unintentional delays, the Company deposited payroll withholdings amounting to \$19 after the time frame deemed to be within DOL regulations for timely remittances. The Company made contributions to the affected participant accounts to compensate those participants by remitting lost earnings during the year 2023, using the DOL guidelines for late deposits.

NOTE 12: SUBSEQUENT EVENTS

The Plan evaluated all events and transactions that occurred after December 31, 2024, through the date the financial statements were available to be issued. Based on the evaluation, the Plan is unaware of any events or transactions requiring recognition or disclosure in the financial statements.
