To the Plan Administrator
Roscoe Brown, Inc. 401(K) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Roscoe Brown, Inc. 401(K) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinions

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinions.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Managements' election of the ERISA Section 103(a)(3)(C) audit does not affect managements' responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE A - DESCRIPTION OF PLAN

The following description of Roscoe Brown, Inc. 401(K) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan providing retirement benefits for employees of Roscoe Brown, Inc. and Roscoe Brown Heating & Air Conditioning of Tullahoma, Inc. (collectively the "Plan Sponsor"). The Plan covers all employees who are age eighteen or older and have completed one year of service ("participants"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Participants may voluntarily make qualified retirement contributions to the Plan which are deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code ("IRC"). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants may make a minimum contribution of 1% to a maximum of 100% of their total annual compensation, as defined in the plan agreement, subject to certain IRC limits. Participants may designate all or a portion of their contributions as Roth deferral contributions at the time their deferral election is made.

The Plan Sponsor may make a discretionary matching contribution at a percentage of each participants' compensation as authorized by the Plan Sponsor's Board of Directors; however, matching contributions by the Plan Sponsor are not required. During 2024 and 2023, discretionary matching contributions were made equal to 50% of the first 6% of each participants' compensation.

The Plan provides that the Plan Sponsor may contribute each year a discretionary profit-sharing contribution in an amount authorized by the Plan Sponsor's Board of Directors; however, an annual discretionary profit-sharing contribution is not required. To be eligible for the discretionary profit-sharing contribution, a participant must be employed on the last day of the plan year and must have completed a full year of service during the plan year, unless the participant became permanently disabled, retires, or dies during the plan year. No annual discretionary profit-sharing contribution was made by the Plan Sponsor during 2024 or 2023.

Plan Sponsor and participant contributions may not exceed the maximum amount allowable for federal income tax purposes.

Participant Accounts

Each participant's account is credited or charged with the participant's contributions, allocations Plan Sponsor contributions, investment earnings or losses, and administrative expenses. Allocations are based on participant compensation or account balances, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their elective salary deferral contributions plus actual earnings or losses thereon. Vesting in the Plan Sponsor's contributions plus earnings or losses thereon is based on years of service. Participants vest ratably at 20% after the two years of service and each year thereafter until fully vested after 6 years of service in the Plan Sponsor's discretionary profit-sharing contributions. Participants vest ratably in the Plan Sponsor's discretionary matching contributions plus earnings or losses thereon at 25% after the first year of service and each year thereafter until fully vested after 4 years of service.

Payment of Benefits

On termination of service due to death, permanent disability, or retirement, a participant with an account balance that exceeds \$5,000 may elect to receive a lump-sum payment in cash equal to his or her entire account. For termination of service due to other reasons, a participant with an account balance that exceeds \$5,000 will be entitled to receive only the vested interest in his or her account as a lump-sum payment in cash. If the vested value of a participant's account is less than \$5,000, the total vested balance is distributed as an automatic lump-sum payment in cash.

Hardship Withdrawals

The Plan permits distributions in the event of a financial hardship, as defined in the plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59 1/2. Hardship withdrawals are limited to the participant's elective account balance.

Administrative expenses

Certain expenses for maintaining the Plan are paid by the Plan or the Plan Sponsor. Fees incurred for investment management services are netted within the net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than as a direct payment.

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Refer to Note D for additional information about fair value.

Purchases and sales of securities are recorded on a trade-date basis.

Excess Contributions Payable

Excess contributions payable to participants totaled \$10,397 on December 31, 2024. The Plan distributed the excess contribution payable prior to March 15, 2025.

Payment of Benefits

Benefits are recorded when paid.

Forfeited Accounts

Forfeitures are created when participants terminate employment prior to becoming fully vested in the Plan Sponsor contribution portion of their accounts. Such forfeitures reduce fees paid by the Plan or Plan Sponsor contributions. At December 31, 2023, forfeited nonvested accounts totaled \$11,728. During 2023, \$2,708 forfeitures were used to pay plan expenses. At December 31, 2024, forfeited nonvested accounts totaled \$6,771. During 2024, \$18,591 forfeitures were used to pay plan expenses.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America which requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE D – FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

- (i) *Cash and Mutual funds:* Valued at the net asset value of shares held by the Plan at year end based on a quoted price in an active market.
- (ii) *Pooled separate accounts:* Valued at net asset value, which is based on the market value of the underlying investments held by the pooled separate accounts at year end. The net asset value is not a publicly quoted price in an active market. The accounts provide for daily redemptions by the Plan at reported net asset values per share with no advance notice required or restrictions on redemptions.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E – INCOME TAX STATUS

The Plan Sponsor adopted a prototype 401(k) profit sharing plan, which received a favorable opinion letter from the Internal Revenue Service (“IRS”) on November 30, 2020, which stated that the prototype plan was designed in accordance with applicable sections of the IRC. The Plan itself has not received a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. The Plan has been amended since the opinion letter was obtained. However, the plan administrator believes that the adopted prototype plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and is therefore, qualified and exempt from taxation.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F – PARTY IN INTEREST TRANSACTIONS

During 2024 and 2023, respectively, administrative fees of \$6,142 and \$23,796 were paid by the Plan to TransAmerica Life Insurance Company, the custodian of the Plan who sponsored pooled separate accounts in which the Plan invested as of December 31, 2023 and for the period from January 1, 2024 through February 26, 2024. Plan investments are managed by Empower Retirement Company, LLC, the custodian of the Plan as of December 31, 2024 and for the period from February 26, 2024 through December 31, 2024. As of December 31, 2024, administrative fees of \$20,041 were paid by the Plan to Empower Retirement Company, LLC. Therefore, these transactions qualify as party-in-interest transactions.
