### **Note 1. Description of Plan**

The Angola Wire Products, Inc. 401(k) Profit Sharing Plan (the "Plan") is a defined contribution plan covering employees of Angola Wire Products, Inc. (the "Company") and its subsidiaries. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The provisions of the Plan are included in the official Plan document which legally governs the operations of the Plan and is available for more detailed information.

#### Contributions

Participants may make voluntary pre-tax or Roth contributions of eligible compensation in percentages or specified dollar amounts, up to the dollar limits set by the Internal Revenue Code. Employee rollover contributions and in-plan Roth rollover contributions are also permitted. Employees must be 18 years or older to participate, and are eligible for the Plan after sixty days of service. An eligible employee may enter the Plan at the beginning of the calendar quarters.

The Company provides a safe harbor matching contribution, which was equal to 100% of the first 4% of each participant's contribution in 2024. The Company also reserves the right to make discretionary profit sharing contributions. To participate in the discretionary profit sharing contribution, a participant must have completed 1,000 hours of service and must be employed on the last day of the Plan year. The Company made no profit sharing contribution in 2024.

#### Participant Accounts

Each participant's account is credited with the participant's voluntary contribution, Company contributions, Plan earnings and is charged with an allocation of administrative expenses. Allocations of the earnings are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

#### Investment Options

Participants have the option of investing in various investment choices offered through Matrix Trust Company, the Custodian of the Plan. All amounts in participant accounts are participant-directed.

#### Notes Receivable from Participants

Participants may borrow not less than \$1,000 from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may have only one loan currently outstanding from the Plan. The term cannot exceed 5 years unless for the purchase of a principle residence. The loans are secured by the balance in the participant's account and bear interest at a fixed rate commensurate with prevailing rates as determined by the Plan Administrator at time of origination. The interest rates for loans outstanding as of December 31, 2024, range from 4.25% to 9.50%. Principal and interest are paid ratably through regular payroll deductions. Loans outstanding at December 31, 2024, mature through December 2029.

### **Note 1. Description of Plan (Continued)**

#### Vesting

Participants are immediately vested in their voluntary contributions and safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's matching contributions before January 1, 2022, and profit sharing contributions plus the earnings thereon is based on years of service. A participant is 100% vested after three years of credited service.

#### Forfeitures

Participants who terminate from the Plan prior to becoming fully vested must forfeit a percentage of the Company's matching contributions prior to January 1, 2022, and profit sharing contributions. These forfeitures are used to reduce future Company contributions or pay Plan expenses. During the year ended December 31, 2024, approximately \$2,900 forfeitures were used to reduce Company contributions or pay Plan expenses. Approximately \$0 and \$2,900 of forfeitures were available at December 31, 2024 and 2023, respectively.

#### Benefit Payments

Upon termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or installment payments. Mandatory cash-outs occur without the consent of the participant if their balance is less than or equal to \$5,000 upon termination. Hardship and in-service distributions are also allowed from the fully vested portion of a participant's account balance with certain restrictions, as outlined in the Plan document.

#### Termination of the Plan

Although the Company has not expressed any intent to terminate the Plan, it may do so at any time, subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

### **Note 2. Significant Accounting Policies**

#### Basis of Financial Statements

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Collective investment funds held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive collective investment funds, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. However, these funds qualify for measuring fair value using the net asset value (NAV) practical expedient. This NAV represents the Plan's fair value since this is the NAV at which the Plan transacts with the fund.

### **Note 2. Significant Accounting Policies (Continued)**

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales transactions are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### Payment of Benefits

Benefit payments to participants are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation or depreciation of fair value of investments.

#### Subsequent Events

Management of the Plan has evaluated events and transactions for possible recognition or disclosure through August 19, 2025, the date the financial statements were available to be issued.

### **Note 3. Information Certified by the Plan's Custodian**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by the Custodian, Matrix Trust Company, and was not subjected to any auditing procedures performed by the independent public accountants.

- a. Total investments shown in the accompanying statements of net assets available for benefits.
- b. Net investment income, as shown in the accompanying statement of changes in net assets available for benefits, including interest and dividends, other income and net realized and unrealized appreciation in fair value of investments.
- c. Schedule of assets (Held at End of Year), except for participant loans.

### **Note 4. Fair Value Measurements**

Fair value measurements are based upon the exit price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, and are determined by either the principal market or the most advantageous market.

Inputs used in the valuation techniques to derive fair values are classified based on a three-level hierarchy to prioritize the inputs used in the valuation techniques to derive fair values. The basis for fair value measurements for each level within the hierarchy is described below with Level 1 measurements having the highest priority and Level 3 measurements having the lowest priority.

- Level 1: Fair value is based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.
- Level 2: Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3: Fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable.

The asset's or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

### Note 4. Fair Value Measurements (Continued)

Following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Cash - interest bearing:* Valued at \$1 per dollar held by the Plan at year end.

*Money market account:* The money market account is valued at cost plus accrued interest, which approximates fair value.

*Mutual funds:* Valued at quoted market prices, which represent the net asset values (NAV) of shares held by the Plan at year end.

*Collective investment trust:* Valued at the net asset value (NAV) provided by the administrator of the fund. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 6. Party-In-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan has a cash and money market account and a collective investment trust, which are managed by the Custodian of the Plan, who qualifies as a party-in-interest. Notes receivable from participants' transactions are also party-in interest transactions.

The Company provides certain accounting, recordkeeping, and administrative services to the Plan for which it receives no compensation. Administrative expenses for legal, accounting, and other services are rendered by parties-in-interest and are paid by the Company.

### Note 7. Risks and Uncertainties

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 8. Income Tax Status**

The Plan, which is a prototype plan sponsored by Nyhart, obtained its latest opinion letter on June 30, 2020, stating the prototype plan is a qualified plan under Section 401 of the Internal Revenue Code. The Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. The Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a liability if the Plan has taken an uncertain tax position that more likely than not would not be sustainable upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### **Note 9. Subsequent Events**

In June 2025, the plan assets were transferred from Matrix Trust Company to Ascensus Trust Company, the new Custodian of the Plan.
