1. Description of the Plan

The following description of TAMKO Building Products LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions. Copies of the document are available from the plan administrator. Effective May 31, 2019, the Plan was amended to change the name of the Plan from TAMKO Building Products, Inc. 401(k) Plan to TAMKO Building Products LLC 401(k) Plan.

General

The Plan is a 401(k) defined-contribution plan covering all employees of TAMKO Building Products LLC (TAMKO), Allmine Trucking LLC, and Allmine Paving LLC (the Companies) who have completed at least one hour of service. Allmine Trucking LLC and Allmine Paving LLC are wholly owned subsidiaries of Allmine Holdings LLC, which is a wholly owned subsidiary of TAMKO, the plan sponsor.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Employees may make annual elective deferral contributions to the Plan in the amount of the lesser of (1) up to 100% (reduced by applicable employment tax withholding obligations) of their compensation, as defined in the plan document, or (2) the maximum amount allowable under the Internal Revenue Code (the Code). The Plan has an automatic enrollment feature for any new employee who does not make a contrary election. The automatic enrollment deferral percentage is 4% of compensation for participants hired on or after January 1, 2017 and before January 1, 2018, 5% of compensation for participants hired on or after January 1, 2018 and before November 1, 2023, and 6% of compensation for participants hired on or after November 1, 2023. Contributions from plan participants and the matching contributions from the Companies are recorded in the year in which the employee contributions are withheld from compensation.

Subject to contrary elections by participants, generally the Companies will automatically begin withholding the automatic enrollment deferral percentage in effect at the time of hire and invest those monies into a qualified default investment alternative (QDIA). Effective March 1, 2016, the Plan includes an automatic increase feature. Under this automatic increase feature, a participant's deferral amount will increase by 1% beginning March 1, 2016, and each March 1 thereafter up to

a maximum automatic deferral amount of 10% through the March 1, 2023, automatic increase. Effective November 1, 2023, the maximum automatic deferral amount increased to 12% of a participant's compensation, starting with the March 1, 2024, automatic increase. A participant has the option to make a timely election not to have the automatic increase feature apply. The Plan provides that participant's deferral percentage will be automatically increased by 1% each year, unless either (i) the participant opts out of such automatic increases or (ii) the participant's deferral percentage is already, otherwise, at or above, or has already previously been increased under the automatic increase feature to 10% or 12% of his or her compensation as indicated above.

The Companies will match contributions for those employees who have completed a minimum of one hour of service and were employed on the last day of the plan year, based on the following:

First Tier: Dollar for dollar on the first \$100 of each participant's salary reduction contribution.

Second Tier: Ten cents for each dollar of salary reduction contributions in excess of \$100 but not exceeding \$4,100 of salary reduction contributions by the participant, inclusive of the first \$100.

The maximum amount of matching contributions permitted under the Plan is \$500 for an individual employee.

Participants direct the investment of their contributions, the Companies' matching contribution, and earnings into various mutual funds and common collective trust funds offered by the Plan, except where the QDIA is utilized.

Participants' Accounts

Each participant's account is credited with the participant's contribution and the Companies' matching contribution and allocations of plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The participant's investments appreciate or depreciate to the benefit or detriment of the participant.

1. Description of the Plan (continued)

Vesting

Participants are immediately vested in their own contributions, employer matching contributions, and their share of the Plan's earnings or losses.

Payment of Benefits

Upon termination of service, a participant with an account balance that does not exceed \$1,000 will receive a lump-sum distribution. A participant with an account balance exceeding \$1,000, but less than \$5,000, will receive a lump-sum distribution directly rolled over to an individual retirement account designated by the Companies, unless the participant elects direct distribution or other eligible direct rollover.

A participant with a balance that exceeds \$5,000 may elect to receive a lump-sum amount equal to the value of the account, part lump-sum amount and part installments, or installments over a specified period of time not to exceed the lesser of ten years or the life expectancy of the participant.

Plan Termination

Although they have not expressed an intention to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of the Plan's termination, participants remain 100% vested in their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for a further discussion and disclosure related to fair value measurements.

2. Summary of Significant Accounting Policies (continued)

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in net assets and liabilities in the financial statements, the accompanying notes, and the supplemental schedule. Actual results could differ from those estimates.

Plan Tax Status

The Plan has received a determination letter from the Internal Revenue Service (IRS), dated February 3, 2014, stating that the Plan is qualified under Section 401(a) of the Code and, therefore, the related trust is exempt from taxation. Subsequent to this determination by the IRS, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan, as amended, is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Payment of Benefits

Benefit payments to participants are recognized upon distribution.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability, with a corresponding reduction to contributions. No excess contributions were made during the plan years ended December 31, 2024 or 2023.

Administrative Expenses

Historically, although not contractually obligated to do so, the plan sponsor has paid costs of administering the Plan, except for investment-related costs, which are netted against investment earnings, and qualified domestic relations order fees, which are paid by the Plan. Total administrative expenses paid by the plan sponsor for the plan years ended December 31, 2024 and 2023, were \$52,546 and \$51,267, respectively. Expenses that are paid by the plan sponsor are excluded from these financial statements.

Notes Receivable From Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance, plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are recorded when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

3. Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation (depreciation) in the fair value of investments, interest, dividends, and interest income on notes receivable from participants for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the Plan's trustees, Principal Trust Company, for the period January 1, 2023 through October 31, 2023, and by Fidelity Management Trust Company as of December 31, 2023, and for the period November 1, 2023 through December 31, 2023, and as of December 31, 2024, and for the year then ended.

4. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). The fair value hierarchy prioritizes the inputs to the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The fair value measurement level for an asset or a liability is based on the lowest level of any input that is significant to the measurement. The three levels of the fair value input hierarchy are as follows:

- Level 1 – Valuations are based on unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets or liabilities.
- Level 2 – Valuations are based on inputs other than quoted prices in active markets for identical assets and liabilities that are observable, either directly or indirectly, for substantially the full term of the asset or liability. Level 2 inputs include the following:
 - Quoted prices for similar assets and liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in markets that are not active
 - Observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means
- Level 3 – Valuations are based on unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumptions about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest-level input that is significant to the fair value measurement in its entirety.

4. Fair Value Measurements (continued)

The following is a description of the valuation techniques and inputs used for each general type of investment measured at fair value by the Plan:

Common collective trust funds: Valuations are based on the net asset value (NAV) provided by the administrator of the fund.

Mutual funds: Valuations are based on quoted market prices, which represent the NAV of shares held by the Plan at year-end.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported on the statements of net assets available for benefits.

6. Related-Party and Party-in-Interest Transactions

The Plan holds certain investment funds managed by Fidelity, the trustee and record-keeper for the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

7. Subsequent Events

Management evaluated subsequent events for the Plan through June 16, 2025, the date the accompanying financial statements were available to be issued. During this period, there were no subsequent events that required recognition or disclosure in the financial statements.
