## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of LOGS Legal Network 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). #### Note 1. Description of the Plan

The following description of LOGS Legal Network 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering all full-time employees of Law Office of Gerald Shapiro, LLC and participating employers (the Plan Sponsor) who have met the service requirement and attained 21 years of age, except employees of certain affiliated employers covered by other plans. An eligible employee may enter the Plan on the first day of the month after the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Investment Committee is responsible for oversight of the Plan.

**Plan changes:** Effective January 1, 2024, the Plan changed its recordkeeper from ADP Retirement Services to Empower Retirement Services, LLC and changed its trustee from Reliance Trust Company to Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively, Empower).

The Plan was restated effective January 1, 2024, to adopt a non-standardized pre-approved plan provided by Empower Retirement Services, LLC.

**Contributions:** Participants may contribute the maximum amount allowed by the Internal Revenue Code (IRC). Participants who will attain 50 years of age by the end of the calendar year are allowed to make a catch-up contribution for that year. The Plan has an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan with a deferral rate of 3% unless they affirmatively elect not to participate.

The Plan Sponsor makes discretionary matching contributions as determined by the Plan Sponsor's board of directors. For the year ended December 31, 2024, the Plan Sponsor's matching contribution was 10% of the first 15% of compensation that a participant contributed to the Plan. Additional profit-sharing amounts may be contributed to the Plan at the option of the Plan Sponsor's board of directors. Such contributions, if any, are allocated to eligible participants based on compensation. No profit-sharing contributions were made in 2024.

Contributions are subject to certain IRC limitations.

**Investment options:** Upon enrollment in the Plan, a participant may direct all contributions to selected investments as made available by the Plan Administrator in 1% increments. Participants may change their investment options daily.

**Participant accounts:** Accounts are separately maintained for each participant. Each participant's account is credited with the participant's contributions and the Plan Sponsor's matching contributions as well as allocations of (a) any Plan Sponsor's profit-sharing contribution and (b) plan earnings, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which each participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their contributions and rollovers plus actual earnings thereon. Participants are vested in the Plan Sponsor's contributions plus actual earnings thereon based on years of continuous service. A participant is 100% vested after six years of credited service, with 20% annual vesting starting after completion of two years of credited service.

#### Note 1. Description of the Plan (Continued)

**Forfeitures:** Forfeitures are used to reduce future employer contributions or pay administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts amounted to \$3,557 and \$6,638, respectively. During the year ended December 31, 2024, \$15,882 was used to reduce employer contributions and none was used to pay plan expenses.

**Notes receivable from participants:** Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the current vested value of their account. Notes must be repaid, including interest at a fixed rate as determined at the time of issuance, over a period not exceeding five years, except for the purpose of acquiring a principal residence. Interest rates are commensurate with local prevailing rates as determined by the Plan Administrator. The notes are secured by the balance in the participant's account. These rates range from 4.25% to 9.50% on loans outstanding at December 31, 2024, and the notes mature through 2051. Principal and interest is repaid ratably through bi-weekly payroll deductions.

**Payments of benefits:** On termination of service for any reason, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. The Plan also permits hardship withdrawals and in-service withdrawals at age 59½.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and such changes could materially affect participant account balances and the amounts reported in the financial statements of net assets available for benefits.

**Noninterest-bearing cash:** On December 29, 2023, the Plan's investments held with the Reliance Trust Company, the former trustee, were liquidated into a noninterest-bearing cash account held by the former trustee in preparation for the transfer of the Plan's assets to the current trustee effective January 1, 2024 (see Note 1).

#### Note 2. Summary of Significant Accounting Policies (Continued)

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make the scheduled repayments and the Plan Administrator deems the participant to be in default, the participant's note receivable is reduced and a benefit payment is recorded based on the terms of the Plan.

**Contributions:** Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of benefits:** Benefits are recorded when paid.

**Expenses:** Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Certain other administrative expenses may be paid directly by the Plan Sponsor and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable that are charged directly to the participant's account and certain recordkeeping fees paid by the Plan. Investment related expenses are included in net appreciation in fair value of investments.

**Subsequent events:** The Plan Administrator has evaluated subsequent events for potential recognition and/or disclosure through August 22, 2025, the date the financial statements are available to be issued.

#### Note 3. Information Certified and Provided by Empower

The following is a summary of the Plan's asset information as of December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified as complete and accurate by Empower, a qualified institution. The Plan's assets as of December 31, 2023, were not certified by the former trustee, Reliance Trust Company, due to the pending transfer of the Plan's assets to Empower (See Notes 1 and 2).

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The Plan held no assets measured at fair value as of December 31, 2023. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

**Registered investment companies (mutual funds):** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Common/collective trusts:** Valued based on the NAV of units of the common/collective trusts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

**Pooled separate account:** Valued based on the daily closing price as reported by the underlying mutual funds and adjusted to apply the expense factor disclosed in the annuity contract

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits.

#### Note 5. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

#### Note 6. Party-in-Interest Transactions

Empower is the trustee and Empower Retirement Services, LLC is the recordkeeper of the Plan; therefore, transactions with the trustee and recordkeeper qualify as party-in-interest transactions. The Plan Sponsor also paid certain administrative expenses of the Plan.

#### Note 7. Tax Status

The Plan has adopted a non-standardized form of a pre-approved plan. The pre-approved plan provider, Empower Retirement Services, LLC, has received an opinion letter from the IRS as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any significant uncertain positions that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
