Notes to Financial Statements

December 31, 2024

1. Description of the Plan

The following description of TAMKO Employees Profit Sharing Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions. Copies of the document are available from the plan administrator.

General

The Plan is a defined-contribution plan covering substantially all full-time employees of TAMKO Building Products LLC (TAMKO), Allmine Paving LLC, and Allmine Trucking LLC (the Companies) who have completed at least one year of service. Allmine Paving LLC and Allmine Trucking LLC are wholly owned subsidiaries of Allmine Holdings LLC, which is a wholly owned subsidiary of TAMKO, the plan sponsor.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each year, the plan sponsor will make an aggregate contribution equal to a certain percentage of adjusted net profits for the year, as defined in the plan document. The plan sponsor may, at its discretion, contribute a greater amount up to certain maximum limitations as defined by the plan document or under Section 401(a) of the Internal Revenue Code (the Code). Employee contributions are not allowed.

Contributions exceeding the calculated amount per the formula set forth in the plan document are discretionary by the plan sponsor. Contributions for the years ended December 31, 2024 and 2023, were \$18,103,595 and \$13,219,008, respectively.

Participants direct the investment of the contributions and earnings into various mutual funds and common collective trust funds offered by the Plan.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Eligibility

To become a participant in the Plan, an employee is required to complete a minimum of 1,000 hours of service during the 12-consecutive-month period from the date of employment. If the service requirement is not met within the initial computation period, the measurement period is the subsequent 12-month period beginning with the employee's anniversary date. An employee receives credit for each hour for which the employer directly or indirectly pays the employee for performance of duties. Service credit is given for up to 501 hours paid for reasons other than performance of duties, such as leave of absence, vacation, holiday, and sick leave. Leased and contracted employees are excluded from participation in the Plan.

Participants' Accounts

The plan sponsor contribution is allocated to active participants on a unit system. For each plan year, the active participant is assigned one unit for each \$100 of the active participant's covered compensation for that plan year and two units for each year of service. To be entitled to an allocation, the participant must complete one hour of service during the plan year and be employed on the last day of the plan year. The contribution is allocated based on the ratio that the units assigned to the active participant bear to the total units assigned. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The participant's investments appreciate or depreciate to the benefit or detriment of the participant.

Vesting and Forfeitures

Participants are vested in their accounts based on years of service, with full vesting after three years of service. The non-vested balance is forfeited upon termination of service. Forfeitures resulting from termination prior to vesting are reallocated to participants on the same basis as the plan sponsor's contribution. Total forfeitures of \$150,981 and \$272,648 were allocated to eligible participants for the plan years ended December 31, 2024 and 2023, respectively.

Payment of Benefits

Upon termination of service, a participant with an account balance that does not exceed \$1,000 will receive a lump-sum distribution. A participant with an account balance exceeding \$1,000, but less than \$5,000, will receive a lump-sum distribution directly rolled over to an individual retirement account as designated by the Companies, unless the participant elects direct distribution or other eligible direct rollover.

1. Description of the Plan (continued)

A participant with a balance that exceeds \$5,000 may elect to receive a lump-sum amount equal to the value of the account, part lump-sum amount and part installments, or installments over a specified period of time not to exceed the lesser of ten years or the life expectancy of the participant.

Plan Termination

Although they have not expressed an intention to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of the Plan's termination, participants become 100% vested in their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for a further discussion and disclosure related to fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in net assets and liabilities in the financial statements, the accompanying notes, and the supplemental schedule. Actual results could differ from those estimates.

2. Summary of Significant Accounting Policies (continued)

Plan Tax Status

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated January 9, 2014, stating that the Plan is qualified under Section 401(a) of the Code, and, therefore, the related trust is tax exempt. Subsequent to this determination by the IRS, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan, as amended, is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Payment of Benefits

Benefit payments to participants are recognized upon distribution.

Administrative Expenses

Historically, although not contractually obligated to do so, the plan sponsor has paid the costs of administering the Plan, except for investment-related costs, which are netted against investment earnings, and qualified domestic relations order fees, which are paid by the Plan. Total administrative expenses paid by the plan sponsor for the plan years ended December 31, 2024 and 2023, were \$39,451 and \$38,939, respectively. Expenses that are paid by the plan sponsor are excluded from these financial statements.

Notes Receivable From Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance, plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are recorded when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

3. Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation (depreciation) in the fair value of investments, interest, dividends, and interest income on notes receivable from participants for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the Plan's trustees, Principal Trust Company, for the period January 1, 2023 through October 31, 2023, and by Fidelity Management Trust Company as of December 31, 2023, and for the period November 1, 2023 through December 31, 2023, and as of December 31, 2024, and for the year then ended.

4. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). The fair value hierarchy prioritizes the inputs to the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The fair value measurement level for an asset or a liability is based on the lowest level of any input that is significant to the measurement. The three levels of the fair value input hierarchy are as follows:

- Level 1 – Valuations are based on unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets or liabilities.

4. Fair Value Measurements (continued)

- Level 2 – Valuations are based on inputs other than quoted prices in active markets for identical assets and liabilities that are observable, either directly or indirectly, for substantially the full term of the asset or liability. Level 2 inputs include the following:
 - Quoted prices for similar assets and liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in markets that are not active
 - Observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means
- Level 3 – Valuations are based on unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumptions about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest-level input that is significant to the fair value measurement in its entirety.

The following is a description of the valuation techniques and inputs used for each general type of investment measured at fair value by the Plan:

Common collective trust funds: Valuations are based on the net asset value (NAV) provided by the administrator of the fund.

Mutual funds: Valuations are based on quoted market prices, which represent the NAV of shares held by the Plan at year-end.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported on the statements of net assets available for benefits.

6. Related-Party and Party-in-Interest Transactions

The Plan holds certain investment funds managed by Fidelity, the trustee and record-keeper for the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

7. Subsequent Events

Management evaluated subsequent events for the Plan through June 16, 2025, the date the accompanying financial statements were available to be issued. During this period, there were no subsequent events that required recognition or disclosure in the financial statements.
