Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of MartinFederal Consulting, LLC 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF PLAN

Nature of the Plan

The following description of the MartinFederal Consulting, LLC 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan’s Summary Plan Description for a more complete description of the Plan’s provisions.

General

The Plan is a safe harbor defined contribution 401(k) plan covering all employees of the Plan Sponsor, MartinFederal Consulting, LLC (the “Company”), who are age 21 or older. The Plan was effective January 1, 2011. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participant Salary Deferrals - Participants may contribute up to 100% of their eligible compensation, as defined by the Plan, or the maximum amount established by the Internal Revenue Service (IRS). Participants 50 years or older during the Plan year are eligible for catch-up contributions, up to a maximum amount established by the IRS. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover).

Participant Roth Deferrals - Participants may contribute up to 100% of their eligible compensation, as defined by the Plan, or the maximum amount established by the IRS as a Roth Deferral. Once made, this election is irrevocable (that is, a Participant Roth Deferral cannot later be re-characterized as a pre-tax Participant Salary Deferral). The amount of Participant Roth Deferral is included in participants’ income for tax purposes, and the income tax withholding amounts are deducted from the remainder of compensation, not from the Participant Roth Deferral amount.

Safe Harbor Matching Contributions - Each Plan year, the Company makes matching contributions to all participants in an amount equal to 100% of the first 3% of eligible compensation and 50% of the next 2% of eligible compensation contributed to the Plan as Deferral Contributions.

Discretionary, Non-elective Employer Contributions - Each Plan year, the Company, at the discretion of the Company’s Board of Directors, may make discretionary contributions, as defined in the Plan document. Discretionary contributions, if made, are allocated to eligible participants, and based upon the percentage of each participant’s compensation to the total compensation of all eligible participants.

Participant Accounts

Each participant's account is credited with the participant's contribution, an allocation of the Company's contribution and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective deferrals and the Company's Safe Harbor Matching Contributions. The Company's discretionary contributions vest over three years of service: 25% after one year of service, 50% after two years of service and 100% after three years of service. Amounts not vested at the time a covered participant ceases to participate in the Plan are forfeited.

Investment Options

A participant may direct employee contributions in one percent increments among a diversified mix of investment options available to the Plan. Participants invest in the trust fund, which is held by Principal Trust Company (the "Trustee"). Principal Financial Group is the record keeper. Participants may make changes in their investment elections at any time.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest rates of 5.75% to 11.50%, which are commensurate with local prevailing rates and determined by the plan administrator at the time of issuance. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of Benefits

Benefits commence upon one of several dates: normal retirement, late retirement, date of disability, death, or upon termination of employment. Benefits are distributed by means of either direct rollover, lump-sum distributions, or by one of various conventional annuity options.

Forfeitures

Forfeited non-vested accounts are used to reduce Plan expenses or offset Company contributions. As of December 31, 2024 and 2023, there were forfeited non-vested accounts totaling \$0 and \$1, respectively. During 2024, there were no participant forfeitures incurred related to withdrawals from accounts that were not fully vested.

Administrative Expenses

Administrative expenses of the Plan are first reduced by forfeitures and then paid by the Company. Administrative expenses recorded in the Plan represent Trustee fees, investment advisory fees and other recordkeeping fees paid directly from the Plan to the Plan's Trustee. Loan fees are deducted directly from the participants' accounts.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America. In preparing the financial statements, management evaluated subsequent events through August 21, 2025, the date the financial statements were available to be issued.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Concentration of Market Risk

As of December 31, 2024 and 2023, approximately 24% and 48%, respectively, of the Plan's net assets were invested in two and four registered investments, respectively. The underlying value of the investments are dependent on the performance of the individual investment holding and the market's evaluation of such performance. It is at least reasonably possible that changes in the fair value of the registered investments and their investment holdings in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Realized gains and losses from security transactions are reported on the average cost method.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

Fair Value

The established framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Fair value is the price the Plan would expect to receive to sell an asset or pay to transfer a liability in an orderly transaction with a market participant at the measurement date. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs which are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Fair Value - Continued

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Payment of Benefits

Benefit payments to participants are recorded when paid.

NOTE 3 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee, Principal Trust Company, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

- Investments at fair value and notes receivable from participants, included in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income, interest income on loans, interest income and net appreciation in fair value of investments, included in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- The schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024, included in the supplemental information.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedule.

NOTE 4 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate and market risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities may occur in the near term and those changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 5 - FAIR VALUE MEASUREMENTS

The following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at December 31, 2024 and 2023.

- *Pooled separate accounts and mutual funds*: Valued at the closing price reported on the active market on which the individual securities are traded.
- *Common collective trust*: Valued at net asset value per share/unit reported at the close of every business day.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 - RELATED PARTY TRANSACTIONS

Certain Plan investments, pooled separate accounts and a common collective trust are managed by Principal Trust Company, the Trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 8 - TAX STATUS

The Plan is a Principal Life Insurance Company volume submitter defined contribution plan. The IRS has ruled, in a letter dated June 30, 2020, that the volume submitter plan developed by Principal Life Insurance Company, after which the Plan is modeled, qualifies under the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the advisory letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.
