### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of The Gatesworth Employee Savings & Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Gatesworth Employee Savings & Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### Note 1: Description of Plan

The following description of The Gatesworth Employee Savings & Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### SECURE 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. Each of the provisions in SECURE 2.0 has its own effective date ranging from the date of enactment to 2028 and beyond, with the bulk of the provisions taking effect in 2023 and 2024. In accordance with SECURE 2.0, the Plan increased the age for required minimum distributions (RMD) from age 72 to age 73 effective January 2023. Further changes set forth in the SECURE 2.0 Act include eliminating pre-death RMD rules for Roth accounts and several voluntary changes to distribution provisions, effective January 2024. The Plan is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

#### **General**

The Plan, which was adopted on January 1, 1994 is a defined contribution plan covering all eligible employees of the Plan Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Principal Life Insurance Company (Principal) is the directed Custodian of the Plan and Orenda Retirement, LLC provides recordkeeping services.

#### **Eligibility**

All non-collectively bargained employees of the Plan Sponsor are eligible to participate in salary deferral contributions and matching contributions after twelve consecutive months of work completing at least 1,000 hours of service during that time and having attained the age of 21.

#### **Contributions**

Each year, participants may contribute up to 92% of annual eligible compensation, as defined in the Plan and designate those contributions as either pre-tax or Roth. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also transfer funds to the Plan from other qualified retirement plans.

For the years ended December 31, 2024 and 2023, the Plan Sponsor matched 25.0% of contributions on the first 5.0% of compensation.

### **Note 1: Description of Plan** (Continued)

#### **Contributions** (Continued)

Discretionary profit-sharing contributions are determined annually and will be allocated to the participant's profit sharing contribution accounts of each participant eligible to share in such allocations after the end of the plan year. Such contributions will be allocated to the profit sharing contribution account of each participant eligible in pro rata shares. There were no discretionary profit-sharing contributions for the year ended December 31, 2024.

Participants may direct contributions to any investment options offered by the Plan. Contributions are subject to certain limitations.

#### **Investment Options**

Participants of the Plan elect investment accounts in which their contributions, as well as employer contributions, are invested. The investment account options comprise various degrees of risk and return.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Plan Sponsor's contributions and an allocation of the Plan's earnings and administrative expenses. Administrative expenses are allocated based on participant transactions. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their elective deferral, Roth, and rollover contributions plus actual earnings thereon. Participants are 20% vested in Plan Sponsor contributions for each service year, as defined by the Plan, beginning after the first year of service until they are fully vested. Non-vested amounts are forfeited if an employee terminates prior to full vesting. In the event of the death, disability, or retirement of a participant, the participant will automatically become fully vested.

#### **Notes Receivable From Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50.0% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates from 4.25% to 9.50%, which are commensurate with the prevailing Prime rate plus 1.0% at the time the loans were granted. Principal and interest are paid ratably through payroll deductions. Loans are for a period not exceeding five years unless used to acquire a personal residence, in which case the term is no more than fifteen years.

### Note 1: Description of Plan (Continued)

#### Payment of Benefits

On termination of service, disability, or retirement, participants may elect to receive an amount equal to the value of the interest in their accounts in either a lump-sum amount or in installments, depending on the size of the participant's account balance at the time of termination. During the year ended December 31, 2024, the Plan increased the dollar limit for mandatory distributions from individual retirement accounts for balances between \$1,000 and \$5,000 to balances between \$1,000 and \$7,000.

The company may authorize certain withdrawals from a participant's account in the event of proven financial hardship or at the age of 59½.

Hardship withdrawals are subject to specific statutory and regulatory requirements. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met.

#### Forfeitures

At the time a participant terminates employment, the non-vested portion of the company matching, or discretionary contribution accounts are forfeited. These accounts may be used to pay Plan expenses or to reduce any employer contributions. Forfeitures used to pay Plan expenses amounted to \$2,313 during 2024. At December 31, 2024 and 2023, the forfeitures accounts did not have a balance.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and reported amounts of revenue and expenses during the reporting period. Actual results may differ from these estimates.

#### Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

#### Payment of Benefits

Benefits to participants are recorded when paid.

#### Administrative Expenses

Participant level processing fees, which include distribution and loan fees, are allocated directly to the participant initiating those transactions. Expenses incurred on the purchase or sale of investments are added to the cost or deducted from the proceeds of the respective investments. Salaries and related benefits of employees who administer the Plan and other Plan level expenses are provided by the Plan Sponsor.

#### Investment Valuation and Income Recognition

Investments, other than fully benefit-responsive investment contracts, are reported at fair value. Fair value is the price that could be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

The Plan's investment in the guaranteed investment contract is stated at contract value. Contract value is the relevant measurement attribute for that portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan (See Note 4).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The fully benefit-responsive investment contract is included in the statements of net assets available for benefits at contract value, which management believes approximates fair value. The statement of changes in net assets available for benefits is prepared on a contract value basis as well.

#### Subsequent Events

Management evaluates subsequent events through August 11, 2025, the date the financial statements are available to be issued.

### Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level I - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level II - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

Level III - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Registered investment companies:* Valued at the daily closing price as reported by the registered investment companies (mutual funds). Registered companies investments held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered companies investments held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* Valued at the NAV of units held by the Plan at year end. The NAV is determined by dividing the net assets, at fair value, of the fund by the number of units outstanding on the day of valuation. The NAV, as provided by Principal, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The pooled separate accounts are comprised primarily of shares of mutual funds that are traded on an active market. The pooled separate accounts may be redeemed by participants daily at NAV with no advanced redemption notice required. There are no unfunded commitments.

### Note 3: Fair Value Measurements (Continued)

*Common collective trust investments funds:* Valued at the NAV of units of the individual funds. The NAV, as provided by the trustees of the invested funds, is used as a practical expedient to estimate fair value and is calculated daily by the trustee. The NAV is based on the fair value of the underlying investments held by the funds less its liabilities. This practical expedient is not used when it is determined to be probable that the funds will sell the investment for an amount different than the reported NAV. The funds have daily redemption frequencies at NAV with no redemption notice periods, and files annual reports on Form 5500 as direct filing entities. There are no capital commitments related to any of the Plan's common collective investment trust funds.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 4: Investments at Contract Value

The Plan entered into a fully benefit-responsive guaranteed investment contract with Principal. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Principal is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Interest income on the contract is calculated and credited daily based on fixed interest rates. Interest rates are reset on a semiannual basis. The average crediting interest rate, net of expenses, was 1.55% during 2024 and ranged from 1.55% to 1.75% during 2023.

### **Note 4: Investments at Contract Value** (Continued)

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) the decision by the Plan Sponsor to withdraw all assets from the contract and reinvest in another investment vehicle, (3) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (4) the delivery of any communication to Plan participants designed to influence the participant not to invest in the fund, (5) any change in law, regulation, ruling, administrative or judicial position, or accounting requirement applicable to the Plan. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

### **Note 5: Information Prepared and Certified by the Custodian**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, net appreciation in net asset value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Principal, the Custodian of the Plan.

### **Note 6: Party-In-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, a person who owns 50% or more of such an employer or relatives of such persons.

Certain Plan investments are pooled separate accounts, common collective investment trust funds, and a guaranteed investment contract managed by Principal during the year ended December 31, 2024 and 2023. The fees paid by the Plan for the investment management services are netted with the investment income on each investment option of the Plan for the year ended December 31, 2024.

In addition, certain participants have outstanding loans with the Plan as of December 31, 2024 and 2023. These transactions qualify as party-in-interest transactions.

The Plan paid an administrative fees of \$42,739 to Principal for the year ended December 31, 2024.

### **Note 7: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

### **Note 8: Income Tax Status**

On June 30, 2020, the Internal Revenue Service stated that the prototype adopted by the Plan, as then designed, qualified under IC Section 401(a). The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe the Plan is qualified and that the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### **Note 9: Risks and Uncertainties**

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
