Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of 401(k) Profit-Sharing Plan for Employees of Alphapointe (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits (modified cash basis) for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in *Note 3* to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the "Auditor's Responsibilities for the Audit of the Financial Statements" section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Note 1. Description of the Plan

General

The following description of 401(k) Profit-Sharing Plan for Employees of Alphapointe (the “Plan”) provides only general information. Participants should refer to the *Summary Plan Description* for a more complete description of the Plan’s provisions.

The Plan is a defined contribution plan covering all eligible employees of Alphapointe (the “Company” or “Sponsor”). The Plan covers all employees of the Company, excluding on-call employees and those employees who opt out of coverage due to Social Security disability coverage limitations. In addition to the two groups above, service contract employees and optometrists are not eligible to receive employer matching or contributions. There is no minimum age requirement for plan eligibility. Employees must complete one year of service to be eligible to receive employer contributions.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Mutual of America Life Insurance Company is the custodian of the Plan.

Effective January 2025, the Company amended the Plan to change the custodian from Mutual of America Life Insurance Company to Empower Trust Company, LLC.

Contributions

The Plan permits eligible employees to make annual contributions of up to 100% of eligible compensation through a salary deferral election subject to certain limitations by the Internal Revenue Code (the “Code”) and regulations thereunder. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Employees have the option of making Roth and rollover contributions.

Upon obtaining twelve months of service, employees will receive a matching contribution equal to 50% of employee’s contribution up to 4% of the employee’s compensation. In addition, employees will receive an employer base contribution equal to 3% of the employee’s eligible compensation.

Participant Investment Account Options

The participant contributions and employer contributions are allocated to the various investment options offered by the Plan as directed by the participants. If a participant does not complete an investment election form, the funds will be placed in the general account (interest accumulation account). For employees hired on or after December 31, 2017, the Plan was amended to include an automatic deferral feature whereby a participant is treated as electing to defer a certain percentage of eligible compensation unless the participant made an affirmative election otherwise. The automatic feature allows for a fixed 4% of compensation deferred unless the participant elects otherwise.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s matching and employer base contributions and (b) plan earnings. Allocations are based on participant earnings or account balances, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. The employer matching contribution and the employer base contributions to each participant's account are subject to vesting requirements. The employer matching and base contributions vest according to the following schedule:

Notes Receivable from Participants

Notes receivable from participants represent loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Participants may borrow from their own account a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. Loan terms, in general, range up to five years. Loan terms may exceed five years for the purchase of a principal residence subject to a limit determined by the Plan's trustees. The loans are secured by the balances in the participants' accounts and bear interest at a rate determined by the Plan Administrator ranging from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document. The maximum number of loans that a borrower may have outstanding at any one time is two.

Payment of Benefits

On termination of service due to death, disability or retirement, participants or their estate will receive an amount equal to the value of the participant's vested account balance in a lump-sum distribution or an annuity. On termination of service due to other reasons, a participant may receive the value of the vested interest in the participant's account as a lump-sum distribution. In-service distributions are made upon request of the participant subject to certain limitations imposed by the Code. Certain income tax penalties may apply to withdrawals or distributions prior to age 59½.

Forfeited Accounts

Plan forfeitures are used to reduce employer contributions. The amount of forfeitures available to reduce employer contributions was \$537 and \$11,524 at December 31, 2024 and 2023, respectively. The amount of forfeitures used to reduce employer contributions was \$104,466 and \$0 for the years ended December 31, 2024 and 2023, respectively.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan maintains its accounts on the basis of cash receipts and disbursements on the modified cash basis, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Consequently, certain revenue and the related assets are recognized when received rather than when earned, and certain expenses are recognized when paid rather than when the obligation is incurred.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Pooled separate accounts are valued at estimated fair value as provided by Mutual of America Life Insurance Company. The Plan's general account with Mutual of America Life Insurance Company is valued at fair value for December 31, 2024 and 2023.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Certification of Plan Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Mutual of America Life Insurance Company, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023. Notes receivable from participants as shown in the statement of net assets available for benefits (modified cash basis) as of December 31, 2024.
- Investment income as shown in the statements of changes in net assets available for benefits (modified cash basis) for the years ended December 31, 2024 and 2023. Interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) (modified cash basis) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain plan investments are units of pooled separate accounts and a general account that is managed by Mutual of America Life Insurance Company, which is the custodian of the Plan. Therefore, these transactions qualify as party-in-interest transactions.

The Plan paid \$9,538 and \$3,476 of recordkeeping fees to Mutual of America Life Insurance Company during the years ended December 31, 2024 and 2023, respectively. The Sponsor provides certain administrative services at no cost to the Plan.

Note 5. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs are supported by little or no market activity and are significant to the fair value of the assets or liabilities

There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 7. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Mutual of America Life Insurance Company. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statements date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits (modified cash basis).

Note 10. Subsequent Events

Subsequent events have been evaluated through August 13, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2026, the Plan was amended to exclude certain employees from contributing to the Plan including interns, residents of Puerto Rico, and employees with less than 1,000 hours of service during the Plan year.
