Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Hirzel Canning Co. & Farms 401(k) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Note 1 – Description of Plan and Significant Accounting Policies

The following brief description of the Hirzel Canning Co. & Farms 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established under Section 401(k) of the Internal Revenue Code of 1986 (the Code) covering all employees of Hirzel Canning Company and the Hirzel Farms (the Company). The Plan was adopted by the Company effective September 1, 2006. Employees who are age 18 or older and have completed at least one year of service accumulating to at least 1,000 hours are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to defer up to 100% of annual earnings, as defined in the Plan, subject to the maximum amount allowable by the Internal Revenue Service per year. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. For 2024 and 2023, the Company's discretionary matching contribution was 50% of participants' contributions, not to exceed 4% of the participants' compensation. There was no additional profit sharing contribution made for both 2024 and 2023.

Valuation of Investments and Income Recognition

Investments are reported at fair value and certified by Capital Bank and Trust Company. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participant Accounts

Each participant's account is credited with their individual contribution and an allocation of the Company's matching and profit sharing contribution, and Plan earnings (losses). Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Each participant directs the trustee to invest his or her funds in the investment options established under the Plan. During 2024 and 2023, there were \$110,798 and \$108,944, respectively, in Company matching contributions and \$403,844 and \$405,348, respectively, in employee contributions.

Vesting

Participant contributions and earnings are always 100% vested. The Company's matching and discretionary contributions and earnings vest 20% after two years of credited service and 20% each additional year becoming fully vested after six years of credited service. Participants are also fully vested if, while employed with the Company, the employee dies or becomes disabled.

Plan Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from the financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$17,628 and \$14,480, respectively. These accounts will be used to either reduce future employer discretionary contributions or to pay expenses. Also, in 2024 and 2023, forfeited nonvested accounts were reduced by \$2,564 and \$0, respectively, to pay Plan expenses.

Payment of Benefits

Upon termination of employment, or due to death, disability, or retirement, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. The Plan provides for in-service distributions if the participant has attained the age of 59 ½. Benefit distributions for the Plan year ended December 31, 2024 and December 31, 2023 were \$667,949 and \$466,059, respectively.

Notes Receivable from Participants

Participant loans are not permitted under the Plan document.

Use of Management's Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Subsequent Events

The Plan has evaluated subsequent events through August 14, 2025, the date the financial statements were available to be issued.

Note 2 – Information Prepared and Certified by Trustee

The trustee of the Plan, Capital Bank and Trust Company, holds the Plan's investments and executes all investment transactions. The related financial information included in the accompanying financial statements and schedule is based solely on information provided by the trustee. The investment results have been reported to the Plan by Capital Bank and Trust Company.

Note 3 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974. In the event of Plan termination, all amounts credited to participants' accounts for employer contributions will be fully vested.

Note 4 – Income Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020 that the prototype plan is designed with applicable sections of the Internal Revenue Code (IRC). The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain tax position that more likely than not would not be sustained by examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 – Related-Party Transactions and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by American Funds Distributors, Inc. American Funds Distributors, Inc. is a wholly owned subsidiary of The Capital Group Companies, Inc. who also owns Capital Bank and Trust Company, the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through a revenue sharing, rather than a direct payment. As described in Note 1, the Plan made direct payments to third parties of \$12,017 in 2024 and \$5,699 in 2023, which were not covered by revenue sharing. The Plan sponsor pays directly any other fees related to the Plan's operations.

Note 6 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access at the measurement date;

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability; and

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Mutual fund accounts: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commissions. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
