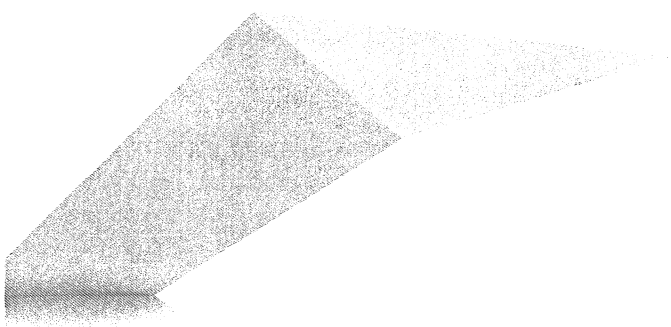

The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Stereon Companies Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

Stereon Management Co., Inc. (the "Company") and its affiliated companies under common ownership are treated as a single group, collectively.

The Plan is a defined contribution plan covering all eligible employees throughout 16 McDonald's franchises and the management company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The plan has adopted the required minimum distribution at age 73 effective January 1, 2023, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

Eligibility

Eligible employees include all employees that are at least 20 years old, except leased employees and residents of Puerto Rico. Employees are eligible to participate in the Plan on the first day of the Plan year, or the first day of the seventh month subsequent to completing one year of service with 1,000 hours, or three years of consecutive service with 500 hours.

Contributions

The Plan permits voluntary participant contributions between 1% and 75% of their salary up to the maximum allowed under the Internal Revenue Service ("IRS").

The Company may make a discretionary profit sharing contribution based on an integrated formula on behalf of each eligible participant. Generally, eligible participants must be employed on the last day of the Plan year, however, if employment is terminated prior to December 31 due to death, disability, or retirement, a participant may still be eligible to receive a portion of the profit sharing contribution.

Profit sharing contributions of \$441,726 were made for the year ended December 31, 2024.

Note 1: Description of Plan (Continued)

Participant Accounts

Individual accounts are maintained for each participant. Each participant's account is credited with participant's contributions, Company contributions, and allocations of Plan earnings (losses), and charged with withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments

Contributions to a participant's account can be invested in a variety of investment vehicles and are managed on the participant's behalf by the Plan's trustee. Investment options are selected by participants and may be changed at any time.

Notes Receivable From Participants

Participants may receive a note from their account for a minimum amount of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes bear interest at the prime rate plus 1% and are repaid through payroll deductions over a maximum term of five years, unless the note is for the purchase of a primary residence, in which case the term may exceed five years. Interest rates on existing notes range between 4.25% and 9.50%. The remaining account balance serves as security for the note and any defaulted balances are included in the participant's gross income for federal income tax purposes as if a regular distribution was made.

Payment of Benefits

Benefits may be paid to the participant or beneficiary upon death, disability, retirement or termination of employment, as defined in the Plan agreement. The Plan provides for normal retirement at age 65 and early retirement on or after attaining age 59 1/2. Distributions may be deferred until the participant reaches the age of 73, provided the account balance is greater than \$7,000. The total vested portion of a participant's account balance is distributed in the form of a lump-sum payment or an annuity. In addition, hardship distributions from the participant's vested account balance are permitted if certain criteria are met.

Vesting

Participants are immediately vested in their contributions plus actual earnings (losses) thereon. An employee receives one year of credited service for discretionary employer profit sharing contributions for each Plan year in which the employee completes at least 1,000 hours of service. A participant's account (other than amounts attributable to the participants' contributions) vests 10% for each year of credited service for the first two years and 20% for the next three years and becomes 100% vested after six years of credited service. Upon normal retirement, death or disability, a participant's account becomes fully vested. However, if employment terminates before a participant's account becomes fully vested; the non-vested portion will be forfeited.

Forfeitures

Forfeitures of non-vested contributions are used to pay administrative, accounting, and legal expenses, with any remaining forfeitures used to reduce Company contributions. At December 31, 2024 and 2023, total unallocated forfeitures were \$65,513 and \$68,128, respectively. Forfeitures of \$26,052 and were used to pay administrative expenses during 2024.

Administrative Expenses

Administrative expenses represent fees paid by the Plan for investment management services. In addition, the Company pays certain administrative expenses of the Plan. Administrative expenses paid by the Company are excluded from these financial statements.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates in Preparation of Financial Statements

The preparation of the accompanying financial statements in conformity with GAAP requires management to make estimates and assumptions that directly affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of changes in net assets available for benefits during the reporting period. Actual results may differ from these estimates and are subject to change in the near term.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through August 21, 2025, which is the date the financial statements were available to be issued.

Note 3: Tax Status

The Plan adopted the Fidelity Prototype Plan ("Prototype Plan") with an IRS determination letter dated June 30, 2020, which states the Prototype Plan was in compliance with the applicable sections of the Internal Revenue Code ("IRC").

Note 4: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

Note 5: Information Certified by the Trustee of the Plan

Certain information related to the Plan's investments disclosed in the accompanying financial statements and supplemental schedule, was obtained or derived from information certified as complete and accurate by Fidelity Management Trust Company ("Fidelity"), trustee of the Plan. This information includes investments held, and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the year ended December 31, 2024.

Note 6: Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Fidelity. As trustee of the Plan, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the trustee for investment management and other services amounted to \$44,006 for the year ended December 31, 2024. The Plan allows participants to obtain notes, which are considered party-in-interest transactions. Notes receivable from participants qualify as party-in-interest transactions, and are exempt from the prohibited transaction rules of ERISA.

Note 7: Fair Value Measurements

GAAP specifies a three-tier fair value hierarchy, which prioritizes the inputs used in estimating fair value. These tiers include Level 1, defined as observable inputs such as quoted market prices in active markets; Level 2, defined as inputs other than quoted market prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable value collective trust fund: A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the NAV of units of the collective trust. The NAV is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily using NAV. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. As of December 31, 2024 and 2023, there were no unfunded commitments.

We have audited the financial statements Stereon Companies Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ["ERISA Section 103(a)(3)(C) audit"] for the year ended December 31, 2024, and we have issued our report thereon dated August 21, 2025. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan ("investment information") by Fidelity Management Trust Company (the "Trustee"), which is a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and supplemental schedule, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America ("GAAP"). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP. Professional standards require that we provide you with information about our responsibilities under auditing standards generally accepted in the United States of America ("GAAS"), as well as certain information related to the planned scope and timing of our audit. We have communicated such information orally during our discussion on May 7, 2025, and in our engagement letter dated April 15, 2025. Professional standards also require that we communicate to you the following information related to our audit.

Significant Audit Matters

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted, and the application of existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. We had no significant differing opinions regarding management's accounting estimates.

Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. There were no particularly sensitive disclosures noted for 2024.

The financial statement disclosures are neutral, consistent, and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. No such known or likely misstatements were identified during our audit. In addition, we did not identify any misstatements that management determined to be immaterial and passed on recording.

Disagreements With Management

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated August 21, 2025, a copy of which accompanies this letter.

Management's Consultation With Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

Other Matters

Our responsibility for the ERISA-required supplemental schedule accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedule, other than that agreed to or derived from the certified investment information, is presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure Under ERISA, and whether the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Internal Control Matters

Except as discussed in the following paragraph, in planning and performing our audit of the financial statements of the Plan, an employee benefit plan subject to ERISA, as of and for the year ended December 31, 2024, in accordance with GAAS, we considered the Plan's internal control over financial reporting ("internal control") as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of issuing our report on the financial statements, but not for the purpose of expressing our opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

We were engaged to perform an ERISA Section 103(a)(3)(C) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan ("investment information") by Fidelity Management Trust Company that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit also did not include a consideration of internal control relating to the investment information.

Our consideration of internal control was for the limited purpose described in the preceding paragraphs and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies; therefore, material weaknesses or significant deficiencies may exist that were not identified. In addition, because of inherent limitations in internal control, including the possibility of management override of controls, misstatements due to error or fraud may occur and not be detected by such controls. Given these limitations, during our audit we did not identify any deficiencies in internal control that we consider to be material weaknesses. However, material weaknesses may exist that have not been identified.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A material weakness is a deficiency, or a combination of deficiencies in internal control, such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented, or detected and corrected, on a timely basis. We did not identify any deficiencies in internal control that we consider to be material weaknesses.

A significant deficiency is a deficiency, or combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance.

Other Operational, Administrative, and Internal Controls Matters

During our audit, we also became aware of deficiencies in internal control other than significant deficiencies or material weaknesses, and the following other matters that are opportunities for strengthening internal controls and operating efficiency:

During our audit, it was noted that the forfeiture balance is not being utilized timely. As of December 31, 2024, there was a balance of \$65,513. The Internal Revenue Service ("IRS") has issued proposed regulations stating that Plan forfeitures must be used no later than 12 months after the close of the Plan year in which they were incurred. We recommend management continue to work with the third-party administrator to utilize the forfeitures timelier. The IRS views timely use of forfeitures as a requirement for maintaining the Plan's tax-qualified status and allowing them to accumulate beyond the deadline could result in operational issues that might jeopardize the Plan's qualified status and losing its favorable treatment as well as costing the Plan Sponsor correction and administrative costs.

We will review the status of these comments during our next audit engagement. We have previously discussed this comment and suggestion with you, and we will be pleased to discuss them in further detail at your convenience, to perform any additional study of this matter, or to assist you in implementing the recommendations.
