Opinion on the 2024 Financial Statements

1. Description of Plan

The following description of the Mission Autism Clinics 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees, excluding those covered under collective bargaining, leased employees, and non-resident aliens, of Mission Autism Clinics LLC (the Company) who are age twenty-one or older. Effective January 1, 2020, any employee who has completed 6 months of service, measured from the date of hire, and has attained age 21 shall be eligible to participate in the plan. After reaching eligibility, participants can elect to enroll in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute up to 90% of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Maximum Roth elective deferral contributions are 50% of compensation. The Plan may make discretionary matching contributions. In 2024, the Plan contributed 100% of participant deferrals up to 3% of compensation deferred by participant. In addition, the Plan may make a discretionary profit-sharing contribution at the end of the Plan year. Only eligible employees who are employed on December 31st will be eligible to receive an allocation. Contributions are subject to certain limitations. No discretionary contributions were made in 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the matching and/or profit sharing contribution's and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant compensation or contributions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after three years of service.

Participant Loans

Participant loans are classified as notes receivable from participants, which are segregated from plan investments and measured at their unpaid principal balance plus any accrued but unpaid interest.

Participants may borrow from their fund accounts a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Loan terms range from 1 to 5 years and bear interest at Prime plus 1%. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 9.0% to 9.50%, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions. The loans are measured at unpaid principal balance plus accrued but unpaid interest.

1. Description of Plan, continued

Payment of Benefits

On termination of service due to death, disability or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may also receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts

Forfeitures attributable to employer contributions are retained in the Plan and will be first used to pay administrative expenses. Any remaining amounts will be used to reduce future employer contributions payable under the plan. During the year ended December 31, 2024, the Plan used \$30,315 to pay employer contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with FASB Accounting Standards Codification (ASC 962).

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Fair Value Accounting

Valuation techniques used in fair value measurements need to maximize the use of observable inputs and minimize the use of unobservable inputs. A valuation method may produce a fair value measurement that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those used by other market participants, the use of different methodologies or assumptions could result in different fair value measurements at the reporting date. Assets and liabilities measured at fair value are categorized into one of three different levels depending on the observability of the inputs employed in their measurement. Level 1 inputs are quoted prices in active markets for identical assets or liabilities. Level 2 inputs are observable inputs other than quoted prices included within Level 1 for the asset or liability, either directly or indirectly through market-corroborated inputs. Level 3 inputs are unobservable inputs for the asset or liability, including the Plan's own assumptions in determining the fair value of the assets or liabilities.

2. Summary of Significant Accounting Policies, continued

Allowance for Credit Losses

When the Plan records contributions receivables arising from transactions, the Plan records an allowance for credit losses for the current expected credit losses (CECL) inherent in the asset over its expected life. The allowance for credit losses is a valuation account deducted from the amortized cost basis of the assets to present their net carrying value at the amount expected to be collected. Each period the allowance for credit losses is adjusted through earnings to reflect expected credit losses over the remaining lives of the assets.

Contributions

Contributions to the Plan are recorded in the period that payroll is taken from Plan participants. Employer matching contributions are recorded based on employee contributions during the period.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold during the year..

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Administrative Expenses

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded in the accompanying statement of changes in net assets available for benefits as administrative expenses. The employer absorbs recordkeeping, accounting, legal, and trustee service fees.

Payment of Benefits

Benefits are recorded when paid.

Reclassifications

Certain reclassifications have been made to prior year's balances in order to conform to current year presentation.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1	Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

The fair values of registered investment companies and money markets are based upon quoted prices when available. At December 31, 2024 and 2023, all such investments were redeemable at the measurement date.

5. Excess Contributions

The Plan passed discrimination tests for 2024 and 2023; as a result there were no excess contribution distributions made to participants related to the years ended December 31, 2024 and 2023.

6. Related-Party Transactions and Party in Interest Transactions

Human Interest is the recordkeeper for the Plan, and assets are held with Human Interest provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement (MSA) between the Company and Human Interest. Investments are provided through Matrix Trust Company which receives revenue from mutual fund fees charged to participant accounts.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

8. Risks and Uncertainties

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. Tax Status

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.
