Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

NOTE 1 DESCRIPTION OF THE PLAN

The following description of The Fort Walton Machining 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan generally covering substantially all employees of Fort Walton Machining, Inc. (the Company). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is designed to comply with Section 404 (C) of the Internal Revenue Code. The Plan is administered by the Company. However, various record-keeping, compliance, and financial reporting requirements are performed through the contracted plan administrator, Great-West Life and Annuity Insurance Company as of December 31, 2024.

Contributions – Participants may contribute up to 50% of their gross annual compensation, subject to certain limitations. Participants may make after-tax Roth 401(k) contributions to the Plan. Participants who have attained age 50 by year-end may also make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Upon completion of one year of service, the Company may make discretionary matching contributions based on a percentage of each participant's elective deferral contributions. Catch-up contributions are not matched. For the year ended December 31, 2024, the Company made discretionary matching contributions equal to 25% of each participant's contributions up to 6% of the participant's compensation. The Company may make qualified nonelective contributions to the Plan for all non-highly compensated employees, up to 5% of their eligible compensation. The Company may also make discretionary profit sharing contributions that are allocated to all active participants on the last day of the Plan year. There were no qualified nonelective contributions or profit-sharing contributions to the Plan for the year ended December 31, 2024.

Participant Accounts – Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their contributions and the Company's qualified nonelective contributions plus actual earnings thereon. Vesting in the Company's matching and profit sharing contribution portions of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service with more than 1,000 hours of service in each year. However, participants become 100% vested in employer matching contributions if employed on or after normal retirement age or if employment is terminated due to disability or death. At December 31, 2024, the vested benefit for terminated employees was \$896,293, respectively.

Investment Options - Participants may choose from several investment options which are offered by the Plan. Those investment options consist of mutual funds, a common collective trust fund, and a fixed annuity contract.

Participant Loans – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by any existing loan balance. Loan terms may range from one to five years, or up to 15 years for the purchase of a principal residence. Principal and interest are paid ratably through bi-weekly payroll deductions. Loan balances considered uncollectible are deemed as distributions to participants. The loans are secured by the balance in the participant’s account and bear interest at a rate between 4.25 – 9.95 percent, which is commensurate with local prevailing rates.

Payment of Benefits – Upon attainment of age 59½, a participant may elect to receive an amount equal to the value of the participant’s vested interest in his or her account in a lump-sum distribution or a partial distribution, with two partial distributions allowed in a 12-month period. Upon termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant’s vested interest in his or her account in a lump-sum distribution. Withdrawals from a participant’s rollover contribution account may be made at any time. A participant may also request a distribution in case of hardship as detailed in the Plan provisions.

Forfeited Accounts – At December 31, 2024, there were no forfeited non-vested accounts. Forfeitures are used to reduce employer contributions or are allocated among participants.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The Plan presents in the statement of changes in net assets available for plan benefits, the net appreciation in the fair value of its investments which consists of the realized gains or losses on investments sold during the year and the unrealized appreciation on investments held at year end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date

Payment of Benefits

Benefits are recorded when properly executed requests for distribution are received.

Administrative Expenses

Broker fees are paid from the participants' individual brokerage accounts. The Plan permits the payment of Plan administrative expenses to be made from the Plan assets. These expenses will generally be allocated among the accounts of all participants in the Plan based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan.

Subsequent Events

The Plan has evaluated subsequent events through the date the financial statements were available to be issued.

There were no material subsequent events which require disclosure at December 31, 2024.

NOTE 3 UNAUDITED INFORMATION

Great-West Life & Annuity Insurance Company holds the Plan investment assets and executes transactions as of December 31, 2024 and 2023. Financial information for 2024 and 2023 relating to these assets is included in the accompanying financial statements and is based on information provided by the trustees. This financial information presented on pages 3, 4 and in Notes 4 and 5 has not been audited by independent auditors.

NOTE 4 FAIR VALUE MEASUREMENTS—UNAUDITED

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the quoted net asset value (“NAV”) of shares held by the Plan at year-end.

Fixed annuity contract: Valued based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider.

Common collective trust fund: Valued at the NAV of units held by the Plan at year-end. The NAV is used as a practical expedient to estimate fair value. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months’ notification to ensure that securities liquidations will be carried out in an orderly business manner.

Participant Loans: Valued at amortized cost, which approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The common collective trust fund and pooled separate accounts are not categorized within the fair value hierarchy. There have been no changes in the methodologies used at December 31, 2024.

NOTE 5 FIXED ANNUITY CONTRACT WITH INSURANCE COMPANY

The Plan provides an investment option to invest in the Empower Investments Fixed Account, which is a fixed annuity contract issued by Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America maintains the contributions in a general account that is credited with a guaranteed and fixed rate of return. The contract issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan. The interest rate is reviewed quarterly for resetting.

The fixed annuity contract is included in the financial statements at fair value as it is not fully benefit-responsive. The fixed annuity contract promises contract value for a benefit event, such as a termination, death, disability or retirement. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. A participant may transfer their account balance to any other investment option offered under the Plan at any time with no restrictions or penalties. However, certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value. If there is an employer-initiated event, such as but not limited to a merger, acquisition or partial Plan termination, a book value payment is made to the Plan sponsor over a period of 12 or 36 months, depending on market conditions. Alternatively, the Plan sponsor can be paid in an immediate lump sum, subject to a market value adjustment.

NOTE 6 TAX STATUS

The Plan uses a non-standardized defined contribution pre-approved plan. Therefore, the Plan itself has not received a determination letter from the IRS. The latest opinion letter covering the Plan from the Internal Revenue Service (“IRS”) is dated August 1, 2023, which states that the document satisfies the applicable provisions of the Internal Revenue Code (“IRC”). The Plan’s management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan’s financial statements.

NOTE 7 PLAN TERMINATIONS

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 8 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefit.
