**1. DESCRIPTION OF THE PLAN**

The following description of the J.D. Eckman, Inc. (Plan Sponsor) Employee Benefit Welfare Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions, copies of which may be obtained from the Plan Sponsor.

***General***

The Plan provides health and other benefits to eligible employees of the Plan Sponsor. Salaried employees are eligible to participate in the Plan on the first day of the month following completion of 30 days of service, as defined by the Plan. Hourly employees are eligible to participate in the Plan on the first day of the month after completing a one-month waiting period that follows the first month of full-time employment, as defined by the Plan.

Certain Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

***Benefits***

The Plan provides health benefits (medical, dental, vision and prescription drugs), life insurance, short-term disability benefits, and accidental death and dismemberment benefits. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

***Insured Benefits***

The Plan fully insures the vision, basic life insurance, and basic accidental death and dismemberment benefits. Effective January 1, 2024, short-term disability benefits are fully insured. The Plan Sponsor purchases annual insurance contracts for these insured benefits. Premiums for these insured benefits for hourly employees are paid from the assets of the VEBA trust and for salaried employees are paid from the general assets of the Plan Sponsor.

***Stop Loss Coverage***

The Plan has entered into a stop loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

***Self-insured Benefits***

All other Plan benefits are self-insured. The claims for self-insured benefits (medical, dental, and prescription drugs) are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by either the Plan's VEBA trust or the general assets of the Plan Sponsor. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

***Contributions***

The Plan Sponsor makes contributions to the Plan as needed to fund claims and pay expenses in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Plan Sponsor on a pay-as-you-go basis.

Participant contributions to the Plan are limited to COBRA benefits. The Plan Sponsor makes contributions to the Plan for hourly employees based on a rate per hour worked from prevailing wage fringe benefits. The Plan Sponsor pays the full cost of benefits for salaried employees. Copayments and deductibles are paid directly by the Plan participants.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Benefits Committee determines the Plan's valuation policies and procedures and reports to the Plan Sponsor's Board of Directors. See note 4 for discussion of fair value measurements.

Interest income is recorded on the accrual basis.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The financial statements of the Plan have been prepared using the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

***Payment of Benefits***

Premiums paid by either the Plan Sponsor or the VEBA trust are recorded as insurance premiums paid in the accompanying statements of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processors. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statements of net assets available for benefits. Through December 31, 2023, short-term disability payments were processed through the Plan Sponsor's payroll system and paid from the Plan's VEBA trust. These payments were recorded as claims paid for benefits in the accompanying statements of changes in net assets available for benefits for the year ended December 31, 2023. Effective January 1, 2024, short-term disability benefits are fully insured and the premium payments are included in insurance premiums paid.

***Stop Loss***

Premiums for stop loss insurance are included in insurance premiums paid in the accompanying statements of changes in net assets available for benefits. Refunds due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid. Stop loss refunds totaling \$599,062 and \$588,206 have been netted with claims paid in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

***Refunds***

Refunds due from the Plan's PBM are recorded when earned. Pharmacy rebates totaling \$515,573 and \$378,573 have been netted with claims paid in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

***Subsequent Events***

Management has evaluated subsequent events through August 22, 2025, the date the financial statements were available to be issued.

**3. CLAIMS INCURRED BUT NOT REPORTED**

Plan obligations at December 31, 2024 and 2023, for claims incurred but not reported are estimated by the Plan's actuary in accordance with accepted actuarial principles, and the Plan Sponsor based on claims data provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment.

**4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, are described as follows:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2            Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**5. ADMINISTRATIVE EXPENSES**

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators, legal counsel, and its broker. These expenses are reported on the statements of changes in net assets available for benefits as administrative expenses.

**6. TAX STATUS**

The VEBA trust, funding certain benefits of the Plan, received an exemption letter from the Internal Revenue Service (IRS) dated July 17, 2017, stating that the trust is tax-exempt under the provisions of Section 501(c)9 of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 or 2023 for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right to modify the benefits provided to participants, the right to modify the contributions required of participants, the right to discontinue its contributions, and the right to terminate the Plan, subject to the provisions of ERISA. In the event the Plan terminates, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Plan Sponsor or be used for purposes other than for the exclusive benefit of the Plan's participants.

**8. PARTY IN INTEREST TRANSACTIONS**

The Plan has several arrangements with service providers as described in Notes 1 and 5. During the years ended December 31, 2024 and 2023, the Plan's interest-bearing cash was held by M&T Bank, the custodian of the Plan. These transactions are party in interest transactions under ERISA.

**9. RISKS AND UNCERTAINTIES**

The Plan maintains cash balances at financial institutions. The cash balances are secured by the Federal Deposit Insurance Corporation (FDIC) up to applicable FDIC limits. At times, the Plan's deposits may exceed insured limits.

The Plan Sponsor's estimate of benefit obligations is subject to certain assumptions that are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
