### Notes to Financial Statements

#### NOTE 1 DESCRIPTION OF THE PLAN

The following description of the United Way of Greater Cincinnati 403(b) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### ***General***

The Plan, established on January 1, 2006, is a defined contribution plan sponsored by the United Way of Greater Cincinnati for the benefit of employees working at least 20 hours a week or are expected to complete 1,000 working hours in a year. The Plan has no minimum age or service requirements for participation. The Plan is subject to the Employee Retirement Income Security Act of 1974 ("ERISA"). The plan was restated on April 19, 2022.

##### ***Contributions***

A participant may contribute up to 100% of eligible compensation on either a pre-tax or Roth after-tax basis. Contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,000 at December 31, 2024). For 2024, Section 414(v) of the Internal Revenue Code of 1986 as amended allowed a maximum catch-up contribution of \$7,500 for employees aged 50 and over. United Way of Greater Cincinnati ("the Company") makes matching contributions equal to 50% of the first 8% of eligible compensation a participant contributes to the Plan. The Company may also make discretionary contributions to the Plan based on various employee allocation groups that participants are a part of as of the last day of the plan year. The allocation groups are determined by the participant's age and years of service as of the last day of the plan year. The Company made no discretionary contributions in 2024 or 2023.

The participants designate the percentage of their total contribution to be invested in any of the Plan's investment funds on a pre-tax basis or Roth after-tax basis. Participants may change the percentage of contributions invested in each account and may make transfers between accounts anytime during the year. A participant may change the amount of his or her elective deferred contributions anytime.

##### ***Rollover Contributions***

Participants may rollover to the Plan a pre-tax distribution they receive from an eligible retirement plan if the distribution qualifies as a rollover amount under the Internal Revenue Service.

##### ***Participant Accounts***

Each participant's account is credited with the participant's and Company's contributions and a pro-rata allocation of the Plan's earnings. The pro-rata allocation is calculated daily based upon the proportion of individual account balances to total participants' account balances in the respective investment funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

### Notes to Financial Statements (Continued)

#### NOTE 1 DESCRIPTION OF THE PLAN (CONTINUED)

##### *Vesting*

Participants are vested immediately in their rollover contributions, pre-tax contributions and Roth after-tax contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contributions plus earnings thereon is based on continuous years of service as follows:

Effective August 15, 2024, vesting in the Company's matching and discretionary contributions plus earnings thereon is based on continuous years of service as follows:

As a result, unallocated forfeitures are \$5,813 and \$11,665 at December 31, 2024 and 2023. These accounts will be used to reduce future Plan expenses and employer contributions. Employer contributions were reduced by \$36,002 and \$59,547 in 2024 and 2023, respectively from these accounts. The Company used \$10,500 and \$12,350 to pay Plan administrative expenses in 2024, and 2023, respectively.

##### *Payment of Benefits*

Upon a participant's retirement, death, disability, termination of employment with the Company, or termination of the Plan, the participant's account is eligible for distribution in a lump sum or periodic installment payments. If a participant's vested interest is \$5,000 or less, distributions are paid in the form of a lump sum and the payment can be involuntarily distributed, payable as soon as administratively feasible. Effective January 1, 2024, if a participant's vested interest is \$7,000 or less, distributions are paid in the form of a lump sum and the payment can be involuntarily distributed, payable as soon as administratively feasible.

In-service distributions are permissible from all vested account balances for participants that have attained the age 59 ½, except to the extent a loan is secured thereby. Effective January 1, 2024, in-service distributions are permissible from all vested account balances for participants that are domestic abuse victims.

### Notes to Financial Statements (Continued)

#### NOTE 1 DESCRIPTION OF THE PLAN (CONTINUED)

##### *Payment of Benefits (Continued)*

In conditions of financial hardship, a participant may apply to the Plan administrator for approval to withdraw the portion of their elective deferrals and the vested portion of their match or profit sharing accounts necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

Upon termination of the Plan, the assets will be distributed to participants in accordance with the Plan's provisions and existing laws and regulations.

#### NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### *Administrative Expenses*

Certain plan expenses are paid by the Company and accordingly, are not reflected in the Plan's financial statements. Certain investment related expenses are included in net appreciation of fair value of investments.

##### *Basis of Accounting*

The financial statements of the Plan have been prepared under the accrual basis of accounting principles generally accepted in the United States of America ("GAAP").

##### *Investment Valuation and Income Recognition*

Investments are reported at fair value and are valued daily. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an ordinary transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Purchases and sales of securities are recorded on a trade-date basis. The cost of investments sold is computed on an average cost basis for all realized gains and losses. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### *Benefit Payments*

Benefit payments are recorded when paid.

#### NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

##### *Estimates*

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### *Subsequent Events*

The Company has evaluated subsequent events through July 29, 2025, which is the date these financial statements were available to be issued.

#### NOTE 3 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) *Accounting Standards Codification (“ASC”) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

The hierarchy is broken down into three levels based on the ability to observe inputs as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Money Market funds:* Valued based on the NAV of units of the money market fund as published by the custodian.

#### NOTE 3 FAIR VALUE MEASUREMENTS (CONTINUED)

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE 4 TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (the “Code”). The terms of the Plan have been prepared to conform with the sample language provided by the IRS in Revenue Procedure 2007-71. The Plan Sponsor intends to apply for a determination letter on the Plan once the IRS opens such a program. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for the plan participants under Section 403(b).

#### **NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.
