Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Umbra Cuscinetti, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

UMBRA CUSCINETTI, INC. 401(k) PLAN NOTES TO FINANCIAL STATEMENTS

NOTE 1 - DESCRIPTION OF THE PLAN:

Umbra Cuscinetti, Inc. 401(k) Plan (the Plan) is a contributory, defined contribution plan for the benefit of the employees of Umbra Cuscinetti, Inc. (the Company). The Plan, which was formed January 1, 1983, is administered by the Company, and the Plan assets are held in a trust by Ascensus Trust Company. The funds must be used for the exclusive benefit of Plan participants and their beneficiaries. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employees are generally eligible for participation in the Plan upon attainment of 21 years of age. Leased employees and non-resident alien employees are generally not eligible to participate in the Plan. Plan entry is the first day of the month after hire or after attainment of 21 years of age.

The Plan includes a 401(k) feature whereby eligible employees may contribute a portion of their compensation, as defined in the Plan, and subject to statutory limitations. The deferrals are pre-tax deferrals. Participants who have reached the age of 50 before the Plan year end may make catch-up contributions, subject to statutory limitations. Newly eligible employees are automatically enrolled at a 6% deferral rate, unless another rate is affirmatively elected by the eligible employee. The automatic enrollment rate is increased by 1% on the first day of each Plan year, until a deferral rate of 10% is achieved. Employee deferrals are generally funded with each pay period. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company makes matching contributions on employee deferrals of 50% of up to 6% of participant compensation. In addition, the Company may make a profit sharing contribution. To be eligible for the profit sharing contribution, if any, the employee must complete 501 hours of service in the Plan year and be employed on the last day of the Plan year. This requirement does not apply if the employee dies or terminates employment due to disability or after reaching normal retirement age. No profit sharing contribution was declared in respect of 2024 or 2023.

Each participant's account is credited with the participant's contribution, employer contributions and net plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. All investments of the Plan are participant-directed.

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Employer matching and profit sharing contributions vest over time, with 100% vesting achieved at 6 years of service. In addition, 100% vesting is achieved upon attaining normal retirement age, death or disability of the participant. Unvested benefits of terminated participants, if any, are forfeited and used to reduce future employer contributions or pay the Plan's administrative expenses.

NOTE 1 - Continued:

As of December 31, 2024 and 2023, the balance of forfeitures available to offset future fees or employer contributions was \$0 and \$30,364, respectively. For the year ended December 31, 2024, \$40,320 of forfeited amounts were applied to employer contributions.

Vested benefits are payable upon retirement, death, disability or termination of a participant. Normal retirement age is defined as age 65 by the Plan. In-service withdrawals of employee deferrals and rollovers are also permitted for participants in limited circumstances which include attaining age 59-1/2 or retirement age, extended military service and cases of hardship, as defined. Accounts of participants who terminate employment with balances less than \$5,000 are automatically rolled out of the Plan into an individual retirement account, unless another distribution option is selected by the participant.

Participants may borrow from their accounts a minimum of \$1,000 and a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans bear interest at the prime rate in effect at the loan date plus 1%. At December 31, 2024, loans bear interest at rates ranging from 6% to 9.25%. Principal and interest are paid through payroll deductions. If a participant with an outstanding loan balance terminates employment or otherwise ceases making payments on the loan, the balance is paid by recognition of a deemed distribution to the participant. No allowance for credit losses is recognized due to adequate collateralization of the loans.

The Company has the right to discontinue the Plan at any time. If the Plan is terminated, the participants will become fully vested in all account balances.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES:**Use of estimates-**

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan's Administrator to make estimates and assumptions that affect the reported amounts of assets and net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Accordingly, actual results could differ from those estimates.

Valuation of investments-

The Plan's investments are stated at fair value. See Note 4.

NOTE 2 - Continued:

Recognition of income and expenses-

The Plan records income and expenses on the accrual basis of accounting. In accordance with generally accepted accounting principles, benefits are recorded in the period paid. Purchases and sales of securities are recorded on a trade-date basis.

Net appreciation (depreciation) in fair value of investments represents the net increase (decrease) in the fair value of investments sold during the year or held at year-end over (1) the fair value of investments held at the prior year-end, or (2) the cost of investments acquired during the current year.

Certain administrative expenses are borne by the Plan. However, the Company provides services and support to the Plan with no associated compensation.

NOTE 3 - INFORMATION PREPARED AND CERTIFIED BY TRUSTEE:

The Plan administrator has obtained certification from the trustee, Ascensus Trust Company, that the following information furnished by the trustee and included in the financial statements and supplemental schedule of Assets (Held at End of Year) is complete and accurate:

1. Investments as of December 31, 2024 and 2023;
2. Participant loans as of December 31, 2024 and 2023; and,
3. Investment transactions, investment income and participant loan transactions for the year ended December 31, 2024.

NOTE 4 - FAIR VALUE MEASUREMENTS:

Fair value is a market-based measurement, determined based on assumptions that market participants would use in pricing an asset or liability. Under generally accepted accounting principles, there are three levels of inputs, which prioritize the inputs used in measuring fair value as follows:

- Level 1: Observable market inputs such as quoted prices (unadjusted) in active markets for identical assets or liabilities;
- Level 2: Observable market inputs, other than the quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3: Unobservable inputs where there is little or no market data, which require the reporting entity to develop its own assumptions.

NOTE 4 - Continued:

The inputs or methodology used for valuing investments is not necessarily an indication of the risk associated with investing in those securities. Further, use of different methodologies or assumptions to determine fair values could result in different fair value measurements at the reporting date.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are actively-traded, open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price.

Collective investment trust: Valued at the net asset value (“NAV”) of units held by the Plan at year end. The NAV, as provided by the trustee and custodian, is used as a practical expedient to estimate fair value. NAV is based on the fair value of the underlying investments owned by the fund, minus its liabilities, and then divided by the number of units outstanding. The NAV of a collective trust is calculated based on a compilation of primarily observable market information. The number of units of the trust that are outstanding on the calculation date is derived from observable purchase and redemptions activity in the trust.

NOTE 5 - FEDERAL INCOME TAXES:

The Plan trustees adopted a volume submitter plan effective August 1, 2021. A determination letter dated June 30, 2020 from the Internal Revenue Service has been obtained by the volume submitter plan sponsor that states that the form of the plan qualifies under section 401 of the Internal Revenue Code. Although the Plan has not received a determination letter specific to the Plan itself, it is the intent of the Company that by following the volume submitter plan, that the Plan be exempt from federal income taxes. The Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has concluded that as of December 31, 2024, the Plan has not taken any uncertain positions that would require recognition or disclosure. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS:

Ascensus Trust Company acts as trustee for investments of the Plan. Therefore, transactions with Ascensus Trust Company qualify as party-in-interest transactions.

NOTE 7 - OPERATIONAL ERRORS AND NONEXEMPT TRANSACTIONS:

The Plan has identified certain areas of noncompliance with its governing documents. These errors include lack of auto enrollment on new hires in 2023, and in 2024 and 2023, certain bonuses and other pay were improperly excluded from deferrals and match. The estimated corrections to the Plan have been accrued as of December 31, 2024 and 2023. Plan management has corrected the amounts pertaining to 2023, and is in process of fully correcting any 2024 errors, including lost earnings, to impacted participants. In addition, a Plan amendment was executed in 2024 to retroactively correct the definition of eligible compensation to conform to actual practice. Any penalties or fees associated with these corrections will be borne by the Company.

In 2022, a remittance to the Plan for one pay period was deemed to be late under the rules for timely remittance of deferrals and loan payments. The remittance was made in 2022 and lost earnings, were restored in 2024.

NOTE 8 - SUBSEQUENT EVENTS:

The Plan has evaluated subsequent events through July 28, 2025, the date which the financial statements were available to be issued.

Effective February 1, 2025, the automatic enrollment feature of the Plan is eliminated.
