Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Pronto 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Notes to Financial Statements

Note 1. Plan Description

The following description of the Pronto 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all employees of Pronto Finance, Inc., Pronto Auto, Inc. and Pronto Insurance Services, Inc. (collectively, the Company) who are 18 years of age or older and have worked for the Company for 90 days. Eligible employees are able to begin participating in the Plan the first day of the month on or after eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: The Plan is designed as a qualified cash deferred arrangement pursuant to Section 401(k) of the Internal Revenue Code (IRC) and provides for the following contributions:

Participant contributions: Eligible employees are automatically enrolled in the Plan at a deferral rate of 6% unless they choose a different percentage, or to opt out of participation in the Plan. Employees are automatically enrolled in an annual 1% increase in contribution deferral rate until it reaches a maximum of 16% of compensation unless the participant elects otherwise. Each year, participants may contribute up to 100% of total pretax or after-tax compensation, as defined in the Plan, not to exceed certain IRC limitations, which was \$23,000 for 2024. Participants who have attained age 50 before the Plan's year-end are eligible to make catch-up contributions of up to \$7,500. Participants may change their salary deferral election as of the beginning of each payroll period.

Rollover contributions: A participant may also contribute amounts disbursed or transferred from another qualified plan.

Company contributions: The Plan has elected to maintain "safe harbor" status, in which the Company is required to make a safe harbor matching contribution equal to 100% of employee salary deferrals that do not exceed 3% of employee compensation plus 50% of employee salary deferrals between 3% and 5% of employee compensation. The safe harbor matching contribution is calculated on a payroll period basis.

The Company, at its sole discretion, may make an annual discretionary contribution. Participants must be an active participant in the Plan at year-end in order to receive the discretionary contribution. Such contributions, if any, are limited to the maximum amount permitted under the requirements of the IRC. During 2024, the Company made \$198,415 in safe harbor matching contributions and \$0 in discretionary contributions.

Participant accounts: Participants' accounts are credited with the participants' contributions and rollover contributions, Company safe harbor matching contributions and discretionary contributions, if any, Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the amount that can be provided from the participant's vested account.

Investment options: Upon enrollment in the Plan, a participant may direct participant and Company contributions, if any, into various investment options offered by the Plan. Participants may change their investment options daily, subject to certain limitations. The Company's safe harbor matching contributions and discretionary contributions, if any, are allocated in the same manner as the participant's elective contributions.

Notes to Financial Statements

Note 1. Plan Description (Continued)

Vesting: Participants are immediately vested in their contributions, Company safe harbor matching contributions and rollover contributions plus actual earnings thereon. Participants are 33.33% vested in the Company's discretionary contributions plus actual earnings thereon after one year of credited service, 66.67% after two years of credited service and fully vested after three years of credited service. Participants are automatically fully vested upon normal retirement, death, permanent disability or termination of the Plan.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding loan balance during the prior 12-month period. Only one loan may be outstanding at any point in time. Note terms are limited to five years. Upon termination of employment, the entire outstanding principal and accrued interest shall be immediately due and payable. However, within 60 days of termination of employment, the participant may request that the Plan Administrator rollover a participant loan to a new employer's retirement plan, if allowed. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 5.25% to 10.50% and maturing through October 31, 2029, as of December 31, 2024, which are commensurate with local prevailing rates at note origination, as determined by the Plan Administrator. Principal and interest are paid ratably through bimonthly payroll deductions.

Payment of benefits: A distribution can be made to a participant upon request due to disability, retirement or termination of employment. A participant's beneficiary or beneficiaries may request a distribution of any vested account balance in the event of the participant's death. Distributions may be deferred until a later date. However, distributions cannot be postponed on any vested account balance that is \$5,000 or less in which case the Plan Administrator will direct the custodian that any amount exceeding \$1,000 be distributed to an individual retirement account (IRA) or annuity for the participant's benefit. Any vested account balance that is \$1,000 or less will be distributed as a lump-sum distribution. Prior to such distribution, a participant still has the right to request that the amount be distributed directly to the participant in the form of a lump-sum payment or to request that it be rolled over to a different IRA provider or another retirement plan eligible to receive rollover contributions. Additionally, the Plan provides in-service distributions related to hardships and obtaining age 59½.

Forfeited accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and there were no forfeitures used during the year ended December 31, 2024. Forfeitures, if any, may at the Company's discretion, be applied to cover the Plan's administrative expenses or to reduce future Company contributions.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Accounting policies: The Plan follows accounting principles generally accepted in the United States of America (U.S. GAAP), as established by the Financial Accounting Standards Board (FASB), to ensure consistent reporting of financial condition.

Use of estimates: The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Note 2. Summary of Significant Accounting Policies (Continued)

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Those in the Plan's governance determine the Plan's valuation policies utilizing information provided by the Plan's custodian. See Note 4 for a detailed discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions: Contributions from the Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivables from participants are recorded as distributions based upon the terms of the plan document. No loans were deemed uncollectible as of December 31, 2024 and 2023.

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan's provisions. Investment-related expenses of the Plan are paid by the Plan as provided in the plan document and are included in net appreciation in fair value of investments in the statement of changes in net assets available for benefits. All other significant costs related to plan administration and professional services are paid by the Company and excluded from these financial statements.

Note 3. Information Certified or Provided by Principal Trust Company

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and income information for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule derived from information certified or provided by Principal Trust Company (the custodian and a party-in-interest) and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodian that the information provided to the Plan Administrator by the custodian related to the following assets and income are complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets:

Principal Trust Company also certified the completeness and accuracy of \$624,479 of net appreciation in fair value of investments, \$69,382 of dividends as well as \$15,699 of interest income on notes receivable from participants for the year ended December 31, 2024.

Note 4. Fair Value of Financial Instruments

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured on a recurring basis at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Shares of registered investment companies: Valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Units of common/collective trust: Valued based on the NAV of units of the common/collective trust. The NAV, as provided by the custodian, is used as a practical expedient in estimating fair value. The NAV is based on the fair value of the underlying investments comprising the trust, less its liabilities. The practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

Note 5. Related-Party/Party-in-Interest Transactions

Certain plan investments are shares of a common/collective trust fund managed by Principal Funds, Inc. Principal Funds, Inc. is an affiliate of Principal Trust Company, which is the custodian of the Plan and third-party administrator and, therefore, these transactions qualify as party-in-interest transactions.

The Plan made a direct payment to an affiliate of the custodian of the Plan, the recordkeeper, of \$48,437 during the year ended December 31, 2024.

Certain employees of the Company are performing services for the Plan and are not reimbursed for their services from the Plan. Certain other expense of the Plan are paid by the Plan Sponsor.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Note 7. Tax Status

Effective June 30, 2020, the Plan adopted a nonstandardized form of a prototype plan sponsored by Principal Life Insurance Company. The prototype plan provider has received an opinion letter from the Internal Revenue Service as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by the Plan. The Plan has been amended since the receipt of this opinion letter; however, the Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that through December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
