**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about ASIC North 401(K) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**(1) Description of Plan**

The following description of the ASIC North 401(K) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

- (a) General – The Plan was established January 1, 2015 as a defined contribution plan covering all eligible employees of ASIC North, Inc. (the “Company”). Employees must attain the age of 21 to participate and will be eligible to make salary deferrals on the first day of the month on or after the day they have met the age requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- (b) Employee Contributions – Participants may contribute up to 100% of eligible compensation as defined in the Plan, limited to a maximum amount as set by the Internal Revenue Service (IRS). These contributions may be pre-tax or after-tax Roth contributions. Participants are automatically enrolled in the Plan at 3% once they have met the eligibility requirements, unless they opt out. Participants who have attained the age of 50 before the end of the year may contribute additional catch-up amounts as set by the IRS. Participants may also contribute amounts representing rollovers from other qualified plans.
- (c) Employer Contributions – Participants are also eligible for safe harbor and profit-sharing contributions. These contributions are based on eligible compensation. The Company makes a safe harbor contribution of 3% and profit-sharing contribution of 7%. These contributions are allocated to participant accounts each payroll period.
- (d) Vesting – Participants are 100% vested in their accounts at all times.
- (e) Payment of Benefits – Upon termination of service due to death, disability, or retirement, a participant may elect to receive distributions equal to the value of the participant’s account balance. The participant may choose either a lump sum distribution or partial payments. If a participant’s vested balance is less than \$5,000, it is mandatory that the benefits be distributed from the Plan.

Hardship distributions are permitted under the Plan. The amount may not exceed the pre-tax, Roth, and profit-sharing deferrals. Participants may take in-service distributions of their pre-tax, Roth, and profit-sharing deferrals once they reach the age of 59½. Participants can also withdraw rollover contributions at any time.

- (f) Participant Accounts – Each participant's account is credited with the participant's contribution, allocations of the Company's contributions, and Plan earnings. Earnings are allocated to participant accounts based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from their vested account. Each participant determines the investment strategy of their account as provided by the Plan.

- (g) Notes Receivable – Participants are permitted to have 2 outstanding loans at any time. Participants may borrow from their fund accounts, less Roth deferrals, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Participants may only take loans from those accounts invested in mutual funds. The loans are secured by the balance in the participant’s account and bear interest at the prime rate as specified in the Wall Street Journal.
- (h) Administrative Expenses – Certain investment and administrative expenses regarding distributions and loans are charged to participant accounts or deducted from check proceeds. The remaining administrative expenses are generally paid by the Plan.
- (i) Plan Termination – Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination and payment of all expenses, the assets of the Plan would be distributed to participants based upon amounts outstanding in their account as of the date of liquidation. Additionally, the Company may amend the Plan at any time without the consent of any participant or beneficiary, provided that no amendment deprives any participant of the participant’s accrued benefit.

**(2) Summary of Significant Accounting Policies**

- (a) Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.
- (b) Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.
- (c) Investment Valuation and Income Recognition – Plan investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.
- (d) Benefit Payments – Benefits are recorded when paid.
- (e) Notes Receivable – Participants may borrow any amount from \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their total vested account balance, as defined in the Plan. A participant may have no more than 2 loans outstanding at any time. The interest rate is based on the prime rate of interest published by the Wall Street Journal.

- (f) Subsequent Events – The Plan has evaluated subsequent events through August 8, 2025, the date the Plan’s financial statements were available to be issued.

**(3) Information Certified by the Plan’s Trustee**

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus, LLC, the trustee of the Plan, has certified to the completeness and accuracy the investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the schedule of assets held for investment purposes as of December 31, 2024, and the related investment activity reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

**(4) Income Tax Status**

The Internal Revenue Services (IRS) has determined and informed the Company by a letter dated January 1, 2018, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**(5) Related Parties**

The Plan has a number of service providers. Such parties are considered parties-in-interest under ERISA.

**(6) Withdrawing Participants**

All participants who have withdrawn from the Plan and requested their benefits have been paid as of December 31, 2024.

**(7) Fair Value Measurements**

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

*Mutual funds, money market funds, and self-directed brokerage accounts:* Valued at the closing price reported on the active market on which the individual securities are traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
