### NOTES TO FINANCIAL STATEMENTS

#### **NOTE A - Description of Plan**

The following description of Townsquare Media, Inc. 401k Plan, (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan was established on January 1, 1997, and is a defined contribution plan covering all employees (other than nonresident aliens, aliens temporarily residing in the United States, and employees who are clerks, interns, co-op students or employed for the sole purpose of completing a specified project of limited duration) of Townsquare Media, Inc. (the "Company") (formerly Regent Communications, Inc.) and its affiliates. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### **Eligibility**

A full-time employee is eligible to participate in the Plan upon attainment of age 21 and upon completing at least two months of service. A part-time employee is eligible to participate in the Plan upon attainment of age 21 and upon working 1,000 hours in a calendar year.

#### **Contributions**

Eligible participants may elect to have a percentage of their pretax annual compensation, as defined in the Plan, contributed to the Plan, subject to Internal Revenue Service ("IRS") limits. Employees who are age 50 or over may make a catch-up contribution of up to \$7,500 in 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Effective August 1, 2024 the Plan allows for in-plan Roth rollover contributions and in-plan Roth conversions subject to the provisions of the plan document and related amendment.

Effective April 1, 2018, the Company implemented an employer match of twenty-five cents per dollar of participant contributions, up to a maximum of 4% of compensation. Effective April 1, 2020, the Company suspended employer-matching contributions to the Plan. Effective January 1, 2022, the Company reinstated employer-matching contributions to the Plan. The Company may, at its discretion, make additional contributions to the Plan. The Company did not make a discretionary contribution in 2024.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, (b) Plan earnings and (c) certain administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants may change their investment allocation elections daily and may change their contribution percentage on a monthly basis.

**Notes Receivable from Participants**

Participants who are actively employed may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants pay all loan fees and interest on loans. The notes receivable from participants bear interest at prevailing rates charged by banks for loans that would be made under similar circumstances (4.25% to 9.50% at December 31, 2024). Principal and interest are paid ratably through payroll deductions. Generally, notes receivable from participants must be repaid within five years. However, employee borrowing used to acquire a primary residence must be repaid within ten years.

**Payment of Benefits**

Distribution of a participant's vested account balance is made in one lump-sum payment to the participant, or the participant's beneficiary, upon termination of employment, permanent disability, or death. Participant accounts that are vested and less than or equal to \$1,000 will be automatically distributed to the participant or the participant's beneficiary. Participants whose accounts are vested and have a balance greater than \$1,000, but less than or equal to \$5,000, must elect in writing whether to receive the distribution directly or have it paid directly to an eligible retirement plan of their choice. If no written election is made, the plan administrator will distribute the

##### **Payment of Benefits (Continued)**

funds in a direct rollover to an individual retirement plan of its choice. Participant accounts in excess of \$5,000 will not be distributed to the participant before they attain age 65 without the written consent of the participant. Participants may apply for hardship withdrawals, subject to approval by the plan administrator. The contributions and earnings are taxable to the participants subject to certain exceptions upon withdrawal from the Plan.

##### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$57,959 and \$50,719, respectively. During the year ended December 31, 2024, approximately \$50,000 was used to reduce employer contributions. These accounts may be used to reduce future employer contributions or may be used to pay administrative expenses of the Plan.

#### **NOTE B - Summary of Significant Accounting Policies**

##### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

##### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make certain estimates and assumptions that affect the reported assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are treated as distributions based on the terms of the Plan documents.

##### **Excess Contribution Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding charge to corrective distributions in the statement of changes in net assets available for benefits. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

#### **NOTE B - Summary of Significant Accounting Policies (Continued)**

##### **Valuation of Investments and Income Recognition**

Investments are reported at fair value. The shares of registered investment companies are valued at quoted market prices, which represent the net asset values (“NAVs”) of shares held by the Plan at year-end. The Plan invests in the Fidelity Managed Income Portfolio (“MIP”) stable value common collective trust fund. The Plan’s interest in the MIP is valued at the NAV practical expedient of the underlying investments reported by the issuer of the common collective trust at year-end. This practical expedient would not be used if it is determined to be probable that the Plan will sell the investment for an amount different from reported net asset value. The underlying assets owned by the MIP consist primarily of readily marketable fixed income securities. Securities traded on a national securities exchange are valued at the last reported sales price on the last business day of the Plan year. See Note C for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

##### **Administrative Costs**

Certain Plan expenses are deducted from participants’ accounts or investment income, and the remainder of Plan expenses are paid by the Company.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Subsequent Events**

The Plan has considered subsequent events occurring through August 12, 2025, the date the financial statements were available for issuance, in evaluating its estimates and in the preparation of its financial statements.

#### **NOTE C - Fair Value Measurements**

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets. Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

All transfers between fair value hierarchy levels are recognized by the Plan at the end of each reporting period. There were no significant transfers between Levels 1, 2, and 3 during the year.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Money market fund: The carrying amount approximates fair value because the instrument is liquid in nature.

Stable value fund: Valued based on the net asset value ("NAV") of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value.

Mutual funds (registered investment companies): Fair values are based on unadjusted quoted prices in active markets for identical assets or liabilities.

Level 1 assets primarily include exchange-traded equity securities, mutual funds and U.S. Treasury Bonds. Prices are obtained from readily available sources for market transactions involving identical assets or liabilities and are classified as Level 1 investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes that its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

This investment is measured at fair value using the net asset value per share practical expedient as of December 31, 2024 and 2023. There are no participant redemption restrictions for these investments; the redemption frequency is daily and the notice period is one day.

The stable value fund objective is to seek the preservation of capital and to provide a competitive level of income over time that is consistent with the preservation of capital. The fund invests in assets (typically fixed-income securities or bond funds and may include derivative instruments such as futures contracts and swap agreements), enters into "wrap" contracts issued by third-parties, and invests in cash equivalents represented by shares in money market funds.

#### **NOTE F - Related Party and Party-In-Interest Transactions**

Certain investments of the Plan are shares of mutual funds offered through Fidelity. Fidelity is the custodian, as defined by the Plan, and therefore qualifies as a permitted party-in-interest, as defined by ERISA. However, these party-in-interest transactions are exempt from the prohibited transactions rules under ERISA. The fair value of such investments aggregated \$36,775,358 and \$32,658,475 as of December 31, 2024 and 2023, respectively. Fees paid by the Plan for investment management services are netted against net appreciation in fair value of investments.

#### **NOTE G - Termination of Plan**

Although the Company has not expressed any intent to do so, the Company reserves the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### **NOTE H - Tax Status**

The Plan is a prototype plan designed by Fidelity. The Plan received an opinion letter from the IRS, dated March 31, 2014, which states that the Plan document satisfies the applicable provisions of the Internal Revenue Code ("IRC"). The Plan has been most recently amended effective September 1, 2018; however, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Further, the Plan's management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

#### **NOTE I - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
