For information included in the supplemental information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Note 1 – Plan Description

The following description of the TxE Energy Investments, LLC 401k Plan (the “Plan”) provides only general information. TxE Energy Investments, LLC (“TXEX Energy”) is the Plan Sponsor. Participants should refer to the Plan Agreement or Summary Plan Description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution 401(k) plan that provides retirement savings benefits to eligible employees of TxE Energy Investments, LLC; TexEx Energy Operating, LLC; Spark Energy, LLC; Spark Energy Gas, LLC; Ideal Interaction, LP; NuDevco Midstream Development, LLC; Retailco Services, LLC; Fuelco Energy, LLC; Xcaliber Logistics, LLC; Verde Energy USA Inc.; National Gas & Electric, LLC; Biztel, LLC; and Major Energy Services, LLC (collectively, the “Company” or “Employer”). Effective March 17, 2022, the Plan was amended to allow employees of the following related employers to participate in the Plan: Bridgeco Financial, LLC; Flipco Financial, LLC; and Via Energy Solutions. Effective April 8, 2023, the Plan was amended to allow employees of the following related employers to participate in the Plan: Homeco Partners, LLC; Loanco Financial, LLC; and NatWireless, LLC. The Plan commenced effective January 1, 2001, and was amended on May 19, 2022, to comply with current law. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”).

Plan Custodian and Trustee

Fidelity Management Trust Company (“Fidelity,” “Trustee,” or “Custodian”) is the Plan Trustee and Custodian. Fidelity maintains custody of all investments held by the Plan, maintains the Plan’s participant account balances, and provides recordkeeping services to the Plan. Among other duties, Fidelity receives contributions, holds and invests fund assets in accordance with the directions of participants, and makes distributions as directed by the Employer.

Eligibility and Plan Entrance Date

All employees, except those under collective bargaining agreements, nonresident aliens who receive no United States source income, and leased employees, are eligible to participate in the Plan after the employee has reached 18 years of age. Eligible employees are permitted to enter the Plan on the first day of each month after satisfying the eligibility requirement.

Contributions

Participants may elect to contribute, on a before-tax or Roth basis, up to 90% of their eligible compensation as defined by the Plan, subject to the annual deferral limit established by the IRC, which was \$23,000 for 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to the maximum amount allowed annually by the IRC, which was \$7,500 for 2024.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation. The Plan also includes an automatic escalation feature where participants with a deferral rate greater than 0% have their deferral rate increased by 1% annually until their deferral rate reaches 6%, unless the participant elects otherwise.

Participants may contribute amounts representing distributions from other qualified benefit or defined contribution plans (“rollovers”).

Note 1 – Plan Description (continued)

Contributions (continued)

During the year ended December 31, 2024, in connection with the qualified automatic contribution arrangements (“QACA”), the Employer made QACA Safe Harbor Employer matching contributions in an amount equal to 100% of a participant’s elective deferral contributions, up to 4% of the participant’s eligible compensation as defined by the Plan. The Plan uses a year-end “true up” matching contribution feature to allow participants to receive the maximum matching contribution available by making up any loss in matching contributions resulting from the participant’s individual savings strategies. The provisions of the Plan also permit discretionary qualified nonelective contributions for non-highly compensated participants. There were no such contributions made in 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, Employer contributions, and an allocation of Plan earnings, and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Separate investment accounts are maintained for each participant for all contributions, and balances are invested among investment options as directed by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participant-Directed Investments

All assets of the Plan are participant-directed investments. The Plan has selected various investment options, as more fully described in the Plan Document, to which participants may designate the allocation of their account balances. Participants may direct their account balances to one or more of these investment options, which vary in types of investments, rates of return, and investment risk.

Vesting

Participants are always vested immediately in their own deferred contributions, rollover contributions, and Safe Harbor Profit-Sharing contributions, as well as any income or loss thereon. Additionally, participants immediately become 100% vested in any unvested Employer contributions, plus income or loss thereon, upon death, disability, or retirement.

Effective January 1, 2010, the vesting schedule for discretionary Employer matching contributions and nonelective Employer contributions, plus earnings thereon, are as follows:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Participants may have only one outstanding loan at any point in time. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above Prime, as defined. Principal and interest are paid ratably through bi-weekly payroll deductions and are due in equal installments not less frequently than quarterly.

Payment of Benefits

Upon separation of service due to death, disability, retirement, or termination of employment, a participant with a vested account balance greater than \$5,000 may elect to receive a lump sum distribution or installment payments equal to the value of the participant's vested account balance, or to maintain their balance within the Plan. A separate participant with a vested account balance equal to or less than \$5,000 receives a lump sum distribution of their vested account balance as soon as administratively possible following the participant's separation. Unless directed otherwise by the separated participant, the Employer transfers the vested account balance to an individual retirement account if such balance is at least \$1,000 but not more than \$5,000.

A participant may withdraw all or a portion of their rollover contributions in the event of financial hardship, as defined by the Plan. Additionally, in-service withdrawals are permitted upon attainment of age 59 ½.

Forfeitures

Forfeited nonvested accounts are used to reduce future Employer contributions and pay Plan administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$289 and \$222, respectively. During the year ended December 31, 2024, forfeitures of \$114,608 were used to reduce Employer contributions and \$24,216 were used to pay administrative expenses.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit loss has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan Agreement.

Note 2 – Summary of Significant Accounting Policies (continued)

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses incurred by maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

- **Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- **Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** – Inputs in the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- **Mutual Funds** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and classified within level 1 of the valuation hierarchy.
- **Money Market Fund** – Valued at cost, which approximates fair value and is classified within level 1 of the valuation hierarchy.

Note 5 – Related Party and Party-in-Interest Transactions

Plan investments are shares of mutual funds and a money market fund managed by the Trustee; therefore, these transactions qualify as party-in-interest transactions as defined by ERISA. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to service providers.

Note 5 – Related Party and Party-in-Interest Transactions (continued)

The Plan has notes receivable from participants as of December 31, 2024 and 2023. These receivables and all related transactions qualify as party-in-interest transactions and are exempt from being prohibited by ERISA.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

Note 7 – Tax Status

The Plan adopted a non-standardized, preapproved profit-sharing plan sponsored by FMR, LLC. The Internal Revenue Service (“IRS”) has determined and informed FMR, LLC, by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has not filed individually with the IRS for a letter regarding the Plan’s qualified tax status; however, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. As such, the Plan Administrator believes that the Plan is qualified and the related trust is tax-exempt, and no provision for income taxes has been included in the Plan’s financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
