For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### **1. Description of Plan**

The following description of the B&P Littleford, LLC 401k Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a contributory, defined contribution plan with a 401k elective deferral arrangement, which covers substantially all employees of B&P Littleford, LLC (Company). The Plan was formed and became effective on April 21, 1995. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Eligibility**

Employees that are age 18 and over are eligible to participate in the Plan immediately upon hire. Non-resident alien employees are excluded from the Plan. Eligible participants are automatically enrolled upon hire to contribute 3% of eligible compensation during the first year, increasing by 1% annually up to the maximum automatic rate of 6%.

#### **Contributions**

The Plan allows participants to defer up to a maximum of 50% of their compensation, not to exceed the maximum contribution allowable by the Internal Revenue Code (IRC) adjusted annually for cost-of-living changes. There is no minimum elective deferral limit for the Plan. Rollover contributions are allowed by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions. The Company contributes employer safe harbor matching contributions of 100% of deferrals of the first 1% of the participant's compensation, plus 50% of deferrals over 1%, not to exceed 6% of the participant's compensation remitted on a quarterly basis. Profit sharing is at the discretion of the Company and is based on a pro rata ratio of each eligible participant's compensation. No profit-sharing contributions were made in 2024 or 2023.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The participant has the responsibility to decide how his or her contribution will be invested. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **1. Description of Plan (continued)**

##### **Vesting**

Participants are immediately vested in their voluntary contributions and rollover contributions plus actual earnings thereon. Participants are 100% vested in safe harbor matching contributions after attaining two or more years of service.

##### **Payment of Benefits**

Plan participants are eligible to receive distributions upon reaching retirement age of 65. Participants are eligible to make in-service withdrawals upon reaching age 59 ½. Hardship withdrawals are allowed to pay certain qualifying expenses as defined in the Plan document. In addition, upon separation of employment, because of death, disability, or for other reasons, participants receive their benefits as a lump-sum payment.

##### **Forfeited Accounts**

Forfeitures of employer contributions shall be used to reduce the employer's matching contributions or reduce administrative expenses under the Plan. Forfeitures that have not been used to reduce employer contributions or pay administrative expenses are allocated to participants as defined by the Plan document. As of December 31, 2024, forfeited nonvested accounts totaled \$7,688 (\$2,988 as of December 31, 2023). During 2024, employer contributions were reduced by \$988 from forfeited nonvested accounts (\$2,934 in 2023), with the remaining balance allocated to participants.

##### **Administrative Expenses**

Certain administrative expenses were paid for by the Company. Additionally, certain administrative expenses were paid by the Plan and are reflected in the accompanying financial statements.

##### **Notes Receivable from Participants**

Participants are permitted to borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. Such loans are secured by the balance of the participant's account and shall be charged an annual prevailing rate of interest to be fixed by the Plan administrators. Such loans shall be fully repaid on or before five years from the date of disbursement.

### **2. Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon terms in the Plan's loan policy.

#### **Subsequent Events**

Subsequent events have been evaluated through July 30, 2025, which is the date the financial statements were available to be issued.

#### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrators to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### **Fair Value Measurements**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan utilizes valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs. Based on the observability of the inputs used in the valuation techniques, the Plan is required to provide information according to the fair value hierarchy.

The fair value hierarchy ranks the quality and reliability of the information used to determine fair values.

## **2. Summary of Significant Accounting Policies (continued)**

### **Fair Value Measurements (continued)**

Financial assets and liabilities carried at fair value will be classified and disclosed in one of the following three categories:

Level 1 – Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2 – Significant other observable inputs other than Level 1 prices, such as quoted prices for similar assets and liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3 – Significant unobservable inputs that reflect an entity's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In determining the appropriate levels, the Plan performs a detailed analysis of the assets and liabilities. At each reporting period, all assets and liabilities for which the fair value measurement is based on significant unobservable inputs are classified as Level 3.

For the years ended December 31, 2024 and 2023, the application of valuation techniques applied to similar assets and liabilities has been consistent.

### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair market value. Shares of mutual funds are valued at quoted market prices in an active market, which represents the value of shares held by the Plan at year end. The pooled separate accounts and common collective trusts, except the stable value fund, are valued at fair value based on the net asset value (NAV). The stable value fund (included in common collective trusts in the statements of net assets available for benefits) is stated at estimated fair value based on the NAV of the participation units in the fund as a practical expedient. There are no lock-up periods, redemption restrictions, or unfunded commitments associated with the investments, including the stable value fund. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

The change in aggregate fair value and the cost of investments purchased, sold, and held is reflected in the statements of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments.

### **Payment of Benefits**

Benefits are recorded when paid.

#### 3. Financial Data Certified by the Trustee – Unaudited

The Plan’s financial information and data was certified by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company and Principal Life Insurance Company (collectively Principal) in accordance with Section 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the investment balances, interest, dividends, and net appreciation (depreciation) in fair value of investments included in the financial statements and supplemental schedule of assets (held at end of year) were obtained from data that has been prepared and certified as complete and accurate by the trustee. This certified information has not been audited by independent auditors.

#### 4. Fair Value Measurements

#### **5. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. At termination, participant accounts would become fully vested.

#### **6. Income Tax Status**

The Plan utilizes a volume submitter plan adopted through Principal. The volume submitter plan obtained its latest determination letter as of June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended or restated since receiving the determination letter, the Plan administrators believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Accordingly, no provision for income tax is included in the accompanying financial statements.

Generally, tax years 2021 through current year remain open to examination. The Plan does not believe that the results from any examination of these open years would have a material adverse effect on the Plan.

#### **7. Party-in-Interest Transactions**

Certain investments are managed by Principal (the Plan's trustee and recordkeeper) or affiliates of Principal, therefore qualifying as a party-in-interest. Fees of \$22,130 were paid to Principal during 2024 (\$20,305 during 2023). Wilshire Associates, Inc. is also a party-in-interest as they serve as investment advisors to the Plan. Notes receivable from participants are also considered party-in-interest transactions. The auditor is also considered a party-in-interest for audit services provided to the Plan.

#### **8. Risk and Uncertainties**

The Plan invests in various investment securities. These investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near-term and long-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
