## *Independent Auditor's Report*

To the Concentrix CVG Employee Benefits Committee  
Concentrix Retirement and Savings Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have audited the accompanying financial statements of Concentrix Retirement and Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### **Opinion**

### ***Basis for Opinion***

**CONCENTRIX RETIREMENT AND SAVINGS PLAN  
NOTES TO FINANCIAL STATEMENTS  
DECEMBER 31, 2024 AND 2023**

**1. Plan description**

The following description of the Concentrix Retirement and Savings Plan provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan's provisions.

Through October 2018, the Convergys Corporation Retirement and Savings Plan (the former plan) was sponsored by Convergys Corporation ("Convergys"). In October 2018, Convergys was acquired by Concentrix Corporation ("we", the "Company" or "Concentrix"), a wholly-owned subsidiary of SYNEX Corporation ("former parent" or "SYNEX"). In connection with the acquisition, Concentrix became the former plan sponsor and was renamed Concentrix CVG Corporation (the "Company" or "Plan Sponsor").

In December 2021, Concentrix completed its acquisition of ProKarma Holdings Inc. ("PK"). Effective January 2023, and in connection with the acquisition, PK employees previously covered under the ProKarma, Inc. 401(k) Plan ("PK plan") became eligible to participate in the Plan.

In July 2022, Concentrix completed its acquisition of ServiceSource International, Inc. ("ServiceSource"). Effective January 2023, and in connection with the acquisition, ServiceSource employees previously covered under the ServiceSource 401(k) Profit Sharing Plan & Trust became eligible to participate in the Plan.

In September 2023, Concentrix completed its acquisition of Marnix Lux SA ("Webhelp"). Effective January 2024, and in connection with the acquisition, Webhelp employees previously covered under the TriNet 401(k) Plan became eligible to participate in the Plan. In April 2024, \$6,940,105 of assets held by these employees under the TriNet 401(k) Plan were transferred into the Plan.

We intend to formally amend, as applicable, the Plan Agreement to incorporate certain provisions implemented under the Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE Act), the SECURE Act 2.0 of 2022, and/ or the Coronavirus Aid, Relief and Economic Security Act of 2020 (CARES Act) prior to the applicable due date as set forth under each Act. The Plan's management is currently evaluating the impact of the SECURE Act 2.0 which was signed into law on December 29, 2022, and included several mandatory and optional provisions with various effective dates over the next several Plan years.

General

The Plan is a defined contribution plan available to all eligible employees who are twenty-one years of age or older of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Company's Employee Benefits Committee (the Committee) is responsible for the general administration of the Plan. Fidelity Management Trust Company (FMTC) is the trustee of and recordkeeper for the Plan.

Contributions

Each year, participants may contribute a percentage of their annual compensation on a pre-tax or after-tax basis, as defined in the Plan and set by the Committee. Participants may also rollover qualified distributions from other defined benefit or defined contribution plans. Each participant has the discretion to invest their contributions in a variety of mutual funds and collective trust funds offered

under the standard investment plan and can change their investment elections on a daily basis. Participants also have the option to create a self-directed brokerage account and invest their contributions in securities not offered under the standard investment plan. The self-directed brokerage account allows plan participants to invest in a wide array of securities, mainly registered investment companies and common stock, beyond those offered under the standard plan offering. The Company contributes an employer match equal to 100% of the first 3% and 50% of the next 2% of eligible compensation deferred by the participant, provided that the participant has completed at least 1,000 hours of service during the 12-month period beginning on the date of first employment with the Company. The matching contributions are invested in the same manner as participant contributions and are designed to comply with the safe harbor design under Section 401(K)(12) of the Internal Revenue Code (the Code or the IRC).

Participants age 50 and older (and those who will turn age 50 by December 31 of a given plan year) may take advantage of catch up contributions under the Code by saving an additional 1% to 50% of pay, subject to Code limits.

#### Participant accounts

Each participant's account is credited with the participant's contributions and the matching Company contributions and allocations of plan earnings and administrative expenses. Allocations of plan earnings and administrative expenses are based on participant earnings or account balances, as set forth in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Participants are vested immediately in the matching contributions made by the Plan Sponsor plus actual earnings thereon.

#### Notes receivable from participants

Participants may borrow from their accounts up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at the prime lending rate plus 1% at the time the loan is initiated. Loans generally must be repaid within five years, unless the participant ceases to be an employee of a Company, at which point any outstanding loan becomes immediately due and payable.

#### Administrative expenses

Certain costs and expenses of administering the Plan are paid by the Company except for fees paid to the investment managers from their respective funds and certain fees paid directly by the participants.

#### Forfeited accounts

Participant forfeitures of amounts not vested are used to offset the Company's contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,015,245 and \$1,346,575, respectively. During 2024, \$782,296 in forfeitures were used to offset Company contributions to the Plan.

### Plan termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

### Payment of benefits

Distribution of a participant's vested account balance is made in one lump-sum payment to the participant, or to their beneficiary, upon termination of employment, permanent disability, or death. Participant accounts that are vested and in excess of \$7,000 will not be distributed to the participant before they attain age 73 without the written consent of the participant. Participants may apply for hardship withdrawals, subject to approval by the plan administrator. Contributions and earnings are taxable to the participants, subject to certain exceptions, upon withdrawal from the Plan.

### Company Stock Fund

Prior to Convergys being acquired by Concentrix in October 2018, participants were able to invest in Convergys common stock through the Plan's Convergys Corporation shared fund (Company Stock Fund). Participants could invest in Convergys common stock by directing a portion of their contributions or by rebalancing their account balance.

In connection with the October 2018 acquisition, the Convergys common stock held by the Plan was exchanged for a combination of cash and common stock of SYNEX. The cash proceeds were reallocated to participants and invested in age-appropriate target retirement funds. The SYNEX common stock was also reallocated to participant accounts.

Prior to the October 2018 acquisition, the Plan was amended to freeze investment in SYNEX common stock. As a result, plan participants were able to maintain their investment in SYNEX, but prohibited from purchasing additional shares of SYNEX common stock through the Plan.

As a result of the December 2020 spin-off from SYNEX, plan participants who maintained their investment in SYNEX received one share of Concentrix common stock for each share of SYNEX common stock held as of the close of business on November 17, 2020. Concurrently, the Plan was amended to freeze investment in Concentrix common stock. In September 2021, the plan was amended to remove SYNEX common stock as an investment option within the Plan. As a result, all existing balances were reallocated to the Vanguard Institutional Retirement Fund by age based on the participant's date of birth.

## **2. Summary of significant accounting policies**

### Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

### Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

### Investment valuation and income recognition

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). The Committee determines the Plan's valuation policies utilizing information provided by its investment advisors and the trustee. See Note 5 for further discussion and disclosures related to the fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### Risks and uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

### Benefits

Benefit payments are recorded when paid.

### Notes receivable from participants

The Plan's notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make repayments and the plan administrator deems the note receivable from the participant to be in default, the balance of the note receivable from the participant is reduced and a benefit payment is recorded per the Plan Document.

## **3. Transactions with parties-in-interest**

Certain plan investments are shares of mutual funds and common/collective trusts managed by Fidelity Investments, a related company to FMTC. FMTC is the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Certain professional and accounting fees incurred in connection with the operation of the Plan are paid directly by the Company. As described in Note 1, the Plan held common shares of Concentrix as of December 31, 2024 and 2023, respectively. Party-in-interest transactions also include loans made to participants.

## **4. Tax status**

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated June 18, 2014, stating that the Plan is qualified under Section 401(a) of the Code and, therefore, the related trust is exempt from taxation. Subsequent to this determination by the IRS, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan, as amended, is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The financial statement effects are recognized when the Plan has taken an uncertain position that more likely than not would be sustained upon examination

by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions. There are currently no audits for any tax periods in progress. As of the date at which the financial statements were available to be issued, the plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

## 5. Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

<i>Registered investment companies:</i>	The fair values of these securities are based on observable market quotations for identical assets and are priced on a daily basis at the close of business.
<i>Interest-bearing cash:</i>	The carrying value approximates fair value.
<i>Self-directed brokerage accounts:</i>	The self-directed brokerage account allows participants to invest in a wide array of securities. Participants can invest their plan assets in individual securities such as mutual funds, individual stocks and debt securities. The fair values of these securities are based on observable market quotations for identical assets and are valued at the closing price reported on the active market on which the individual securities are traded.
<i>Common stock:</i>	Valued at the closing price reported on the active market on which the security is traded
<i>Collective trust funds:</i>	Valued at the net asset value (NAV) of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information included in the financial statements and supplemental schedule.

#### **8. Fidelity bonding requirements**

The Plan was covered by a \$10,000,000 fidelity bond during 2024 and 2023.

#### **9. Subsequent events**

The plan administrator has evaluated subsequent events through August 13, 2025, the date the financial statements were available to be issued.

## *Independent Auditor's Report*

To the Concentrix CVG Employee Benefits Committee  
Concentrix Retirement and Savings Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have audited the accompanying financial statements of Concentrix Retirement and Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Concentrix Retirement and Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Concentrix Retirement and Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Concentrix Retirement and Savings Plan's ability to continue as a going concern within one year after the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Concentrix Retirement and Savings Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Concentrix Retirement and Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS  
DECEMBER 31, 2024 AND 2023**

**1. Plan description**

The following description of the Concentrix Retirement and Savings Plan provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan's provisions.

Through October 2018, the Convergys Corporation Retirement and Savings Plan (the former plan) was sponsored by Convergys Corporation ("Convergys"). In October 2018, Convergys was acquired by Concentrix Corporation ("we", the "Company" or "Concentrix"), a wholly-owned subsidiary of SYNEX Corporation ("former parent" or "SYNEX"). In connection with the acquisition, Concentrix became the former plan sponsor and was renamed Concentrix CVG Corporation (the "Company" or "Plan Sponsor").

In December 2021, Concentrix completed its acquisition of ProKarma Holdings Inc. ("PK"). Effective January 2023, and in connection with the acquisition, PK employees previously covered under the ProKarma, Inc. 401(k) Plan ("PK plan") became eligible to participate in the Plan.

In July 2022, Concentrix completed its acquisition of ServiceSource International, Inc. ("ServiceSource"). Effective January 2023, and in connection with the acquisition, ServiceSource employees previously covered under the ServiceSource 401(k) Profit Sharing Plan & Trust became eligible to participate in the Plan.

In September 2023, Concentrix completed its acquisition of Marnix Lux SA ("Webhelp"). Effective January 2024, and in connection with the acquisition, Webhelp employees previously covered under the TriNet 401(k) Plan became eligible to participate in the Plan. In April 2024, \$6,940,105 of assets held by these employees under the TriNet 401(k) Plan were transferred into the Plan.

We intend to formally amend, as applicable, the Plan Agreement to incorporate certain provisions implemented under the Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE Act), the SECURE Act 2.0 of 2022, and/ or the Coronavirus Aid, Relief and Economic Security Act of 2020 (CARES Act) prior to the applicable due date as set forth under each Act. The Plan's management is currently evaluating the impact of the SECURE Act 2.0 which was signed into law on December 29, 2022, and included several mandatory and optional provisions with various effective dates over the next several Plan years.

General

The Plan is a defined contribution plan available to all eligible employees who are twenty-one years of age or older of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Company's Employee Benefits Committee (the Committee) is responsible for the general administration of the Plan. Fidelity Management Trust Company (FMTC) is the trustee of and recordkeeper for the Plan.

Contributions

Each year, participants may contribute a percentage of their annual compensation on a pre-tax or after-tax basis, as defined in the Plan and set by the Committee. Participants may also rollover qualified distributions from other defined benefit or defined contribution plans. Each participant has the discretion to invest their contributions in a variety of mutual funds and collective trust funds offered

under the standard investment plan and can change their investment elections on a daily basis. Participants also have the option to create a self-directed brokerage account and invest their contributions in securities not offered under the standard investment plan. The self-directed brokerage account allows plan participants to invest in a wide array of securities, mainly registered investment companies and common stock, beyond those offered under the standard plan offering. The Company contributes an employer match equal to 100% of the first 3% and 50% of the next 2% of eligible compensation deferred by the participant, provided that the participant has completed at least 1,000 hours of service during the 12-month period beginning on the date of first employment with the Company. The matching contributions are invested in the same manner as participant contributions and are designed to comply with the safe harbor design under Section 401(K)(12) of the Internal Revenue Code (the Code or the IRC).

Participants age 50 and older (and those who will turn age 50 by December 31 of a given plan year) may take advantage of catch up contributions under the Code by saving an additional 1% to 50% of pay, subject to Code limits.

#### Participant accounts

Each participant's account is credited with the participant's contributions and the matching Company contributions and allocations of plan earnings and administrative expenses. Allocations of plan earnings and administrative expenses are based on participant earnings or account balances, as set forth in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Participants are vested immediately in the matching contributions made by the Plan Sponsor plus actual earnings thereon.

#### Notes receivable from participants

Participants may borrow from their accounts up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at the prime lending rate plus 1% at the time the loan is initiated. Loans generally must be repaid within five years, unless the participant ceases to be an employee of a Company, at which point any outstanding loan becomes immediately due and payable.

#### Administrative expenses

Certain costs and expenses of administering the Plan are paid by the Company except for fees paid to the investment managers from their respective funds and certain fees paid directly by the participants.

#### Forfeited accounts

Participant forfeitures of amounts not vested are used to offset the Company's contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,015,245 and \$1,346,575, respectively. During 2024, \$782,296 in forfeitures were used to offset Company contributions to the Plan.

### Plan termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

### Payment of benefits

Distribution of a participant's vested account balance is made in one lump-sum payment to the participant, or to their beneficiary, upon termination of employment, permanent disability, or death. Participant accounts that are vested and in excess of \$7,000 will not be distributed to the participant before they attain age 73 without the written consent of the participant. Participants may apply for hardship withdrawals, subject to approval by the plan administrator. Contributions and earnings are taxable to the participants, subject to certain exceptions, upon withdrawal from the Plan.

### Company Stock Fund

Prior to Convergys being acquired by Concentrix in October 2018, participants were able to invest in Convergys common stock through the Plan's Convergys Corporation shared fund (Company Stock Fund). Participants could invest in Convergys common stock by directing a portion of their contributions or by rebalancing their account balance.

In connection with the October 2018 acquisition, the Convergys common stock held by the Plan was exchanged for a combination of cash and common stock of SYNEX. The cash proceeds were reallocated to participants and invested in age-appropriate target retirement funds. The SYNEX common stock was also reallocated to participant accounts.

Prior to the October 2018 acquisition, the Plan was amended to freeze investment in SYNEX common stock. As a result, plan participants were able to maintain their investment in SYNEX, but prohibited from purchasing additional shares of SYNEX common stock through the Plan.

As a result of the December 2020 spin-off from SYNEX, plan participants who maintained their investment in SYNEX received one share of Concentrix common stock for each share of SYNEX common stock held as of the close of business on November 17, 2020. Concurrently, the Plan was amended to freeze investment in Concentrix common stock. In September 2021, the plan was amended to remove SYNEX common stock as an investment option within the Plan. As a result, all existing balances were reallocated to the Vanguard Institutional Retirement Fund by age based on the participant's date of birth.

## **2. Summary of significant accounting policies**

### Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

### Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

### Investment valuation and income recognition

The Plan's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). The Committee determines the Plan's valuation policies utilizing information provided by its investment advisors and the trustee. See Note 5 for further discussion and disclosures related to the fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### Risks and uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

### Benefits

Benefit payments are recorded when paid.

### Notes receivable from participants

The Plan's notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make repayments and the plan administrator deems the note receivable from the participant to be in default, the balance of the note receivable from the participant is reduced and a benefit payment is recorded per the Plan Document.

## **3. Transactions with parties-in-interest**

Certain plan investments are shares of mutual funds and common/collective trusts managed by Fidelity Investments, a related company to FMTC. FMTC is the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Certain professional and accounting fees incurred in connection with the operation of the Plan are paid directly by the Company. As described in Note 1, the Plan held common shares of Concentrix as of December 31, 2024 and 2023, respectively. Party-in-interest transactions also include loans made to participants.

## **4. Tax status**

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated June 18, 2014, stating that the Plan is qualified under Section 401(a) of the Code and, therefore, the related trust is exempt from taxation. Subsequent to this determination by the IRS, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan, as amended, is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The financial statement effects are recognized when the Plan has taken an uncertain position that more likely than not would be sustained upon examination

by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions. There are currently no audits for any tax periods in progress. As of the date at which the financial statements were available to be issued, the plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

## 5. Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

<i>Registered investment companies:</i>	The fair values of these securities are based on observable market quotations for identical assets and are priced on a daily basis at the close of business.
<i>Interest-bearing cash:</i>	The carrying value approximates fair value.
<i>Self-directed brokerage accounts:</i>	The self-directed brokerage account allows participants to invest in a wide array of securities. Participants can invest their plan assets in individual securities such as mutual funds, individual stocks and debt securities. The fair values of these securities are based on observable market quotations for identical assets and are valued at the closing price reported on the active market on which the individual securities are traded.
<i>Common stock:</i>	Valued at the closing price reported on the active market on which the security is traded
<i>Collective trust funds:</i>	Valued at the net asset value (NAV) of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities.

- Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information included in the financial statements and supplemental schedule.

#### **8. Fidelity bonding requirements**

The Plan was covered by a \$10,000,000 fidelity bond during 2024 and 2023.

#### **9. Subsequent events**

The plan administrator has evaluated subsequent events through August 13, 2025, the date the financial statements were available to be issued.
