Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Co-operative Insurance Companies 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for plan benefits as of December 31, 2024, and the related statement of changes in net assets available for plan benefits for the year then ended, and the related notes to the financial statements.

Opinion

Basis for Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. - Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Co-operative Insurance Companies 401(k) Plan internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Co-operative Insurance Companies 401(k) Plan ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

(1) Description of The Plan

The following description of the Co-operative Insurance Companies 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan’s Adoption Agreement for a more complete description of the Plan’s provisions.

In prior years, the Plan qualified as a “small plan” (fewer than 100 eligible participants at the beginning of the plan year) and, accordingly, was exempt from the audit requirement. This financial statement audit represents the first year for which the Plan has been audited.

(a) General – The Plan is a defined contribution plan covering all full-time and part-time employees of Patrons Co-operative Fire Insurance Company D/B/A Co-Operative Insurance Companies (the “Company”). Participants must attain the age of 19 to become a participant in the Plan, with the exception of interns, leased and temporary/seasonal employees. Participants are eligible to enter the Plan and begin making salary deferrals on the first day of hire. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). In accordance with the SECURE Act and SECURE 2.0, certain long-term, part-time employees may also be eligible to participate if they have completed at least 500 hours of service in three consecutive years (for plan years beginning before January 1, 2025) or two consecutive years (for plan years beginning on or after January 1, 2025), subject to the Plan’s provisions and applicable law.

(b) Employee Contributions – Participants may contribute up to 75% of eligible compensation as defined in the Plan, subject to Internal Revenue Service “IRS” limits. Participants must attain the age of 19 before they become eligible in the Plan. There are no service requirements prior to entry into the Plan, participants are automatically enrolled in the Plan upon eligibility at 4% unless they elect out. As of January 1, 2025 the automatic enrollment into the Plan increased to 5%.

Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions as set by the IRS. Participants may also contribute amounts representing rollovers from other qualified defined benefit or contribution plans. Union employees governed by a collective bargaining agreement, nonresident aliens, and leased employees are excluded from participating in the Plan.

(c) Employer Safe Harbor Matching Contribution – The Company makes a matching contribution equal to 100% of the participants salary deferral not to exceed 3% of compensation plus 50% salary deferrals between 3% and 5% of compensation. The matching contribution is 100% vested. Contributions are made each payroll period for each employee who enters into a salary reduction agreement. Eligible participants to receive the safe harbor contributions have to be of the age of 19 and completed 12 months of service.

(d) Discretionary Profit-Sharing Contributions – The Company may contribute a discretionary profit-sharing contribution for each employee, without regard to current or accumulated net profits of the Company. Employees are eligible for the discretionary profit-sharing contribution if employed on the last day of the Plan year. During 2024, the Company made a profit-sharing contribution for each eligible participant equal to 0% of their eligible compensation.

Description of The Plan (continued)

- (e) Participant Accounts – Each participant’s account is credited with the participant’s contributions, the Company’s matching contribution, and allocation of (a) the Company’s additional discretionary contribution, (b) the participant’s contribution, and (c) Plan earnings. The allocation of the profit-sharing contribution is based on the relationship of the participant’s compensation to the total compensation earned by participants in the Plan. The allocation of the Plan's earnings is based on participants' account balances. The benefit to which a participant is entitled is that which can be provided from the vested balance in the participant's account. Participants direct all contributions into various investment options.
- (f) Vesting – Participants are immediately vested in their voluntary and employer safe harbor matching contributions plus actual earnings thereon. Vesting in the discretionary profit sharing contributions of the participant’s account plus actual earnings thereon is based on years of continuous service. Upon normal retirement age, death or disability, a participant becomes fully vested.

- (g) Payments of Benefits – Upon termination of service, death, disability, or normal retirement, the participant or beneficiary may elect to receive distributions equal to the value of the participant’s vested interest in their account. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution or leave the funds in the Plan until retirement age or transfer to a trustee of another qualified plan or individual retirement account. If the terminating employee’s non-forfeitable account balance is less than \$5,000, it is mandatory that the Plan distribute the entire account balance, less forfeitures, if any, as soon as administratively practical.

A participant may withdraw rollover contributions at any time which are 100% vested. Hardship withdrawals are permitted by the Plan. In-service distributions are also permitted once the participant has reached age 59 ½ and can only be made from accounts which are 100% vested.

- (h) Forfeited Accounts – Forfeitures represent amounts which could not be paid to terminated participants due to failure to meet vesting requirements. Forfeitures are used to reduce the Company’s contributions or Plan expenses. Total forfeitures used during 2024 were \$201. As of December 31, 2024 and 2023, there were \$0, of available forfeitures.

- (i) Notes Receivable – Participants may borrow a minimum of \$1,000 up to a maximum, not to exceed 50% of their vested account balance or \$50,000, whichever is less. Loan transactions are treated as transfers between the investment fund and the loan account, representing issuance and repayments. Loan terms vary in range, from one to five years. The loans are secured by the balance in the account and bear interest at the prime rate as published in the Wall Street Journal Prime rate + 1%. Principal and interest are repaid ratably through weekly payroll deductions. No more than two loans may be outstanding at a time for a participant.

(2) Summary of Significant Accounting Policies

- (a) Basis of Accounting – The accompanying financial statements are prepared on the accrual basis of accounting.
- (b) Investment Valuation and Income Recognition – Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts because the contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

- (c) Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document.
- (d) Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.
- (e) Administrative Expenses – All direct administrative expenses are paid by the Plan except postage, advisor and audit fees.
- (f) Benefit Payments – Benefits are recorded when paid.
- (g) Subsequent Events – The Plan has evaluated subsequent events through July 17, 2025, which is the date that the financial statements were available to be issued.

(3) Plan Amendment and Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue contributions or terminate the Plan at any time, subject to provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Additionally, the Company may amend the Plan at any time without the consent of any participant or any beneficiary, provided that no amendment deprives any participant of the participant's non-forfeitable accrued benefit.

(4) Tax Status

The Plan is based on a pre-approved plan document sponsored by OneAmerica, and is relying on the sponsor's opinion letter from the Internal Revenue Service dated December 31, 2018. This letter states that the pre-approved plan is designed in accordance with applicable sections of the Internal Revenue Code "IRC". The Plan sponsor believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

(5) Withdrawing Participants

There were no participant distributions requested in 2024, but not paid until 2025.

(6) Related Party Transactions

The Plan has a number of service providers. Such parties are considered parties-in-interest under ERISA.

(7) Information Certified By The Plan's Trustee

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix Trust Company, the Trustee of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statement of net assets available for plan benefits as of December 31, 2024, the schedule of assets held for investment purposes as of December 31, 2024 and the related investment activity reflected in the statement of changes in net assets available for plan benefits for the year ended December 31, 2024.

(8) Investments at Contract Value

The Plan has entered into a fully benefit-responsive guaranteed investment. The custodian maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for plan benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawals or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment option or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, (d) a material misrepresentation. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

(9) Fair Value Measurements

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the closing price reported on the active market on which the individual securities are traded. Mutual fund accounts totaled \$18,090,720 and \$16,998,814 at December 31, 2024 and 2023, respectively.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(10) Risks and Uncertainties

The Plan provides for various investment instruments. Investment securities, in general, are exposed to various risk, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the financial statements.
