## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of  
R&R Invest, Inc. Employees' Retirement Savings Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of R&R Invest, Inc. Employees' Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

#### **Other Matter**

##### *Supplemental Schedule Required by ERISA*

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplemental information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**NOTE 1 — DESCRIPTION OF THE PLAN**

**General**

The following description of the R&R Invest, Inc. Employees' Retirement Savings Plan (Plan) provides only general information. Participants should refer to the Plan agreement (Agreement) for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan which generally covers persons regularly employed by R&R Invest, Inc. (the Company). The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan Administration**

The Company has contracted Principal Life Insurance Company, Principal Global Investors Trust Company, and Principal Trust Company (collectively, Principal) to hold the Plan's assets, execute investment transactions, perform allocations of contributions and investment earnings, and make benefit payments.

**Contributions and Eligibility**

The Plan allows for employee contributions up to 100% of eligible compensation, subject to certain Internal Revenue Code (IRC) limitations. Employees of the Company who are hired to work at least 1,000 hours annually are eligible to make elective deferrals immediately upon employment.

The Plan also provides for discretionary Company-matching and profit-sharing contributions at the sole discretion of the Company's Board of Directors. During the years ended December 31, 2024 and 2023, the Company made discretionary matching contributions of 50% of the participant's contribution, up to 6% of their eligible compensation. Additionally, during the years ended December 31, 2024 and 2023, discretionary profit-sharing contributions equal to 2% of the participant's gross wages were made by the Company. Employees are eligible for Company-matching and profit-sharing contributions upon completion of one (1) year of employment. Additionally, for profit-sharing contributions, employees must be with the Company as of the last day of a given Plan year.

**Participant Accounts**

Individual accounts are maintained for each Plan participant. Each participant's account is increased or decreased by the participant's contributions, withdrawals, and an allocation of Plan earnings (losses), net of administrative expenses and an allocation of the Company's contributions. Allocations to participants are based on the funds selected by the participant, as defined in the Agreement. The benefit to which a participant is entitled is the benefit that can be provided by the participant's account.

**Investments**

Participants direct the investment of the contributions into various investment options offered by the Plan. The Plan currently offers mutual funds, pooled separate accounts, and collective investment trusts. Assets held within the self-directed brokerage account pertain to a participant's balance in a portfolio held outside of Principal, which is frozen from additional contributions. On September 6, 2024, the self-directed brokerage account was fully distributed.

**Vesting**

All participants are 100% vested in their contributions and allocated Plan earnings. Participants become vested in Company-matching contributions and allocated Plan earnings on a schedule beginning after two (2) years of vesting service, as defined in the Agreement. The initial vesting percentage is 20%, increasing by 20% annually, until becoming fully vested after six (6) years of vesting service, as defined in the Agreement. Participants are considered 100% vested if they reach the age of fifty-five (55), become totally disabled as defined in the Agreement, or die, while participating in the Plan.

**Notes Receivable, Participants**

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum of 50% of their vested account balance or \$50,000, whichever is less. Outstanding loans are limited to one (1) per participant at any given time, are secured by the balance in the participant's account, and bear interest at rates ranging from 4.25% to 9.50% as of December 31, 2024. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant (or a participant's beneficiary in the event of death) may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. A participant may also withdraw a portion of his or her vested Plan benefit upon attaining age 59 1/2 while still employed by the Company. In addition, hardship distributions are permitted if certain criteria are met.

**Forfeitures**

Forfeited accounts are used to offset the Company's future matching contributions. Forfeitures of \$30,908 and \$34,534 were utilized to offset employer contributions for the years ended December 31, 2024 and 2023, respectively.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to terminate the Plan subject to the provisions of ERISA. In the event that the Plan terminates, the accrued benefits of all participants shall be distributed to participants as provided in the Agreement.

**NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**

The preparation of the financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 4 for discussions of the fair value measurements utilized by the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes gains and losses on investments bought and sold, as well as held, during the period.

**Notes Receivable, Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Contributions**

Contributions from the Plan participants and the matching contributions from the Company are recorded in the year in which the participant contributions are withheld from compensation.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to administration of notes receivable from participants and distributions are charged directly to participant accounts. Certain investment-related expenses are included within net appreciation in fair value of investments.

**NOTE 3 — INVESTMENTS AND INVESTMENT INCOME**

**Information Certified by Principal**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal has certified that the following unaudited information included in the accompanying financial statements and supplemental schedule is complete and accurate as of December 31, 2024 and 2023 and for the years then ended:

**Self-Directed Brokerage Account**

The Plan's investments held within the self-directed brokerage account through September 6, 2024 have not been certified by Principal. Therefore, the investments and related investment income are excluded from the above table and are not subject to the exemption allowed for certified investments. As of December 31, 2023, the self-directed brokerage account fair value was \$740,545. During the year ended December 31, 2024, the self-directed brokerage account had dividends/interest and net appreciation in fair value of \$19,314 and \$3,931, respectively. During the year ended December 31, 2023, the self-directed brokerage account had dividends/interest and net appreciation in fair value of \$23,309 and \$43,615, respectively.

**NOTE 4 — FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a three-tier fair value hierarchy, which categorizes the inputs used in measuring fair value. These categories include (in descending order of priority): Level 1, defined as observable inputs such as quoted prices in active markets for identical assets; Level 2, defined as inputs other than quoted prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore requiring the Plan to develop its own assumptions. The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Pooled separate accounts, and collective investment trusts*— Valued based on quoted redemption values, also known as net asset values (NAV), determined by using available market information and appropriate valuation methods, as provided by Principal and represent the value at which the Plan (or the participant) could initiate a transaction with Principal. There are no imposed redemption restrictions on participants, except for certain short-term trading restrictions, which prohibit participants from reinvesting into the same account within 30 days. Other than the U.S. Property Separate Account, there are no limitations on redemptions.

The NAV of the U.S. Property Separate Account is based on the underlying real estate assets, which are valued using discounted cash flow valuation models that utilize public real estate market data such as transaction prices, market rents, vacancy levels, leasing absorption, market cap rates and discount rates. In addition, each property is appraised annually by an independent appraiser. Principal has the ability to apply a contractual limitation, which delays the payment of withdrawal requests (Withdrawal Limitation). Since December 31, 2022, the Withdrawal Limitation was in effect. As of December 31, 2024 there were 6 outstanding distribution requests totaling \$175,509. As of December 31, 2023 there were 7 outstanding distribution requests totaling \$663,753.

- *Mutual funds* – Valued based on observable market quotations for identical assets and are priced on a daily basis at the close of business.
- *Self-directed brokerage account* – This account is comprised of money market funds and common stocks of publicly-traded corporations and United States Treasury securities. Money market funds and common stocks are valued based on quoted prices in active markets for identical assets. United States Treasury securities are valued based on observable inputs other than quoted prices in active markets for identical assets.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement.

- (a) Due to the Withdrawal Limitation applied on July 1, 2022, the Principal U.S. Property Separate Account utilized its NAV as a practical expedient to estimate fair value at December 31, 2024 and 2023. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. The Principal U.S. Property Separate Account has no unfunded commitments, allows for daily redemptions when a Withdrawal Limitation is not in effect, and has no required redemption notice period.

**NOTE 5 — PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Principal. Fees incurred by the Plan for the investment management services are included in net appreciation in fair values of investments. Therefore, these transactions with Principal qualify as party-in-interest transactions. A participant who acquires a participant loan is also a party-in-interest. However, all such transactions are exempt and are not prohibited by ERISA. Principal also charged administrative fees of \$64,589 and \$54,485 for the years ending December 31, 2024 and 2023, respectively.

**NOTE 6 — INCOME TAX STATUS**

The Plan uses a prototype plan document sponsored by Principal. Principal received a letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the prototype plan document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in accordance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that "more-likely-than-not" would not be sustained upon examination by the IRS. The Plan's management has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

**NOTE 7 — SUBSEQUENT EVENTS**

The Plan's management has evaluated subsequent events through August 4, 2025, the date the financial statements were available to be issued.
