Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of JAS Design-Build Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. 1. DESCRIPTION OF PLAN

The following description of the JAS Design-Build Incorporated 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

a. General

The Plan is a defined contribution plan established on January 1, 2000. The Plan covers all employees of JAS Design-Build, Inc. (the Company) who are not in an ineligible class of employees, as defined in the Plan Document.

The Company is the plan sponsor and plan administrator.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

b. Eligibility

Employees who are at least 21 years of age are eligible to participate after two consecutive months of service and can elect to enter the Plan as a participant on the first day of the month which coincides with, or next follows, the date on which the employee satisfies the service requirement.

c. Contributions

Participants may contribute up to 100% of their compensation, as defined by the Plan. Employees may choose between pre-tax and Roth contributions in their elective deferrals. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Company, at its discretion, may make matching employer contributions. These contributions are calculated based on a participant's elective deferrals and eligible compensation, using a percentage determined by the Company. During the year ended December 31, 2024, the Company made discretionary matching contributions of \$133,564. The Company matched 25% of each participant's contributions up to \$2,000.

Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. Participants may change their investment elections as often as permitted under the investment vehicles they choose.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

1. DESCRIPTION OF PLAN, (Continued)

d. Participant accounts

Each participant's account is credited with the participant's contributions and an allocation of the Company contribution (if any) and earnings thereon and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

e. Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings or losses thereon. Vesting in all matching contributions is based on years of service, as follows:

1	20%
2	40%
3	60%
4	80%
5 or more	100%

Upon death, disability, or reaching early retirement age (age 59.5), participants become fully vested in all account balances.

f. Notes receivable from participants

Participants may borrow from their account balance a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. Loan terms can be up to 5 years, except loans used to purchase a principal residence which can be for extended loan terms. The loans are secured by the balance in the participant's account and bear interest at a rate which is commensurate with the prevailing rates as determined by the plan administrator. The Plan requires repayment of the loan obligation through payroll deductions; however, the participant may repay the loan at any time.

g. Payment of benefits

Benefits will be paid to the participants or participant's beneficiary upon termination of service, death, disability, or retirement.

If the participant's account balance is over \$5,000, the distributions will be paid either as a lump sum cash payment or as a direct rollover or in installment payments for required minimum distributions, at the participant's discretion.

g. Payment of benefits, (Continued)

If the participant's account balance is under \$5,000 but over \$1,000, then the distribution will be made, either as a lump sum cash payment or as a direct rollover, as soon as administratively practicable after the participant leaves the Company. If the participant does not respond regarding method of distribution, then the distribution will be rolled into an Individual Retirement Account in the name of the participant.

If the participant's account balance is under \$1,000, then the distribution will be automatically made in a lump sum cash payment regardless of whether the participant consents to receive it.

Participants may also withdraw funds from their account in the event of financial hardships as defined in the Plan document.

h. Forfeitures

Forfeited nonvested account balances at December 31, 2024 and 2023 were \$2,847 and \$2,435, respectively. These amounts can be used to pay administrative expenses or be used to reduce future employer contributions. Administrative expenses were reduced by \$8,733 from forfeited nonvested accounts for the year ended December 31, 2024.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

a. Basis of accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

b. Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

c. Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrative committee determines the Plan's valuation policies utilizing information provided by the investment adviser and trustee. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

d. Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

e. Payment of benefits

Benefits are recorded when paid.

f. Administrative expenses

Transaction based fees are charged directly to the participant's accounts. Certain administrative expenses incurred by the Plan are paid by the Company and are excluded from these financial statements. Administrative expenses not paid by the Company are charged to participants' accounts and apportioned based upon their relative account values.

g. Date of the Plan's review

The Plan has evaluated subsequent events through August 21, 2025, the date the financial statements were available to be issued.

3. TRUSTEE CERTIFICATIONS UNDER ERISA SECTION 103(a)(3)(C)

The plan sponsor has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the auditors' examination did not extend to the following information certified by Ascensus Trust Company (Ascensus), the trustee, as complete and accurate:

- Investments
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest and dividends
- Interest income on notes receivable from participants
- Schedule of assets (held at end of year)

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2 Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market fund: Valued at cost plus accrued interest which approximates fair value.

5. PARTY-IN-INTEREST TRANSACTIONS

During 2024 and 2023, the Plan held investments in fund options managed by Vanguard. Vanguard is the recordkeeper as defined by the Plan and, therefore, these transactions are recognized as exempt party-in-interest transactions under ERISA.

For the year ending December 31, 2024, the Plan paid \$9,933 for certain expenses related to plan operations to various service providers. These expenses are recognized as exempt party-in-interest transactions under ERISA.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

7. TAX STATUS

The Plan document uses a prototype non-standardized profit sharing plan that received a favorable opinion letter from the IRS dated June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC) and, accordingly, was exempt from federal income tax. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

7. TAX STATUS, (Continued)

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any taxing periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
