### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Parks Motor Group 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Parks Motor Group 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

### **Opinion**

#### (1) Description of Plan

##### (a) General

The following description of the Parks Motor Group 401(k) Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan covering all full-time employees of Longwood-Lincoln Mercury, Inc. d/b/a Parks Lincoln of Longwood, JP Cycles, Inc. dba Seminole PowerSports, Prestige Lincoln-Mercury, Inc., d/b/a Parks Ford Lincoln Hyundai of Gainesville, Parks Automotive Group, Inc., dba Parks Toyota of DeLand and Seminole Powersports North, LLC (collectively the "Companies") who have 2 months of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

The Companies absorb certain expenses that relate to the administration and management of the plan such as expenses to maintain the plan's tax-qualified status and to communicate plan information to participants and beneficiaries of the plan.

Effective January 1, 2015, the plan documents were amended and restated under the DATAIR Mass-Submitter Prototype Non-Standardized Cash or Deferred Profit Sharing Plan documents. The corresponding adoption agreement and amendments thereto included the requirements of the Pension Protection Act of 2006 ("PPA 06"), the Heroes Earnings Assistance and Relief Tax Act of 2008 ("HEART"), the Emergency Economic Stabilization Act of 2008 ("EESA"), the Workers, Retiree, and Employer Recovery Act of 2009 ("WRERA"), as well as the required changes from the 2010 Cumulative List of Changes in Plan Qualification Requirements described in section 4 of Revenue Procedure 2005-66 as modified by Revenue Procedure 2007-44. These changes were primarily technical in nature; however, the Plan eligibility date was changed from 3 months to 2 months effective January 1, 2015.

On November 20, 2017, the plan documents were amended to change Plan eligibility from 2 months to 6 months effective January 1, 2018.

**(1) Description of Plan - Continued**

**(b) Contributions**

Each year, participants may contribute a percentage of pretax annual compensation up to Internal Revenue Service (IRS) Code limitations, as defined in the Plan and by the IRS. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible compensation. Unless an election is made by the participant, automatically enrolled participant deferral rates are increased by 1% each year up to a maximum of 10%. Contributions are automatically invested in a designated balanced fund until changed by the participant. Participants may also contribute amounts representing distributions from other qualified plans (“rollover contributions”). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Companies may make matching and or profit sharing contributions, in their sole discretion. All employer contributions are invested as directed by the Participants. Contributions are subject to certain limitations, as defined.

**(c) Participant Accounts**

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Companies’ contribution (if any) and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**(d) Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Companies’ discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six or seven years of credited service (depending on date of hire).

**(e) Payments of Benefits**

On termination of service due to death, disability or retirement, a participant will receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account.

**(f) Forfeited Accounts**

Forfeitures of the Companies' matching contributions shall be used to reduce the Companies' discretionary matching contributions. The amounts included on the accompanying statements of net assets available for benefits of \$17,421 and \$2,973 at December 31, 2024 and 2023, respectively, represent the unallocated forfeitures. Such amounts are not participant-directed until allocated. During 2024, \$2,973 from the unallocated forfeitures cash account was used to reduce employer contributions.

**(g) Subsequent Events**

In preparing these financial statements, the Plan has evaluated subsequent events and transactions for potential recognition and disclosure through August 8, 2025, which is the date the financial statements were available to be issued.

**(2) Summary of Significant Policies**

**(a) Basis of Accounting**

The accompanying financial statements have been prepared on an accrual basis of accounting and present the net assets available for benefits and changes in those assets.

**(b) Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**(c) Valuation of Investments and Income Recognition**

Investments are stated at fair market value determined by quoted market prices or their equivalent with the exception of certain stable value investment contracts which are stated at contract value. Changes in the aggregate market or contract value of the investments are charged or credited to net investment income for the year. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(d) **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Notes receivable from participants are stated at the amount management expects to collect from securing participant account balances. When applicable, management provides for probable uncollectible amounts through a valuation allowance based on its assessment of the current status of individual accounts. At December 31, 2024 and 2023, there were no valuation allowances considered necessary by management.

Delinquent notes receivable from participants are reclassified as a benefit payment based upon the terms of the plan document; generally, when repayments have stopped for a period of time, as defined, and the participant terminates employment. During 2024, there were no benefit payments due to defaults.

(e) **Payment of Benefits**

Benefits are recorded when paid.

(3) **Investments**

During 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) increased in value by \$1,342,676. All of the investments are participant directed and were held in pooled accounts by the Custodian.

(4) **Fair Value Measurements**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

The Plan has an investment contract with John Hancock Life Insurance Company (JH) for the purpose of investing Plan assets. Participants can elect to invest amounts allocated to their accounts in either fixed income investment options under a guaranteed investment contract or to purchase units in various funds of registered investment companies - mutual funds.

The Plan invests in a fully benefit-responsive guaranteed investment contract with JH. JH maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. JH, as the guaranteed investment contract issuer, is contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan. Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for plan benefits at contract value. Contract value, as reported to the Plan by JH, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

**(5) Related Party Transaction**

Certain Plan investments are shares of mutual fund managed by John Hancock Life Insurance Company (JH). JH is the custodian, as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$21,778 for the year ended December 31, 2024. This party-in-interest transaction is exempt from the prohibited transaction rules of ERISA.

**(6) Plan Termination**

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**(7) Tax Status**

The Plan has adopted the DATAIR Mass-Submitter Prototype plan. The DATAIR Mass-Submitter Prototype plan has received an opinion letter dated March 31, 2014 (with an effective date of October 31, 2011) from the Internal Revenue Service indicating that the form of the plan is acceptable in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator and the Plan's tax consultant believe the terms of the plan are being followed in operation as outlined in the opinion letter. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax consultant believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

**(8) Risks and Uncertainties**

The Plan, through participant directed accounts, invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
