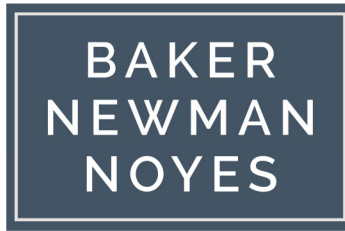

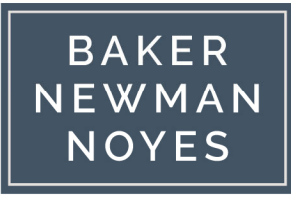

INDEPENDENT AUDITORS' REPORT

To the Plan Administrator, Trustees and Participants
MountainOne Financial, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of MountainOne Financial, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. 1. **Description of Plan**

General

The following description of the MountainOne Financial, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a discretionary contribution retirement plan. The Plan Sponsor is MountainOne Financial, Inc. (the Company). Participating employers in the Plan include the Company's wholly owned subsidiary, MountainOne Bank (the Bank), and the Bank's wholly owned subsidiary, MountainOne Insurance Agency, Inc. Effective January 1, 2017, True North Insurance Agency, Inc. (True North) was merged into Coakley, Pierpan, Dolan & Collins Insurance Agency, Inc. (CPDC), which was renamed MountainOne Insurance Agency, Inc. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The original effective date of the Plan is January 1, 1993.

Eligibility

Employees become eligible to make pre-tax and/or after-tax (Roth) contributions, and to receive Company matching contributions, if any, as of the date they reach the later of 90 days of eligible service or age 21.

Employees become eligible to receive Company discretionary (core) contributions when they reach the later of age 21 or the completion of 1 year of eligible service. A year of eligible service is a 12-month period measured from date of hire in which employees are credited with at least 1,000 hours of service. If paid for fewer than 1,000 hours in that period, employees will be credited with a year of eligible service whenever 1,000 hours or more of service is completed in any Plan year following the date of hire.

Any employee of South Coastal Bank, a former subsidiary of the Company that was merged into the Bank effective July 22, 2013, who was a participant in South Coastal Bank's defined benefit plan as of November 1, 2008, and any employee hired on or before December 31, 2008 by the Company, the Bank or the former True North, is not eligible to receive core contributions.

Contributions

Participants may elect to contribute a voluntary pre-tax or Roth salary deferral amount, subject to the provisions of the Internal Revenue Code (IRC). The Plan also allows rollover contributions of eligible rollover distributions from other qualified retirement plans.

The Company has the option of making matching contributions. In 2024 and 2023, the Company matched 50% of a participant's contributions on the first 6% of a participant's eligible compensation under the Plan.

Additionally, the Company contributes 3% of participants' eligible compensation under the Plan for participants hired after December 31, 2008 and that have completed one year of service. These contributions are referred to as "core" contributions by the Company.

1. **Description of Plan (Continued)**

Participants may select the investments in which their accounts are invested from among a variety of available investment options.

Vesting

Any elective deferrals or rollover contributions are 100% vested. Additionally, participants are automatically fully vested upon attainment of normal or early retirement age, or upon retirement due to disability or death. Contributions made by the Company are fully vested immediately for all participants. Certain former employees of CPDC had a vesting schedule for Company contributions made prior to January 1, 2016, which are now fully vested.

Forfeitures

Forfeitures may be used to pay any administrative expenses as well as to reduce employer contributions. At December 31, 2024 and 2023, there was no balance in the forfeiture account.

Participant Accounts

Each participant's account is credited with the participant's contribution and a proportionate allocation of any Company contributions and Plan earnings or losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

The Plan allows loans to employees participating in the Plan. The amount of any loan shall be at least \$1,000 and shall not exceed the lesser of (a) \$50,000 reduced by the individual's highest outstanding loan balance during the twelve-month period ending on the day before the date the new loan is made; or (b) 50% of the individual's vested interest in his or her total account. Notes must be repaid within five years, unless the proceeds are used to buy a principal residence, with fixed interest rates at prime plus 1% for loans based on current market rates at the time of the loan.

Each loan is collateralized by the borrower's interest in the Plan and is evidenced by a promissory note. Loan repayment is made through payroll deduction. Loan fees are assessed against an individual participant's account.

Participant Withdrawals

The Plan provides for participants to withdraw their funds at any time after reaching normal retirement age (65) or early retirement age (55 ½) with certain employment requirements. The Plan also provides for withdrawals in the event of death, disability, hardship or termination.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Investment Valuation and Income Recognition

Investments in mutual funds and collective trust funds are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The guaranteed investment contract is reported at contract value, as determined by the insurance company, as it is considered fully benefit-responsive. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of investment securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes realized gains and losses on investments that were sold during the year as well as net unrealized appreciation (depreciation) on investments held at year-end.

Contributions

Participant contributions are reported in the period in which payroll deductions are made; employer matching and core contributions are recorded in the same period as corresponding participant contributions.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses of the Plan are paid by the Plan participants to the extent they are not paid by the Company, except for the administrative costs of mutual funds, collective trust funds, pooled separate accounts and loan processing fees, which are paid from participants' investment funds.

Notes Receivable from Participants

Notes receivable from participants are carried at the unpaid principal balance plus any accrued but unpaid interest.

Subsequent Events

Events occurring after the statement of net assets available for benefits date are evaluated by management to determine whether such events should be recognized or disclosed in the financial statements. Management has evaluated subsequent events through August 4, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan features an automatic enrollment provision. All employees who become eligible subsequent to January 1, 2025 are automatically enrolled in the Plan and 3% of eligible compensation is deferred, unless the participant specifically elects another amount or opts out of the Plan.

3. Tax Status

A qualifying plan is one for which the employer may currently deduct contributions on its income tax return, the employee is not currently taxed on the contribution, and the plan income is not taxable.

Effective January 1, 2022, the Plan adopted a non-standardized pre-approved plan sponsored by The Angell Pension Group, Inc. and the Company was informed by a letter dated June 30, 2020 from the IRS that the form of the Plan was acceptable under Section 401(a) of the IRC. Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

4. Fair Value Measurements

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. Management has evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

4. **Fair Value Measurements (Continued)**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Assets that are measured at fair value using the net asset value (NAV) per share practical expedient have not been classified in the fair value hierarchy.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund. The Plan has no unfunded commitments for those accounts and they can be redeemed daily at NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Contract with Insurance Company

The Plan has a fully benefit-responsive group annuity contract issued by Principal Life Insurance Company (Principal). Principal maintains the contributions in a general account. The account is credited with the earnings on the underlying investments and is charged for participant withdrawals and certain administrative expenses charged by Principal. The contract is included in the financial statements at contract value, as reported to the Plan by Principal. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and certain administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The contract is backed by Principal's general account, which is invested in a diversified portfolio, consisting predominately of fixed income investments. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a semiannual basis for resetting.

5. **Contract with Insurance Company (Continued)**

Certain events limit the ability of the Plan to transact at contract value with the insurance company under the group annuity contract. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures, or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such events that would limit the Plan's ability to transact at contract value with participants is probable.

6. **Information Certified by the Plan's Custodians**

Information disclosed in the accompanying financial statements and supplemental schedule, relating to investments, related net appreciation (depreciation) in fair value of investments, interest and dividends, and related investment transactions, was certified as complete and accurate by Principal Life Insurance Company, on behalf of Principal Global Investors Trust Company, and Principal Trust Company, the Plan's custodians, as of December 31, 2024 and 2023 and for the years then ended. Plan Management has determined that the Plan's custodians meet the requirements of a qualified institution as defined by the United States Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by the custodians. Notes receivable from participants and the related income were subject to procedures under auditing standards generally accepted in the United States of America.

7. **Related-Party Transactions and Party-in-Interest Transactions**

Certain investments qualify as party-in-interest transactions. Investment choices are provided under a group annuity contract and recordkeeping agreement issued by Principal. Affiliated companies, Principal Trust Company and Principal Global Investors Trust Company, registered investment advisors, provide investment information relating to the Plan. These transactions qualify as party-in-interest.

Notes receivable from participants and the related income qualify as party-in-interest transactions.

Administration expenses charged to the Plan and paid to Principal, Principal Trust Company and Principal Global Investors Trust Company were \$69,787 and \$60,344 in 2024 and 2023, respectively. These transactions qualify as party-in-interest.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a full Plan termination, participants will become 100% vested in their accounts.

9. Reconciliation of Financial Statements to Form 5500

Notes receivable from participants are reflected as investments in the Form 5500 as of December 31, 2024 and 2023. The related interest income is shown as investment income on the Form 5500 for the years ended December 31, 2024 and 2023.
