Independent Auditors' Report

**The Board of Directors

Opinion on the Financial Statements

We have audited the accompanying financial statements of the Florida Bankers Health Consortium, Inc. (the "Plan"), an employee benefit plan subject to the Employee Retirement Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in benefit obligations and net assets available for benefits for the years then ended, and the related notes to the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other Matter - Supplemental Schedule Required by ERISA

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for the purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content is presented in conformity with DOL's Rules and Regulations under ERISA.

(1) Description of plan

The following description of the Florida Bankers Health Consortium, Inc. (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a not-for-profit multiple employer welfare arrangement domiciled in Florida and created in accordance with Florida Statute 624.436. The Plan constitutes an employee welfare benefit plan and a single employer association health plan within the meaning of the Employee Retirement Income Security Act of 1974 ("ERISA") and provides its members a program of group health benefits that the members may offer to their eligible employees and their dependents. The Plan members consist of banks, trust companies, saving and loan associations and their holding companies and service companies in Florida who are members of the Florida Bankers Association, Inc. and who have consolidated in one entity. The institutions participate in the Plan on an annual basis. Any institution that should cease participation must wait a minimum of three years before rejoining the Plan.

Each year, the members execute a participation agreement. The participation agreement sets forth the rights, obligations, and liabilities of the parties with respect to the Plan and the assets in the Plan, including the payment of premiums, claims, fees and expenses. Most members are required to make monthly payments based on rates that are fixed for the year.

In 2022, the Plan submitted a plan to transition from a self-insured multiple-employer welfare arrangement to a fully-insured multiple-employer welfare arrangement. Beginning January 1, 2023, the Plan changed their product offering to a fully-insured arrangement and no longer self-insure their medical claims and prescription drug benefits.

In 2022, the Plan assessed a capital call of its members amounting to \$1,604,000 to meet the minimum capital requirements in place for a self-insured multiple-employer welfare arrangement. Due to the transition from a self-insured multiple-employer welfare arrangement to a fully-insured multiple-employer welfare arrangement, the Plan determined there was an excess of self-insured capital and surplus amounting to \$1,202,819 during 2024. The funds were returned to the 2022 Plan participants in 2024.

The Plan is administered by Trust Management Group, Inc. ("TMG"). TMG is a Florida not-for-profit and holds a Florida third party administrator license. TMG is affiliated with the Plan through common management. TMG, on behalf of the Plan, provides administrative services and arranges for fully-insured products to be provided to the Plan. Administrative services include web portal access for enrollment and billing, customer service, call centers, and other health and welfare benefits administration services.

(b) Insurance premiums paid

Beginning January 1, 2023, the Plan is fully insured and provides comprehensive medical expense benefits, dental and vision expense benefits, prescription drug benefits, and legal insurance. The Plan purchases annual insurance contracts for these insured benefits. Members may choose to offer different benefit options to their employees according to their participation agreements.

(c) Contributions

The Plan has procured insurance policies with various insurance companies to pay claims. The Plan pays the premiums for such policies with the assets of the Plan. Such premiums are generally paid monthly. The insurance companies that issue the policies are responsible for paying all claims and benefits under the Plan. Participants receiving benefits under COBRA pay the full cost for their coverage under the Plan.

Premiums are billed monthly on a per employee basis and are recognized as contributions over the period in which the Plan is obligated to provide services to members. Contributions collected in advance are recorded as liabilities until earned.

(d) Claims paid

Claims paid in 2023 relate to medical claims and unpaid claims adjustment reserves for claims incurred prior to the Plan's conversion from a self-insured arrangement to a fully-insured arrangement on January 1, 2023. Because the medical claims and unpaid claims adjustment reserves are estimates, any adjustment to these reserves is reflected in the year in which the changes in estimate are realized.

(e) Administrative expenses

Significant administrative expenses are paid by the Plan, which primarily consist of overhead, professional fees, insurance and fees.

(f) Plan termination

Although it has not expressed any intent to do so, the Plan has the right under the Plan agreement to modify the benefits provided to, and contributions required of, members and to discontinue member contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Plan or be used for purposes other than for the exclusive benefit of the Plan's members.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

(b) Cash equivalents

Cash equivalents include demand deposits with financial institutions and other highly liquid investments with original maturities of three months or less.

(c) Investment valuation and income recognition

Investments are stated at fair value as reported by the financial institution. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements. Interest income is recorded on the accrual basis.

(d) Benefit obligations

Prior to becoming fully insured, medical claims and unpaid claims adjustment expense reserves include the accrual for medical claims and unpaid claims adjustment expenses incurred but not paid and the estimated liability for medical claims and unpaid claims adjustment expenses incurred but not reported. The reserve for medical claims and unpaid claims adjustment expenses incurred but not reported was determined by the Consortium's independent actuary based on historical evaluations and statistical analysis of paid claims and represents an estimate of the unpaid liabilities incurred.

(e) Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Such estimates also affect the reported amounts of additions and deductions to net assets available for benefits. Actual results could differ from those estimates.

(f) Events occurring after reporting date

The Plan Sponsor has evaluated events and transactions that occurred between December 31, 2024, and July 31, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Credit risk and other concentrations

At various times during the year, the Plan had cash deposits at a bank in excess of the federally insured limit. The Plan has not experienced any losses in such accounts, and Plan management believes the Plan is not exposed to any significant credit risk in this regard.

(4) Fair value measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, Fair Value Measurements, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Interest bearing cash is valued at its carrying value, which approximates fair value. It is a level 1 investment in the fair value hierarchy. There have been no changes in the methodology used at December 31, 2024 and 2023.

(5) Administration contract

The Plan entered into an administrative agreement with Trust Management Group, Inc. ("TMG") to provide various services including enrolling of employees in the group benefit plans offered by the Plan, consolidating the billing and premium information of its members and collecting and remitting of premiums for insurance products and similar services offered by the Plan. TMG is paid per employee per month and invoices employer members directly for this administrative fee and requires this fee be paid from each employee member's general assets. The agreement is for a one-year term and automatically renews unless notice is given by either party 90 days in advance of the anniversary date.

The Plan had an annual administrative services agreement with Blue Cross Blue Shield of Florida, Inc. and its affiliate Health Options, Inc. ("BCBS") for the provision of health claims handling, administration, utilization, case management, and other preferred medical management services while the Plan was self-insured. BCBS was paid monthly administrative fees based on plan enrollment.

The Plan had an annual administrative services agreement with RX Benefits, Inc. ("Rx") for the provision of prescription claims handling, administration, utilization, case management, and other preferred medical management services while the Plan was self-insured. Rx was paid a monthly administrative fee based on plan enrollment.

(6) Income tax status

The Plan was established as a voluntary employee benefit association within the meaning of Section 501(c)(9) of the Internal Revenue Code ("IRC") of 1986. The Plan received a determination letter dated September 17, 2018, which stated that the Plan was in compliance with the applicable requirements of the IRC. Therefore, the Trust is exempt from income tax, but is required to file an annual information return. The Plan is also required to file an annual return/report with the Department of Labor.

(7) Related party and party-in-interest transactions

The Plan is due \$5,744 and \$5,079 at December 31, 2024 and 2023, respectively from a related party. These amounts represent medical insurance premiums. The Plan pays insurance premiums to insurance providers and administrative expenses to various service providers as described in Note 1. These transactions are considered party-in-interest transactions under ERISA.
