Report on the Audit of the Financial Statements

Opinion

We have audited the accompanying financial statements of SECU/S3 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of SECU/S3 401(k) Retirement Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report. NOTE 1 DESCRIPTION OF PLAN

The following description of the SECU/S3 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that is qualified under Section 401-1(b)(3) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA) of 1974. All employees of State Employees Credit Union of Maryland, Inc. and S3 Shared Services Solutions, LLC (collectively, the Corporation) who are full-time or part-time are eligible to become participants in the Plan immediately at date of hire. Employees are excluded from participation in the Plan if they are covered by a collective bargaining agreement, a nonresident alien, a leased employee, an intern, employees classified as contractors, or a supplementary employee who works on an on-call basis and receive no benefits.

Contributions

Under the Plan, participants are allowed to make voluntary pre-tax contributions to the Plan not to exceed the maximum amount permitted by the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. New participants are automatically enrolled at a 6% contribution level unless they elect otherwise. Automatically enrolled participants will have their deferral percent increased by 1% on their anniversary date up to a maximum of 10%. In addition, current employees' participants contributing less than 6% will have their deferral percentage automatically increased by 1%, unless they affirmatively elected otherwise. Participants are permitted to make Roth contributions into the Plan. Rollovers from other qualified defined benefit or defined contribution plans are allowed into the Plan.

The Corporation may make a discretionary matching contribution in an amount equal to 50% of the first 6% of eligible compensation that a participant contributes to the Plan. Additionally, the Corporation may make discretionary nonelective and/or discretionary qualified nonelective contributions. To receive the nonelective contributions, an employee must be employed on the last day of the Plan year and have completed 1,000 hours of service during the year. For the year ended December 31, 2024, discretionary contributions equaled 5% of participants' gross compensation for employees of State Employees Credit Union of Maryland, Inc. and 3% of participants' gross compensation for employees of S3 Shared Services Solutions, LLC. For the years ended December 31, 2024, the Corporation also elected to contribute the amount of the forfeiture balance as an additional discretionary contribution subsequent to year-end which equaled \$139,927 for employees of State Employees Credit Union of Maryland, Inc.. The qualified nonelective contributions were allocated to participants based on a ratio of their compensation to total eligible compensation for the Plan. For the year ended December 31, 2024 the Corporation made a \$2,087,460 Employer match contribution and \$3,162,476 of nonelective contributions.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Corporation's contributions, and an allocation of Plan earnings (losses) and administrative expenses. Allocations are based on participant account balances, compensation, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All accounts are participant directed.

Vesting

Participants are immediately vested in their participant contributions, including rollovers, and the Corporation discretionary qualified nonelective contributions plus actual earnings thereon. Vesting in the Corporation matching and discretionary nonelective contributions, plus earnings thereon, is based on years of continuous service as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 1 year	0%
1	20%
2	40%
3	60%
4	80%
5 or more	100%

Participants become fully vested in the Corporation's matching and discretionary nonelective contributions upon death, total disability, normal retirement, or the termination of the Plan.

Payment of Benefits

Participants or their beneficiaries are eligible for distributions upon the participant's termination, death, disability, or retirement. The Plan also allows for in-service withdrawals for financial hardships and for participants who have reached the age of 59½. Distributions are made in the form of lump sum amounts. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan will distribute the benefit in a lump sum as soon as administratively practicable. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name. Vested account balances exceeding \$5,000 are paid at the participant's discretion or can be left in the Plan until such time the participant wishes to withdraw it, with the account continuing to share in the Plan's earnings. At all times, participants may withdraw in total or a portion of their rollover contributions. Effective January 1, 2024, as a result of the SECURE 2.0 Act, the mandatory cash out limit was increased from \$5,000 to \$7,000.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum of, the lesser of one half of the vested account balance or \$50,000, reduced by the highest outstanding loan balance for all loans during the preceding 12 months. The minimum loan amount is \$1,000. A participant may not have more than two outstanding loans at any time. Loans bear interest at a rate equal to the prime lending rate in effect at the time of the loan plus 1%. The loans are secured by the balance in the participant's account. A loan must be repaid over a period of no more than five years unless it is used to acquire a principal residence and the administrator agrees to a longer term not to exceed 20 years. Loan payments are made through payroll deductions. Any loan will become due and payable in full if the Plan is terminated for any reason.

Forfeitures

Forfeitures represent the nonvested portion of terminated participants' account balances. These amounts can be used to reduce future Plan expense or future matching or discretionary nonelective contributions. Effective January 1, 2024, forfeitures may be reallocated to participants in proportion to compensation, as an additional nonelective Contribution or added to nonelective contributions. Forfeitures of \$337,900 were used to reduce the Corporations matching and nonelective contributions during the years ended December 31, 2024. At December 31, 2024 and 2023, the forfeited nonvested account totaled \$177,418 and \$150,102 respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates in Preparing Financial Statements

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Contributions

Contributions from participants and Corporation contributions are recorded in the year in which the employee contributions are withheld from compensation

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Corporation and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and processing of benefit payments are charged directly to the participant's accounts and are included in administrative expenses. Investment related expenses are also included in administrative expenses.

Subsequent Events

The Plan has evaluated subsequent events through July 1, 2025, the date the financial statements were available to be issued.

NOTE 3 FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quotes prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the assets or liabilities;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodology used at December 31, 2024 and 2023.

Registered Investment Companies (Mutual Funds) – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

Collective Trust – Units held in the collective trust (CT) are valued using the net asset value practical expedient (NAV practical expedient) of the CT as reported by the CT manager. The NAV practical expedient is based on the fair value of the underlying assets owned by the CT, minus its liabilities, and then divided by the number of units outstanding. CT contains no redemption restrictions or notice periods. Redemption frequency is daily. There were no unfunded commitments as of December 31, 2024 and 2023.

Interest-Bearing Cash – Valued at cost plus accrued interest. Interest-bearing cash is generally classified within level 1 of the valuation hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value for certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY

During 2024, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Transamerica Financial Life Insurance Company (the Insurance Company). The Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than zero percent. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the Insurance Company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the Plan by the Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

The guaranteed investment contract does not permit the Insurance Company to terminate the agreement prior to the schedule maturity date.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

NOTE 5 PLAN TERMINATION

Although it has not expressed any intent to do so, the Corporation has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Corporation contributions.

NOTE 6 RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are units of a collective trust fund, insurance contract and a cash account managed by Diversified Retirement Corporation, an affiliate of Transamerica Retirement Services, the recordkeeper of the Plan during the year ended December 31, 2024. These investments qualify as party-in-interest investments and transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter from the IRS on the Pre-Approved in accordance with the applicable section of the plan indicating that the Plan is designed IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress

NOTE 8 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
