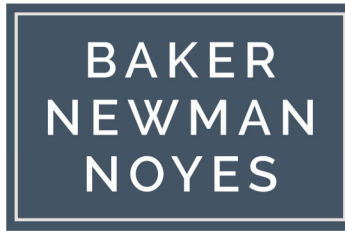

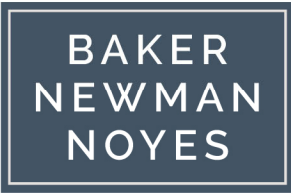

## INDEPENDENT AUDITORS' REPORT

The Plan Sponsor and Participants  
Vygon Corporation 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Vygon Corporation 401(k) Plan (formerly the Advanced Medical, Inc. 401(k) Plan) (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements (financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

### 1. Description of Plan

The following brief description of the Vygon Corporation 401(k) Plan (previously known as Advanced Medical, Inc. 401(k) Plan) (the Plan) presents only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan and was established on April 1, 1995 for all eligible employees of Advanced Medical, Inc. and Churchill Medical Systems, Inc. (collectively, the Employers), and is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Effective January 1, 2022, the Employers merged with their parent company, Vygon Corporation (the Plan Sponsor). There was no impact on the operations of the Plan during 2022. On March 7, 2023, the Plan was renamed Vygon Corporation 401(k) Plan to align with the reorganization of the Plan Sponsor. The Plan operates under Section 401(k) of the Internal Revenue Code (IRC).

On December 29, 2022, the *Setting Every Community Up for Retirement Enhancement Act of 2022* (SECURE 2.0 Act) was signed into law. It includes mandatory and optional provisions impacting defined contribution plans. Applicable provisions outlined in the SECURE 2.0 Act will be adopted if elected and/or required. Plan amendments for these changes are not yet required.

#### Eligibility

Generally, all employees age 21 and over are eligible to enter the Plan on the first day of each quarter following a 60-day service requirement. Participants are eligible to receive matching contributions once they have completed 6 months of service.

The SECURE 2.0 Act expanded eligibility for certain long-term part-time (LTPT) employees. Effective January 1, 2024, part-time employees who have completed between 500 and 999 hours of service in the three most recent consecutive years (2021-2023) are eligible to participate in the Plan. Effective January 1, 2025, the requirement is being reduced from three to the two most recent consecutive years (2023-2024).

#### Contributions

##### *Participant Salary Deferral*

Participants in the Plan may contribute to the Plan up to 90% of their annual compensation, as defined, not to exceed the maximum amount allowable under the IRC in any calendar year. Participants are also permitted to make Roth elective 401(k) contributions. Employees 50 years or older may elect to defer additional amounts (catch-up contributions, which are subject to Internal Revenue Service (IRS) limitations). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). In addition, the Plan has an automatic enrollment feature whereby participants who have not completed an enrollment or opt-out form are automatically enrolled into the Plan with a 6% deferral once they meet the eligibility requirements.

#### *Employers' Matching*

Effective for the 2023 Plan year, the Employers provided safe harbor matching contributions in an amount equal to 100% of the participants' deferrals up to 2% of compensation (as defined) plus 50% of the participants' deferrals that exceeded 2% of compensation up to 5% of compensation. Effective January 1, 2024, the Plan was amended to provide safe harbor matching contributions in an amount equal to 100% of the participants' deferrals up to 5% of compensation.

#### *Discretionary Contributions*

The Employers may make a discretionary matching contribution equal to a uniform percentage of the participants' salary deferrals. There was no discretionary matching contribution in 2024 or 2023.

#### Vesting

Participants are immediately 100% vested in their own contributions plus actual earnings thereon. Vesting in the Employers' matching contribution and earnings thereon is based on a rate of 50% after one year of service and 100% after two years of service.

#### Forfeitures

A participant who terminates employment and is less than 100% vested forfeits the non-vested portion of their account. Forfeitures may be first used to pay any administrative expenses and can also subsequently be used to reduce any employer contributions. Forfeitures used during 2024 and 2023 and available for future use were not material.

#### Participant Accounts

Individual participant accounts are credited with applicable contributions and related employer matching contributions and allocations of plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based upon participant earnings or account balances, as defined in the Plan Document. The benefit to which a participant is entitled is equal to the vested portion of the participant's account. Participants direct the investment of their contributions into various investment options offered by the Plan.

#### Benefit Payments

On termination of service, death, disability or retirement, or attainment of age 59 ½ while still employed, a participant may elect to receive the value of the participant's vested interest in their account in either a lump-sum amount or partial withdrawals or installments. Plan provisions allow for involuntary distributions as follows: participants who are no longer employed by the Employers and who have a vested balance less than \$5,000 will receive a lump-sum payment, with balances between \$1,000 and \$5,000 being rolled into an Individual Retirement Account (IRA). Hardship withdrawals are allowed under the provisions of the Plan and cannot exceed the amount required to meet the immediate financial need created by the hardship. Effective January 1, 2025, the mandatory cash-out threshold was increased from \$5,000 to \$7,000 within the SECURE 2.0 Act.

### 1. **Description of Plan (Continued)**

#### *Notes Receivable From Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participants' accounts and bear interest at a reasonable rate based on the prevailing interest rates charged in the business of lending money for loans which would be made under similar circumstances at the date of the loan. Principal and interest are paid ratably through payroll deductions generally over a period not to exceed 5 years unless the loan is for the purchase of a primary residence in which case the term shall not exceed 30 years. Interest on loans outstanding as of December 31, 2024 ranged from 4.25% to 9.5% per annum, and the loans mature on various dates through October 2029.

#### *Revenue Sharing Account*

The Plan shares in investment related revenue, which Reliance Trust Company (Reliance), the trustee, receives from mutual funds or collective trusts attributable to the plan assets invested in such mutual funds and trusts. The Plan receives a credit for the revenue share on a monthly basis which is deposited into an ERISA Budget Account. The Plan Sponsor can use the funds in the account to pay for certain approved plan related expenses. During 2024, the total revenue share deposited into the ERISA Budget Account was \$17,549, all of which was applied to plan administrative expenses before December 31, 2024. During 2023, the total revenue share deposited into the ERISA Budget Account was \$16,731, all of which was applied to plan administrative expenses before December 31, 2023.

### 2. **Significant Accounting Policies**

#### *Basis of Accounting*

The accompanying financial statements are prepared on the accrual basis of accounting.

#### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of plan income and expenses during the reporting period. Actual results may differ from those estimates.

#### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Dividends are recorded on the ex-dividend date. Capital gain distributions are recorded in dividend income. Interest is included in income when earned, based on the terms of investments and the periods during which the investments are owned. Purchases and sales of securities are recorded on a trade-date basis. See note 3 for discussion of fair value measurements.

#### 2. **Significant Accounting Policies (Continued)**

Net appreciation in fair value of investments includes realized gains and losses on investments that were both purchased and sold during the period as well as unrealized appreciation or depreciation of the investments held at year end.

##### Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded (deemed distribution).

##### Contributions

Contributions from employees are recorded during the period in which the Employers make payroll deductions. Employer matching contributions are recorded in the same period as the corresponding participant contributions.

##### Payment of Benefits

Benefits are recorded when paid.

##### Administrative Expenses

Certain administrative expenses are paid by the Sponsor.

##### Subsequent Events

Events occurring after the statement of net assets available for benefits date are evaluated by management to determine whether such events should be recognized or disclosed in the financial statements. Management has evaluated subsequent events through August 18, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan trustee was changed from Reliance to ADP Retirement Trust Services, LLC.

#### 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value fall into one of the three levels of the fair value hierarchy below and are defined as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust fund* – The units of the collective trust fund are valued using the net asset value practical expedient as determined by the issuer based on the current fair values of the underlying assets of the fund. The fund's investment objective is stability of principal and high current income. The common/collective trusts do not have any unfunded commitments relating to their investments, or any significant restrictions or redemptions. Participant-directed redemptions can be made on any business day and do not have a redemption notice period.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### 5. **Tax Status (Continued)**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### 6. **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in assets available for benefits.

#### 7. **Plan Termination**

The Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. The Employers shall make no further contributions after the termination of the Plan. In the event of plan termination, amounts credited to the participants' accounts as of the date of termination will be fully vested.

#### 8. **Party-in-Interest Transactions**

During 2024 and 2023, the Plan had agreements with ADP Retirement Services, Reliance, RSG Advisory and LPL Financial to provide recordkeeping, trustee, loan processing, and investment advisory services. Total fees paid by the Plan for these services were \$31,863 and \$31,004 for the years ended December 31, 2024 and 2023, respectively. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA. In addition, loans to participants qualify as party-in-interest transactions.
