To the Plan Administrators of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Acme Tools 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Acme Tools 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 PLAN DESCRIPTION

The following description of the Acme Tools 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of Acme Electric Motor, Inc. (the “Company”) who have met certain eligibility requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by a committee appointed by the Company. Third party administrators serve as the trustees of the plan, maintain the records of the participant data and hold the Plan assets.

Eligibility

Employees of the Company are generally eligible to make contributions to the Plan upon attainment of age 21 and completing one month of service. Employees can enroll in the Plan on the first day of each calendar month.

Contributions

Participants may contribute up to 75% of their income, but are restricted by the annual IRS limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan allows participants to allocate contributions between pretax and after tax (Roth 401(k)) deferrals.

The employer may make a discretionary matching contribution equal to a uniform percentage or dollar amount of the participant's elective deferrals each plan year. The discretionary matching contribution is allocated to plan participants who meet the eligibility requirements of at least 501 hours of service during the previous year and are employed on the last day of the plan year. Each year, the employer will determine the formula for the discretionary matching contribution. In addition, the employer may contribute a qualified nonelective contribution at its discretion. Effective April 1, 2023, the Plan was revised to remove the additional service requirements related to the employer match and change the timing of employer match contributions so they are to be made every pay period.

Roth rollover contributions are not allowed.

Participant Accounts

Each participant's account is credited with the participant's contribution, the employer's contributions and an allocation of the plan earnings. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. The Plan allows for participant-directed investment programs for which separate funds are maintained. The value of each participant's account is determined daily.

Participants' Investment Options

Participants must direct their salary deferral contributions and employer contributions, if any, to selected investments as offered by the Plan. Participants may change their investment options throughout the year by contacting the Plan's third-party administrator.

Vesting

Participants are immediately 100% vested in their deferral and rollover contributions plus actual earnings thereon. Vesting in the remainder of their account is based on years and hours of service. A participant is 100% vested after six years of credited service. Effective April 1, 2023 the Plan's vesting schedule was amended to five years of credited service.

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 and a maximum of 50% of their vested account balance. In no event can the participant borrow more than \$50,000. Loans bear interest at 1% over the prime interest rate. Principal and interest repayments are made ratably through payroll deductions and must be repaid within five years, unless used by the participant to purchase a primary residence. Loans made for the purchase of a principal residence must be repaid within fifteen years.

Payment of Benefits

A participant is eligible to request a distribution of their vested account balance based on any of the following events: death, disability, financial hardship, retirement, minimum required distributions, and termination of employment. On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of their account, or part lump-sum and part installments. A participant is also able to elect installment payments (annually, quarterly or monthly) over a specified period of time. Additionally, participants may take an in-service distribution upon reaching age 59 ½. Upon termination, automatic distributions are required for balances of less than \$5,000. Generally, certain minimum distributions are required for participants who have separated from service and have reached required minimum distribution age.

The Plan allows hardship withdrawals, subject to account balance limitations and applicable laws.

Forfeitures

Forfeitures are used first to reduce employer contributions to the Plan and second to reduce administrative expenses. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$10 and \$10, respectively. In 2024 and 2023, employer contributions were reduced by \$45,675 and \$31,946, respectively, from forfeited nonvested accounts.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Basis of Presentation

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, ("GAAP"), as codified by the Financial Accounting Standards Board.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the trustees. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded as earned on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year and is reflected in the statements of changes in net assets available for benefits.

Contributions

Contributions from Plan participants and matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Several of the investment fund options are subject to investment fees based on a percentage of assets invested, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the plan sponsor. Expenses that are paid by the plan sponsor are excluded from these financial statements.

Income Taxes

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based on the terms of the plan document.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to March 15, 2025 and 2024, respectively.

NOTE 4 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Collective Trust Fund: A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the NAV of units of the bank collective trust. The NAV, as provided by the Trustees, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 INCOME TAX STATUS

The Plan is a Nonstandardized Pre-Approved Plan sponsored by the Trustees and adopted by the Company. The Internal Revenue Service informed the Trustees by an opinion letter dated June 30, 2020, that the Pre-Approved Plan is acceptable under section 401(a) of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter, however, the Company and plan administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and the Plan continues to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken a significant uncertain tax position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

NOTE 6 EXEMPT TRANSACTIONS WITH PARTIES-IN-INTEREST

Principal Trust Company and ADP Retirement are the named Trustees of the Plan as defined by the plan document. As such, transactions with the Trustee qualify as party-in-interest transactions. Total fees paid to Principal Life Insurance Company, an affiliate of Principal Trust Company, for recordkeeping services amounted to \$20,604 for the year ended December 31, 2023. Principal Life Insurance Company receives revenue from mutual fund service providers for services Principal Life Insurance Company provides to the funds. This revenue is used to offset certain amounts owed to Principal Life Insurance Company as compensation for services Principal Life Insurance Company provides. Revenues credited to reduce fees amounted to \$23,815 for the year ended December 31, 2023. Revenue sharing in excess of fees have been credited to participant accounts and is included in Net Appreciation in Fair Value of Investments on the Statements of Changes in Net Assets Available for Benefits. Total fees paid to ADP Retirement for recordkeeping services amounted to \$53,376 and \$18,979 for the years ended December 31, 2024 and 2023, respectively.

Alerus Financial N.A. provided consulting services to the Plan during 2024 and 2023. Fees paid by the Plan for the consulting services amounted to \$43,157 and \$22,423 for the years ended December 31, 2024 and 2023.
