Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Notes to Financial Statements

December 31, 2024 and 2023

(1) Description of Plan:

The following brief description of the Bonacio Construction 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General – The Plan was established by Bonacio Construction, Inc., (the “Company”) on June 1, 1999 as a defined contribution retirement plan covering substantially all employees of the Company. The Plan is subject to the provisions of ERISA.

The Plan was amended and restated effective November 1, 2021, for the Cycle 3 Restatement and other legislative and regulatory changes. The amendment also increased the matching of deferrals from 50% of the first 6% to 50% of the first 8% effective November 1, 2021.

Eligibility – Generally, all employees of the Company, except those covered by a collective bargaining agreement, are eligible to participate in the Plan upon attaining the age of 18 and completing 2 months of service. Once the participant has met the age and service requirements, he/she will enter the Plan the first day of the next month. The Company is a member of a controlled group including B & B Plumbing, Inc., West Side Management of Saratoga, LLC, Julie & Co., LLC, 2 West Ave, LLC, and Neumann Building, LLC. Together, the entities are referred to in the notes to the financial statements as the “Company”.

Contributions – Eligible employees may contribute up to 100% of their annual eligible compensation on a pre-tax basis and after-tax (Roth) basis, or a combination of both, as defined by the Plan, subject to Internal Revenue Service limitations. Participants who are age 50 or older may elect to defer additional amounts called “catch-up” contributions. Rollover contributions from another qualified retirement plan or special individual retirement plan are permitted. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make a discretionary matching contribution in an amount determined by management. Amounts deferred over 6% are not matched prior to November 1, 2021. Effective with the amendment noted above in “General”, amounts deferred over 8% are not matched. The Company, also at its discretion, may make non-elective profit sharing contributions as defined in the Plan document. Participants will become eligible to begin receiving matching contributions and profit sharing contributions on the first day of each plan quarter coincident with or next following the date they attain age 18 and complete one year of eligible service. Participants must be employed on the last day of the year to receive profit sharing contributions, unless employment is terminated due to death, disability, or attainment of normal retirement age. The Company made \$407,723 and \$400,863 in matching contributions in 2024 and 2023, respectively. The Company did not make a profit sharing contribution for 2024 or 2023.

Notes to Financial Statements, continued

(1) Description of Plan, continued:

Automatic Enrollment – Upon hire, employees are given a salary deferral agreement to elect to make elective deferrals into the Plan or to decline enrollment. If the agreement is not received once the employee becomes eligible to participate, the employee will have 4% automatically withheld and contributed into a default investment fund selected by the Company as a pre-tax contribution. The deferral percentage will increase by 1% each year up to 12%. A notice will be provided prior to the beginning of each plan year to allow the participants to update their deferral information.

Participant Accounts – Accounts are participant directed. Account balances are tracked in units and the value is updated with the daily market price. As of any business day accounts are charged or credited with earnings (dividends, capital gains, expenses and market fluctuation) as well as account activity such as contributions, loans, distributions or hardships.

Vesting – Participants are immediately vested in their voluntary contributions and earnings or losses thereon. Vesting in the Company's contribution portion of their account is based on years of service. A participant becomes 100% vested after three years of service.

Notes Receivable from Participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of (a) \$50,000 or (b) 50% of their account balance. Participants are allowed only one outstanding loan at a time. Loan terms range from 1-5 years or up to 20 years for the purchase of a primary residence. The loans are collateralized by the balance in the participant's account and bear interest at the prime rate as published by the Wall Street Journal. The interest rates for 2024 and 2023 ranged from 3.25% to 8.50% for both years.

Withdrawal Privileges – Prior to termination, a participant may withdraw all or any portion of his fully vested account, excluding earnings on elective deferrals, in the event of undue financial hardship. The participant's request for a withdrawal shall include his statement and documentation proving that such a hardship exists and explain its nature. To qualify as a financial hardship withdrawal it must be determined that the withdrawal is to meet an immediate and financial need of the participant and the amount of the withdrawal is not reasonably available from other sources of the participant. Hardship withdrawals are limited to the following: financial needs arising on account of a college education, purchase of a principal residence, major medical expenses, prevention of eviction or foreclosure, burial or funeral expenses, and damage to a principal residence due to fire, storm or other casualty. The Plan Administrator has established uniform, nondiscriminatory guidelines to use in determining if such a condition of undue financial hardship exists. The Plan Administrator's determination shall be final. The participant has no legal or equitable right to such a withdrawal unless the immediate and financial need as defined has been demonstrated.

Withdrawal Provisions – The Plan also provides for in-service distributions for participants that have attained age 65. Such participants will be entitled to receive a distribution of all or a portion of their vested contributions. At age 59½ participants are entitled to receive a distribution from their pre-tax deferrals. Participants may withdraw from the rollover account at any time.

(1) Description of Plan, continued:

Payment of Benefits – Upon termination of service, disability, death or retirement, participants may elect to receive a lump sum or partial distribution, if their account exceeds \$5,000, equal to the value of their accounts. Upon termination of service, the participants may also elect to roll over the funds into an IRA or to another employer's tax qualified plan. If the participant's account balance exceeds \$5,000 (excluding any rollover contributions plus earnings) he or she may also elect to receive partial payments or defer receiving payments until age 70½. If the participants account balance is \$5,000 or less and they do not elect to receive a lump-sum or a direct rollover, the balances will automatically be cashed out in the form of a lump-sum.

Administrative Services – The Plan states that costs incurred in administering the Plan may be paid by the Company, but if not paid by the Company when due, the costs shall be paid from the assets of the Plan. Administrative fees for loan and distribution processing are charged to the participant. The administrative fees paid from the assets of the Plan amounted to \$72,150 and \$63,252 in 2024 and 2023, respectively.

Forfeitures – Forfeitures of participants' non-vested account balances shall become available for payment of administrative expenses or used to reduce employer contributions.

(2) Summary of Significant Accounting Policies:

Basis of Accounting – The financial statements of the Plan are prepared under the accrual method of accounting in accordance with generally accepted accounting principles.

Investments held by a defined contribution plan are required to be reported at fair value, except for common collective trust funds. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to common collective trust funds because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable from Participants – Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Use of Estimates – The preparation of the Plan's financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for plan benefits at the date of the financial statements and the changes in net assets available for plan benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Risks and Uncertainties – The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for plan benefits.

(2) Summary of Significant Accounting Policies, continued:

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 – Fair Value Measurements below for discussion of fair value. Notes receivable from participants are valued at cost, which approximates fair value.

Dividend income is recorded on the ex-dividend date. Interest income is recorded as earned. Security transactions are recorded on a trade-date basis. Gains or losses on sales of securities are based on average cost.

The Plan presents in the statements of changes in net assets available for plan benefits the net appreciation in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments.

Benefit Payment Recognition – Benefits are recorded when paid.

Date of Management Review – Subsequent events were evaluated through July 31, 2025, which is the date the financial statements were available to be issued.

(3) Fair Value Measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification (ASC) 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- a. Quoted prices for similar assets or liabilities in active markets;
- b. Quoted prices for identical or similar assets or liabilities in inactive markets;
- c. Inputs other than quoted prices that are observable for the asset or liability;
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

(3) Fair Value Measurements, continued:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust fund: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

(4) Information Certified by the Trustee:

At December 31, 2024 and 2023, the Plan's investments were held by the Trustee and monitored by the Plan's investment board. The following is a summary of the Plan's financial information that is included in the financial statements based on information certified by the Trustee as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

During 2024 and 2023, the Plan's investments (including realized and unrealized gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$1,179,128 and \$1,374,529, respectively.

(5) Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. Upon termination of the Plan, all amounts credited to the accounts of the participants shall vest and become non-forfeitable. The employer shall direct the Trustee to make or commence distribution to, or on behalf of, each participant the value of his or her account balance in the Plan.

(6) Tax Status:

The IRS has determined and informed the Plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

(7) Related-Party and Party-In-Interest Transactions:

Plan investments are managed by Reliance Trust Company, the Trustee of the Plan. Transactions in such investments qualify as party-in-interest transactions, which are exempt from prohibited transaction rules. Notes receivable from participants totaling \$348,266 and \$243,906 at December 31, 2024 and 2023, respectively, also qualify as party-in-interest transactions.
