**NOTE 1 DESCRIPTION OF PLAN**

The following description of Mark-Taylor Development, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all employees of Mark-Taylor Development, Inc. and Mark-Taylor Residential (collectively referred to hereafter as the Company or Plan Sponsor). The Plan has been restated and amended throughout the years to comply with tax legislation and most recently restated effective January 4, 2021 and amended January 1, 2025. The Plan excludes leased employees, union employees, nonresident aliens, and residents of Puerto Rico. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The 401(k) Plan Committee is responsible for the oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

**Eligibility**

Employees are eligible to participate in deferral and employer discretionary matching contributions of the Plan once they have completed two months of service and are 21 years of age. Effective July 15, 2024, the age requirement was lowered to 18 years of age. Employees enter the Plan on the first day of each month upon completion of the eligibility requirement.

**Contributions**

The Plan allows employees to make pre-tax and Roth contributions up to the maximum amount allowed under the Internal Revenue Code (IRC). Participants who have attained age 50 by the last day of the calendar year are allowed additional "catch-up" contributions. Participants may elect to automatically escalate their deferral election 1% to 3% of eligible compensation annually up to a maximum of 25% of eligible compensation.

The Company discretionary matching contributions are equal to 50% of the first 6% of eligible compensation.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's discretionary matching contribution and an allocation of the Plan's earnings (losses) and administrative expenses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant account balances, or participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

**Vesting**

Participants are 100% vested at all times with respect to their own contributions and earnings on their contributions from date of admission to the Plan. With respect to Company discretionary matching contributions, participants are vested over a six-year period based on a Plan year in which an hourly participant completes 1,000 hours of service, or the equivalent of 1,000 hours for nonhourly participants.

Employer matching contributions vest and become nonforfeitable as follows:

Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

**Forfeitures**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$73,770 and \$78,283, respectively. Forfeited balances of terminated participants' nonvested accounts may be used to reduce future employer matching contributions or pay Plan administrative expenses. Employer matching contributions paid for with forfeitures for the years ended December 31, 2024 and 2023 were \$79,095 and \$42,504 respectively. There were no administrative expenses paid for with forfeitures for the years ended December 31, 2024 and 2023.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance and are secured by the balance in the participant's account. A participant may have no more than two loans outstanding from the Plan at any one time, and notes bear an interest rate equal to 1% above the prime rate. Principal and interest is paid ratably through bi-weekly payroll deductions.

**Payment of Benefits**

Upon termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution, partial withdrawals of \$1,000 or more, or installment payments related to requirement minimum distributions. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan administrator will authorize the benefit payment without the participant's consent. Effective January 4, 2021, if the balance of the terminated participant's account is between \$0.01 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to employee contributions. The Plan distributed excess contributions relating to the years ended December 31, 2024 and 2023 to applicable participants prior to March 15.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting, in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian, trustee, and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Benefit Payments**

Benefits are recorded when paid.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes receivables are reclassified as distributions based upon the terms of the Plan document. As all notes receivable are secured by participant balances, no allowance is maintained. Upon termination, any outstanding notes will be offset against an employee's account balance or treated as a taxable deemed distribution.

**Administrative Expenses**

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investment presented in the accompanying statement of changes in net assets available for benefits.

**Subsequent Events**

The Plan has evaluated subsequent events through August 4, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

John Hancock Trust Company LLC, the trustee of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the related investment income and interest income on notes receivable reflected in the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust Fund:* Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

**NOTE 5 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits. Exposure to loss in any specific investment is directly related to the investment chosen by the participant and any losses are allocated to the specific participant.

**NOTE 6 PLAN TERMINATION**

Although the Plan Sponsor has not expressed any intent to do so, the Plan Sponsor has the right under the Plan Agreement to terminate the Plan subject to the provisions of ERISA. If the Plan should be terminated, the amount in each participant's account as of the date of such termination (after proper adjustment for all expenses, earnings, and allocations) becomes fully vested.

**NOTE 7 PLAN TAX STATUS**

The Plan is placing reliance on opinion letters received from the IRS on the prototype plan indicating that the Plan is qualified under Section 401 of the IRC and is therefore not subject to tax under current income tax law. The prototype plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

**NOTE 7 PLAN TAX STATUS (CONTINUED)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 PARTY-IN-INTEREST TRANSACTIONS**

Plan participants have outstanding notes receivable with John Hancock Trust Company LLC. These transactions qualify as party-in-interest transactions.
